RE: CalFresh RFA 17-01 Addendum 1

Information contained in Addendum 1 takes precedence over the original RFA. All other terms and requirements of the RFA not specified in this addendum remain unchanged. Applications are to be submitted in response to the RFA as herein amended. Any attachments or exhibits updated or replaced are posted to the CalFresh Outreach website.

The following changes have been made to the original RFA. Changes to the RFA are itemized as follows, and noted in red:

1. RFA Page 14, Section L, Subsection 3

Revised language should read as follows to correct the language:

Reimbursement Budget guidelines for program deliverables

2. RFA Page 25, Section M, Subsection 2

Revised language should read as follows to correct the formatting requirement:

Format the narrative portions of the application using one-inch margins at top, bottom and both sides, a font size of not less than 11 points, printed single-sided on ~~bond~~ standard 8.5 X 11 inch paper with sequential pagination. The application must include tabbed divider pages, separating the application into the following sections:

3. RFA Page 40, Section Z

The following definition has been added:

Electronic Application: For the purpose of this RFA, an electronic application refers to CalFresh applications submitted to a CWD containing a proper and valid electronic signature as defined in California Civil Code Sections 1633.1 – 1633.17. At present, electronic applications meeting the aforementioned Civil Code are submitted through the consortia portals provided by Your Benefits Now, C4 Yourself and My Benefits CalWIN.

4. Attachment 7, Program Deliverables Worksheet

Attachment 7 is updated to reflect the change in RFA Page 14, Section L, Subsection 3.

5. Attachment 12, Federal Funding Accountability and Transparency Act of 2006 (FFATA).

Attachment 12 is updated with the FFATA form to be submitted with RFA 17.01.

6. Exhibit B – Budget Detail

The following language has been removed from Exhibit B, and is reposted on the CalFresh Outreach website.
