

NOTICE TO ALL CALFRESH RECIPIENTS IMPORTANT — PLEASE READ

Effective October 1, 2016, State and Federal laws provide for the following:

Maximum CalFresh Allotments: These are benefit amounts your household would receive if your household had no income.

- Additionally, the maximum excess shelter deduction has increased from \$504.00 to \$517.00.
- The homeless shelter allowance of \$143.00 remains unchanged.
- The standard deductions have changed as follows:

Standard Deductions for FFY 2017:

Household Size	Standard Deductions
1 to 3 persons	\$157.00
4 persons	\$168.00
5 persons	\$197.00
6 or more persons	\$226.00

The Standard Utility Allowance (SUA) of \$385.00 increased to \$389.00.

The Limited Utility Allowance (LUA) of \$118.00 slightly increased to \$122.00.

If the SUA/LUA is used as part of your shelter deduction and if you have had no changes in your CalFresh case, your CalFresh benefits may be changed. With the changes in your CalFresh benefits, the amount you will get depends on other household changes. These changes will be included in any notice you get that tells you about other changes in your CalFresh benefits.

If you think we made a mistake in figuring your October CalFresh benefits due to the new amounts for allotments and SUA/LUA you may ask for a state hearing, **within 90 days of when you got this letter** by writing to:

You can speak for yourself at the hearing or you can have a friend, attorney, or other person speak for you, but you must get these people to help you. Nrog rau qhov kev pauv hloov hauv koj cov nyiaj pab ntawm CalFresh, cov nyiaj uas koj yuav tau txais yuav nce raws li lwm yam pauv hloov ntawm tsev neeg. Tej kev pauv hloov no muaj xws li txhua tsab ntawv ceebtoom uas koj tau txais thiab qhia rau koj txog lwm yam kev pauv hloov nyob hauv koj cov nyiaj pab ntawm CalFresh.

Yog koj xav tias peb xam koj cov nyiaj pab ntawm CalFresh thaum lub Kaum Hli yuam kev lawm vim los ntawm cov nyiaj tshiab SUA/LUA tej zaum koj yuav thov kom rov qab taug xyuas dua tshiab, **kom tsis pub dhau 90 hnub txij hnub koj tau txais tsab ntawv nous** yog sau ntawv mus rau:
