

NOTICE TO ALL CALFRESH RECIPIENTS IMPORTANT — PLEASE READ

Effective October 1, 2011, State and Federal laws provide for the following:

Maximum CalFresh Allotments: These are benefit amounts your household would receive if your household had no income.

- Additionally, the maximum excess shelter deduction has been increased from \$458.00 to \$459.00.
- The homeless shelter allowance of \$143.00 will remain unchanged.
- However, the standard deduction has changed as follows:

Standard Deductions for FFY 2011:

Household Size	Standard Deductions
1 to 3 persons	\$147.00
4 persons	\$155.00
5 persons	\$181.00
6 or more persons	\$208.00

The Standard Utility Allowance has been increased from \$320.00 to \$329.00.

The Limited Utility Allowance has been raised from \$94.00 to \$99.00 for FFY 2012, also effective October 1, 2011.

If the SUA/LUA is used as part of your shelter deduction and if you have had no changes in your CalFresh case, your CalFresh benefits may be changed. With the changes in your CalFresh benefits, the amount you will get depends on other household changes. These changes will be included in any notice you get that tells you about other changes in your CalFresh benefits.

If you think we made a mistake in figuring your October CalFresh benefits due to the new amounts for allotments and SUA/LUA you may ask for a state hearing, **within 90 days of when you got this letter** by writing to:

You can speak for yourself at the hearing or you can have a friend, attorney, or other person speak for you, but you must get these people to help you. You may ask for free legal aid at a legal aid office in your area.

Cov nyiaj pab khoom siv muaj cwj ciam (LUA) tau muab nce ntawm \$94.00 mus rau \$99.00 ntawm xyooj npaj nyiaj hauv tsoom fwv (FFY) 2012, los kuj siv tau txij hnuv tim 1 lub Kaum Hli Ntuj, 2011.

Yog tias SUA/LUA raug muab siv raws feem ntawm koj qhov kev txiav nyiaj chaw nyob thiab yog tias koj tseem tsis tau muaj kev hloov

hauv koj cov nyiaj CalFresh, koj cov nyiaj pab ntawm CalFresh kuj yuav raug hloov. Nrog kev hloov hauv koj cov nyiaj pab ntawm CalFresh, cov nyiaj uas koj yuav tau txais nce raws lwm yam hloov hauv tsev neeg. Cov kev hloov no yuav xam nrog rau hauv ib tsab ceeb toom koj tau txais uas qhia koj txog lwm qhov kev hloov hauv koj cov nyiaj pab ntawm CalFresh.

Yog koj xav tias peb tau ua ib qho twg yuam kev hauv kev xam koj cov nyiaj CalFresh lub Kaum Hli Ntuj vim cov nyiaj tshiab coj los faib thiab SUA/LUA koj kuj yuav thov ib lub rooj kho ob tog lus hauv xeev, **tsis dhau 90 hnuv tom qab uas koj tau txais tsab ntawv no** los ntawm kev sau ntawv mus rau:
