1. Nkag mus rau thiab kuaj lub chaw zov menyuam yam tsis tas qhia paub ua ntej thaum twg lawv tab tom zov menyuam.
2. Ua daim ntawv foob tus neeg muaj lais-xees rau tim lub hoob kas muab lais-xees thiab kuaj tus neeg muaj lais-xees cov ntaub ntawv uas nyob tim lub hoob kas muab lais-xees.
3. Kuaj, tim lub chaw zov menyuam, tej ntaub ntawv qhia txog kev kuaj lais-xees thiab tej lus foob tus neeg muaj lais-xees uas muaj tseeb thaum peb lub xyoos tag los no.
4. Tham lus tsis txaus siab rau lub hoob kas muab lais-xees thiab kuaj lub chaw zov menyuam yam koj thiab koj tus menyuam yuav tsis raug cais lossis raug tawm tsam.
5. Ua ib daim ntawv thov hais tias kom tsis txhob pub lwm tus niam txiv tuaj saib koj tus menyuam lossis koj tus menyuam tawm ntawm lub chaw zov menyuam mus qhov twg, tsuav yog koj muaj ib daim ntawv xam tso cai ua li no.
6. Txais los ntawm tus muaj lais-xees hais txog lub npe, chaw nyob thiab tus xov tooj ntawm lub hoob kas muab lais-xees.
