Qhov no txhais tau tias peb yuav tsis pauv hloov koj cov nyiaj ntsuab pab dawb rau lub sijhawm no.

[] Koj daim ntawv hais qhia tom ntej yog thaum lub sijhawm rov qab txheeb xyuas qhov tseeb hauv ib lub xyoos puag ncig. Txhua yam ntaub ntawv yuav tsum muab hais qhia thiab raug lees paub rau ntawm koj daim ntawv rov qab txheeb xyuas qhov tseeb dua SAWS 2.
