(PIN Personal Identification Number)

Tus leb PIN muaj plaub tug leb cim tseg tsis muaj lwm tus paub koj siv nrog koj daim ntawv EBT los pab thaiv tsis pub lwm tus siv koj daim ntawv tsuas koj thiaj siv tau xwb. Lub cav POS tsuas ua hauj lwm thaum koj ntaus koj tus leb PIN xwb. Tseem ceeb heev yog koj kawm thiab nco koj tus leb PIN. Koj tus leb PIN yuav zoo li no ntawm lub cav POS.



Paib Quest® (Quest® Mark)

Koj yuav pom daim paib Quest® ntawm tej qhov rooj pem tab laj, ntawm cov kab mus sawv them khoom, thiab ntawm cov cav POS uas nws txais koj daim ntawv EBT ntawm nws lub tab laj lossis ntawm lub cav ntawv. Nrhiav daim paib Quest® nrog cov nduab no ua ntej koj yos tab laj.



Txog Koj Tus PIN

- Koj plaub tug leb tsis muaj lwm tus paub hu Personal ID no lossis PIN.
- Txhua zaus koj siv daim ntawv no, koj yuav tau siv koj tus PIN lossis daim ntawv yuav TSIS ua hauj lwm thiab koj yuav siv TSIS tau koj cov nyiaj.
- TSIS MUAJ leej twg paub koj tus leb PIN tseem ceeb heev yog kom koj nco ntsoov.



Yog Li Cas Thiaj Khaws Tau Tus Leb PIN Zoo

- TSIS TXHOB sau koj tus leb PIN IB ZAUG rau koj daim ntawv, lub hnab cia daim ntawv lossis lwm yam koj khaws nrog koj daim ntawv.

Ruam 7 Khaws koj daim receipt koj thiaj paub tias seem nyiaj li cas rau lwm zaus koj yos tab laj.
