- (2) Meih sei benx ninh mbuo gorngv hoic mborqv jaa-zinh benx yietc dauh mienh dongh meih ba'baac liepc hnyouv zoux waaic gong-bou maiv baac maiv gaengh duqv goz faaux zongc wueic laaix meih duqv zoux buangv junh yietc zungv gong-bou laengx ei gan ninh mbuo goz zongc jauv louc nzengc mi'aqc.

- Meih nyei zornc nyaanh aengx caux ga'naaiv nyungc siou-setv yaac zuqc nzipc jienv saav funx mingh dongh haaix zanc ninh mbuo dorh mingh paaiv mangc jaa-dingh sei maaih ze'buonc pui-zipv horpc duqv gin fu'loqc nyaanh nyei fai wuov.
- Meih caux/a'fai domh mienh hmuangv doic yiem biau zong ga'nyuoz oix zuqc jaav nzuonx gan ca'lengc CalFresh nyaanh dongh hmuangv doic duqv zipv longc jhex daaih wuov, se gorngv haaix nyungc, zuov taux meih duqv jaav nzuonx sung nzengc.
- Meih nyei jaa-dingh CalFresh nyaanh yaac haih zuqc zanz zoqc njiec a'fai dingh maiv duqv zipv dongh meih maiv maaih ze'buonc pui-zipv nyei ziangh hoc lemh jienv da'nyeic dauh hmuangv doic yiem jaa-dingh ga'nyuoz.

- Meih yaac maiv maaih ze'buonc pui-zipv horpc longc CalFresh gong bou yiem paaiv njiec nyei ziangh hoc se gorngv beiv taux ninh mbuo porv leiz ciangv lorz maiv buatc gorngv meih za'gengh gu'baeqc zoux dorngc yaac baac.

- 12 hlaaz nyieqc (benx zuqc dornge da'1 nzunc).
- 24 hlaaz nyieqc liouh:
  - Benx zuqc zoux dornge da'2 nzunc.
  - Ninh mbuo porv leiz ciangv duqv njiec zuiz bun gorngv wueic laaix dorh CalFresh nyaanh mingh zoux saeng-eiz zoux dornge da'1 nzunc.
- 10 hnyangx wueic laaix gu'baeqc a'fai bun waa-fienx mingh bun bieqc hnyouv dornge nyungc zeiv, buon-deic dornge dauh yiem zoqc dauh mienh bun duqv zipv CalFresh nyaanh camv nzunc.
- Dingh yietc liuz liouh:
