SUBJECT: FISCAL YEAR 2014-15 REVISED PERCENTAGE CALCULATION

FOR THE 2011 REALIGNMENT PROGRAMS IMPACTED BY SENATE BILL (SB) 1020 (CHAPTER 40, STATUTES OF 2012) AND SB 1013 (CHAPTER 35, STATUTES OF 2012) AND

ADJUSTMENT TO JANUARY AND FEBRUARY 2015

PROTECTIVE SERVICES SUBACCOUNT

REFERENCE: CFL NO. 13/14-42, DATED APRIL 4, 2014

This letter informs counties of the Fiscal Year (FY) 2014-15 revised Protective Services Subaccount percentage distribution pursuant to Government Code section 30027.6.

Attachment I displays the FY 2014-15 revised Protective Services Subaccount base percentage distribution. This percentage includes each county's FY 2013-14 Protective Services Subaccount base; the growth distributed by the State Controller's Office (SCO) on November 24, 2014 (refer to website: <u>California State Controller's Office: Fiscal Year 2013-2014</u>); and FY 2014-15 <u>AB 12</u> After 18 program funds in the amount of \$15.3 million.

In conjunction with the County Welfare Directors Association (CWDA), the AB 12 After 18 program funds of \$15.3 million were distributed based on the following:

- Fifty percent of funds were distributed based on a percent to total of each county's FY 2013-14 After 18 program expenditures as reported on the County Expense Claim and Assistance Claim (CA800).
- The remaining 50 percent of funds were distributed to each county based on the number of Foster Care cases between 17 and 20 years of age for both child welfare

and probation as of the April 2014 quarter. The caseload data was obtained from the University of California, Berkeley, Center for Social Services Research quarterly extracts from the Child Welfare Services/Case Management System.

• The distribution was adjusted to ensure no counties received less in FY 2014-15 than what they received in FY 2013-14 prior to growth, pursuant to <u>Government Code Section 30029.5</u>, subdivision (b), paragraph (1).

Attachment II displays the necessary adjustments to the 2011 Realignment revenues required to correct distributions for the months of September 2014 through November 2014. These adjustments will be reflected in the January 2015 and February 2015 Local Revenue Fund distribution to counties. Each county's final adjusted distribution percentage has been determined based on a percent to total of the revised base in the amount of \$1.9 billion as displayed in Attachments I and II.

An additional amount of \$32.7 million was set aside for distribution to Santa Clara County, the county designated to receive funding that will be used to reimburse the state for realigned contracts and services that will continue to be administered by the California Department of Social Services (CDSS) pursuant to <u>Government Code Section</u> 30029.8.

The CDSS will continue to issue the federal fund advances as previously provided and will remain the single state agency for the administration of federal funding. The Department of Finance (DOF) is required to provide an annual county distribution schedule for the Protective Services Subaccount to the SCO, which is done in coordination with CDSS and CWDA. The DOF provided the revised county distribution schedule for FY 2014-15, consistent with the overall distribution percentages contained in Attachment I to SCO in December 2014.
