Absent parent	The parent who does not live with or have custody of the child, but does have responsibility for paying child support.
Accusation (CCL)	A formal, written statement of the statutory or regulatory violations or other deficiencies upon which a request to revoke a license with or without a suspension is made. Also known as a pleading.

Action for Civil Judgement (CW)	The action taken by the appropriate county official to take the recipient or former recipient to court.
Acute Care Facility	A place where urgent care is given.
AD	Authorization Document

Adequate care	Care which is sufficient for a specific requirement.
Adequate notice	A written notice informing the claimant of the action the county intends to take, the reason, the specific regulations supporting the action and an explanation of the claimant's right to request a state hearing. The notice must be in clear, nontechnical language and sent to the claimant in duplicate, in a timely manner.
ADH (FS, CW)	Administrative Disqualification Hearing
Adjustment to order (CS)	See Modification
Administrative Action (CCL)	A term applied to legal actions against a licensee initiated by CDSS.
Administrative Disqualification Hearing Waiver (FS, CW)	See Waiver of Right to an Administrative Disqualification Hearing
Administrative error overpayment (CW)	An overpayment caused by an error on the part of the county when all information necessary to make a correct determination of the grant was in the possession of the county.
Administrative hearing (CCL)	A formal proceeding, comparable to a trial.
Administrative hearing (SHD)	See "State hearing"
Administrative Law Judge (CCL)	ALJ - An impartial hearing officer from the Office of Administrative Hearings who presides over an administrative hearing in a licensing case.
Administrative Law Judge (SHD)	ALJ - An impartial hearing officer from SHD who presides over an administrative hearing in a public assistance case.
Adopted decision (DAPD)	A decision regarding disability made by one level of authority and accepted by another level.
Adoptee	Person who is adopted or being adopted.
Adopting parent	Parent who is in the process of adopting a child(ren).
Adoption Assistance Program	AAP - Provides financial assistance, including help with medical care, to families who adopt special needs children.
Adoptive parent	Parent who has adopted a child(ren).
Adult adoptee	Adult who is adopted.
Adult Aid Programs	Programs providing benefits for the aged, blind, and disabled which are administered by CDSS. These include State Supplementary Payment Program, Special Circumstances, and Interim Assistance.

Adult Basic Education (CW WTW)	ABE - A welfare-to-work activity that encompasses programs, including English-as-a-Second Language, which help participants to improve reading, writing, and arithmetic skills and to obtain high school proficiency or general educational development certificates.
Adult caretaker relative (CW)	A person age 18 or older taking care of a related minor.
Adult Day Programs Facility	A facility that offers community-based day programs designed to meet the needs of functionally-impaired adults who require personal services, supervision, or assistance with activities of daily living on less than a 24-hour basis.
Adult (Medi-Cal)	 A person who is 21 years of age or older. A blind or disabled MN person who is 18 to 21 years of age, living in the home of a parent and not currently enrolled in school. Any person who is now or has been married, regardless of age, unless the marriage was annulled. An AFDC-MN or MI person who is 18 to 21 years of age, who is not living in the home of a parent or caretaker relative. A person 14 to 18 years of age who is not living in the home of a parent, caretaker relative and who does not have a parent, caretaker relative or legal guardian handling any of his/her financial affairs.
Advanced Earned Income Credit	Earned Income Credit (EIC) applied in advance instead of being applied at the time the income tax is filed.
AE	Administrative Error
AED	Automatic External Defibrillator
AFDC	See Aid to Families with Dependent Children. Also see CalWORKs which replaced the AFDC Program with some exceptions.
AFDC-FC	See Aid to Families with Dependent Children-Foster Care
AFDC-FG	See Aid to Families with Dependent Children-Family Group. Has been replaced by CalWORKS.
AFDC-MN (Medi-Cal)	Aid to Families with Dependent Children-Medically Needy
AFDC-U	See Aid to Families with Dependent Children- Unemployment. Has been replaced by CalWORKs.
Affidavit	A statement in writing made under oath or an affirmation before an authorized magistrate or officer.
Affirmative misstatement	A false statement.
AG	Attorney General. See Attorney General's Office.

Agency adoption	Placement by an adoption agency or a CDSS adoptions district office of children given up (legally relinguished) to the agency by their natural parent(s). Also known as a relinguishment adoption.
Agnos Act	The Agnos Child Support Standards Act of 1984 specifying how much child support should be paid. The amount to be paid is based on the income and earnings of each parent.
Aid	Cash assistance, food stamps or Medi-Cal.
Aid Paid Pending Decision	In some cases the judge will render a decision at the end of the hearing, but in other cases the judge will issue an order for Aid Paid Pending Decision to allow the claimant to continue receiving his or her regular benefits until the decision is rendered.
Aid Paid Pending (SHD)	APP - Aid paid pending an administrative hearing. Aid which continues in the amount that the claimant would have been paid if the proposed action were not to be taken provided that the claimant files a request for a state hearing prior to the effective date of the notice of action.
Aid to Families with Dependent Children	AFDC - A public assistance program designed to provide aid for children who are deprived of financial support and care due to the absence, incapacity, unemployment, or death of either parent. Has been replaced by CalWORKs in most cases.
Aid to Families with Dependent Children-Family Group	AFDC-FG provides aid to children in a family group in which the child is deprived because of the absence, incapacity or death of either parent. Has been replaced by CalWORKs.
Aid to Families with Dependent Children-Foster Care	AFDC-FC provides aid to needy children in foster care. Has not been replaced by CalWORKs.
Aid to Families with Dependent Children-Unemployment	AFDC-U provides aid to children in a family group in which the child is deprived because of the unemployment of the principal wage earner living in the home. Has been replaced by CalWORKs.
AIDS	Acquired Immunodeficiency Syndrome
AIM	Access for Infants and Mothers
Alien	A person lawfully admitted for permanent residence or permanently residing in the United States under color of law.
Alien Registration Card	A card issued by U.S. Citizenship and Immigration Services (USCIS) (formerly known as the Immigration and Naturalization Service [INS]) which is used to verify legal residency in the United States.
Alien status	The condition of an alien (i.e., legal or illegal).

Alimony	Spousal support after divorce.
ALJ	See Administrative Law Judge
Alleged	Accused but not proven or convicted.
Alleged father	A person that is said to be the father (of a certain child).
Allot	To assign as a share or portion.
Allotment (FS)	The total value of food stamp coupons a household is authorized to receive during each calendar month of certification.
Allowable deductions	Deductions that are allowed when budgeting an assistance unit's grant.
Allowance	Something that is considered acceptable or approvable as a deduction when computing the claimant's assistance.
Alternate Decision	A state hearing decision adopted by the Director which differs from the original hearing officer's decision. The Director's decision is binding.
Alternative Payment Program (CS)	APP - A program administered through the California Department of Education providing vouchers or vendor payments for child care services to parents or guardians who are working, in training, incapacitated, seeking employment or are homeless.
Alternative Work Experience (GAIN)	AWEX - A work experience activity for which no pay is given but which enables a person to develop marketable skills and gain useful work experience while continuing to receive cash aid and other benefits. A person is expected to look for a job while participating in an Alternative Work Experience. Obsolete.
Amnesty	The act of an authority (as a government) by which pardon is granted to a large group of individuals.
AMS	Asset Match System
Annual Review Period (FS)	The 12 month period from October 1 of each calendar year through September 30 of the following calendar year.
Annuities	Contracts with insurance companies that provide tax deferral on your investment. They can be fixed rate or variable and there is no limit to the amount you can contribute each year. You give your money to an insurance company to invest over a specific period of time and the money earns tax-deferred interest until it is withdrawn.
APP	See Alternative Payment Program or Aid Paid Pending

Appeal	To take a lower court's decision to a higher court for review.
Appellant	One that appeals a judicial decision or decree.
Appellee	One against whom an appeal is taken.
Applicant (CC)	Any person or persons making an application for a license to operate a family child care home or child care center.
Applicant (CW)	The individual, family, or child making (or on whose behalf is made) a new application for aid, a request for restoration of aid or a reapplication.
Application, new (CW)	The applicant has not previously applied for the same aid in the same county.
Appraisal	A valuation of property by the estimate of an authorized person.
Appraisal (CW WTW)	The CalWORKs WTW Program component that occurs when the participant enters the Program, at which time he/she is informed by the county of the requirement to participate in training opportunities available to the participant and of the availability of supportive services. During the appraisal, the participant must provide information about his/her employment history and skills, the need for supportive services, and any other relevant information that the CWD requires to assign welfare-to-work activities appropriately.

Arrearage payment (CS)	The amount by which the collection exceeds the current support obligation to be applied to past support owed.
Arrearages (CS)	Unpaid child support payments for past periods owed by a noncustodial parent.
Arrest	The detention of a person to answer a criminal charge.

Assembly Bill	AB - A proposed piece of legislation introduced by way of the Assembly.
Assessed value	Determined value.
Assessment	Appraisal.
Assessment (CW WTW)	The CalWORKs WTW Program component that occurs after the Appraisal and Job Search components. Assessment is the detailed evaluation of the participant's work history and employment skills, educational background and present educational competency level, supportive service needs, chances for employment given the current labor market conditions, and physical and mental limitations. The results of the assessment are used as the basis for the participant's welfare-to-work plan, which identifies the activities and supportive services that the county will provide to the participant to assist him/her in attaining self-sufficiency.
Assets	The entire property of a person, association, corporation, or estate applicable or subject to the payment of debts.
Assignment	A specified task or amount of work assigned or undertaken as if assigned by authority.
Assignment of support rights (CS)	When a person gives up his/her child or medical support rights to the state as a condition of receiving CW (Welfare) or Medi-Cal benefits.
Assistance dog	A general term for all of the following: guide dog for the blind; signal dog for the deaf; and service dog for the disabled.
Assistance Unit (CW)	AU - The individuals who are receiving public assistance under the same case.
Assistant provider (CC)	A person at least 14 years of age who is primarily involved in caring for children during the hours that the home provides care.
At Risk Child Care Program (GAIN)	ARCCP - A program that provides help with child care to families that would be at risk of becoming dependent on Welfare without that help. Has been absorbed into the CalWORKs Child Care Program.
ATM	Automated Teller Machine
ATP Card (FS)	See Authorization to Participate Card
Attorney General's Office	The agency within the Department of Justice responsible for representing state agencies in most litigation.
ATV	All Terrain Vehicle. Also known as "off-road vehicle".

AU (CW)	See Assistance Unit
Authorization to Participate Card (FS)	ATP Card - A document which is issued by the county to a certified household to show the allotment the household is authorized to receive on presentation of such document.
Authorized Representative	AR - A person or group that has written authorization from the applicant or recipient to act on his/her behalf.

BICE	Bureau of Immigration and Customs Enforcement	
Block Grant (CC)	An amount of money set aside for child care for low income families, administered by the Department of Education.	
Board and care	Shelter, food and supervision of persons not in their homes.	
Board and care (Medi-Cal)	 Receipt of board, room, personal care and designated supplemental services related to individual needs in one of the following nonmedical protective living environments: A licensed residential care facility. The home of a relative or legally appointed guardian or conservator, other than the home of a spouse or the home of a parent for a blind or disabled child. A home in which a child is placed by a court under Welfare and Institutions Code 727(a). An exclusive-use home approved by a licensed home-finding agency. 	
Bond	Basically an IOU of a corporation - it is evidence of a debt that the issuing company promises to pay usually with a specified amount of interest. The holder of the bond is a creditor of the corporation, not a part owner as is a stockholder.

Budget computation	The computation of the assistance unit's grant.
Bureau of Citizenship and Immigration Services	BCIS - Formerly known as Immigration and Naturalization Service (INS). Now known as U.S. Citizenship and Immigration Services (USCIS).
Bureau of Criminal Identification Division (CCL)	BCID - A bureau within the Department of Justice where the fingerprints of licensees and employees are sent for processing.

Cal-Learn (CW)	Cal-Learn is a part of the CalWORKs Program. Cal-Learn requires CalWORKs custodial teen parents (up to the age of nineteen) to attend an educational program that will lead to a high school diploma or its equivalent.
	(Note to translators: Cal-Learn can be identified as a CalWORKs Educational Program for Teenage Parents.)
California Administrative Code	CAC - An official publication of the State of California which contains the regulations of state agencies filed with the Secretary of State.
California Department of Health Services	CDHS - The state agency responsible for the public assistance programs related to health care, primarily the Medi-Cal Program.
California Department of Social Services	CDSS - The state agency responsible for supervising the administration of public assistance and social services programs. This includes the Food Stamp (FS) Program, the California Work Opportunity and Responsibility to Kids (CalWORKs) Program, various adult programs, the In-Home Supportive Services (IHSS) Program, and the state hearing process.
California Law Enforcement Telecommunications System	CLETS - A state network that gives agents access to California motor vehicle records, rap sheets and fingerprints.
California Relay Service	Also known as Telecommunication Relay Services
California Work Opportunity and Responsibility to Kids Program	CalWORKs Program - Formerly known as AFDC with some exceptions. The maximum time limit for receiving benefits from this program is 60 months.
CalTAP	The new program substituting AFDC and GAIN.
CalWORKs Program	See California Work Opportunity and Responsibility to Kids Program.

CalWORKs Welfare to Work Program	The state's primary welfare-to-work program that assists CalWORKs cash assistance recipients to attain the employment-related skills needed to become self-sufficient through participation in Job Search, education, skills training, and other programs. Participants are also given necessary supportive services, such as assistance with transportation, child care, and work-related expenses, so that they can complete their programs or find and retain jobs. All recipients must participate for 18 or 24 months, unless they meet specific exemption criteria. Note: Los Angeles County calls its welfare-to-work program "GAIN", even though it is not entirely the same as the original GAIN Program replaced by the CalWORKs Welfare to Work Program.
CAPI	Cash Assistance Program for Immigrants
CARE	Cooperative Agencies Resources for Education
Caretaker relative (CW)	An immediate relative in the home responsible for the care and supervision of an eligible child receiving SSI/SSP.
Case plan (AFDC-FC)	A written document in the services case record which at a minimum specifies how the child's problems or needs identified in the assessment are to be addressed.
Caseworker	A general term used instead of eligibility worker, intake worker, or social worker.
Cash Aid General Assistance Program	Cash aid through the county General Assistance Program.
Cash surrender value	The cash value at any given time of a life insurance policy.
Cash-based Medi-Cal	Medi-Cal eligibility based on cash aid eligibility.
Casual income	Income in cash or in-kind from an inconsequential resource which is unpredictable as to amount and time of receipt, of short duration, and is of negligible importance in meeting the needs of the recipient.
CCDBG	Child Care and Development Block Grant
CCL	Community Care Licensing
CCS	California Children's Services
CD	Certificate of Deposit
CDHS	See California Department of Health Services
CDSS	See California Department of Social Services
CE (DAPD)	See Consultative Examination
Center care, licensed (CC)	Care provided at locations which have been inspected by the state. "Centers" can care for large numbers of children.

Certification period (FS)	The time period for which a food stamp household has been determined to be eligible to receive food stamps.
Certified copy (CS)	A copy of a court document which the court clerk has stated, in writing, is a true and correct copy of the original document.
Certified family home (AFDC-FC)	A family residence certified by a licensed foster family agency and issued a certificate of approval by that agency as meeting licensing standards, and used only by that foster family agency for placements.
CETA	California Education and Training Act
CETA (Medi-Cal)	Comprehensive Employment and Training Act
CFR	Code of Federal Regulations
CHAMPUS (CW)	Civilian Health and Medical Program of the Uniformed Services (a program for ex-military individuals and their dependents or spouses not covered under the VA Program)
Change-reporting household (FS)	A household that is required to give CWD reports about their current status only when there are changes in their situation.
CHDP	Child Health and Disability Prevention Program
CHEP	See Cuban/Haitian Entrant Program
Child Abuse Index Check (CCL)	CAIC - The response from the Department of Justice as to whether a person by the same or similar name has a report on the Index. Also, a form submitted to the Department of Justice in order to access the Child Abuse Registry.
Child Abuse Registry (CCL)	A database maintained by the Department of Justice to collect information on suspected child abusers. Also includes abuse complaints which result in convictions, information on complaints which led to an arrest but not to a conviction, and complaints for which the evidence was insufficient even for an arrest.
Child care children	Children in child care.
Child Care Facility	Any place or building in which less than 24-hour per day non-medical care and supervision are provided to children in a group setting. Formerly known as Child Day Care Facility.
Child Care Services	The comprehensive and coordinated sets of activities providing direct care and protection of infants, preschool and school-age children during a portion of a 24 hour day inside or outside the child's own home.
Child Care Trustline Registry System	See Trustline

Child (CW)	A person, including an infant, who has not yet reached his or her eighteenth birthday.
Child (Medi-Cal)	 A. A person under the age of 21 except for the following persons which are considered adults: 1. A person under the age of 21 who is now or has been married, unless the marriage was annulled. 2. A person 18 to 21 years old, not living in the home of a parent or caretaker relative. 3. A blind or disabled MN person who is 18 to 21 years of age, living in the home of a parent and not currently enrolled in school. 4. A person 14 to 18 years old, not living with a parent or caretaker relative and not having a parent, caretaker relative or legal guardian handling any of his/her financial affairs. B. An unborn is considered a child for Medi-Cal purposes.
Child support	Payments made by absent parents for the support of their children. Support payments for CW children must be paid directly to the county District Attorney.
Child Support State Licensing Matching System	AB 257 expanded the State Licensing Matching System, a system that matches parent names to DMV files. The District Attorney uses this information to suspend or revoke the noncommercial driver's license of delinquent child support obligors until full payment is made.
Child Welfare Services/Case Management System	CWS/CMS - The statewide integrated computer system for children's services cases.
CISO	Citizenship and Immigration Services Ombudsman
Civil penalty (CCL)	A fine assessed by the licensing agency against the licensee or unlicensed operator for failure to comply with applicable law and regulation.
CLETS	See California Law Enforcement Telecommunications System
Closed period (DAPD)	A period of time in the past during which a person was disabled, but the disability is not on-going.
CMSP	County Medical Services Program
Color of law	See PRUCOL
Communal dining facility (FS)	A public or private nonprofit establishment approved by FNS which prepares and serves meals for elderly persons or for Supplemental Security Income (SSI) recipients and their spouses.

Community property	Property jointly owned by husband and wife. In the administration of public assistance, it is presumed that any property of either spouse is considered community property unless evidence establishes it to be separate property.
Community Service/Work Experience Activities	CS/WEA - Community service activities/activities to acquire experience working in the community.
Companion appeal	An appeal involving one case number, but two people have the same problem within the same household and go to the same hearing.
Complainant (CCL)	In an administrative action, the party filing an Accusation or Statement of Issues.
Complaint	A written document filed in court in which the person starting the legal action names the defendant, allegations and desired relief.
Concurrent budgeting	See Prospective budgeting
Conditional withdrawal	A claimant's withdrawal of a hearing request which is contingent upon certain conditions being met.
Conduct inimical (CCL)	Statutory basis for application denials, revocations or excluding someone from a facility because they have acted in a harmful or injurious manner, either in or out of the facility.
Consecutive interpretation	The interpreting of a word or phrase immediately after it has been said, but while no other speaking is in progress.
Consistency (AD)	Related to behavior; e.g., parents applying discipline in the same way each time.
Consultative Examination (DAPD)	CE - A separate medical examination requested by DAPD.
Contempt	Disobeying a court order when a person has the ability to comply.
Continuance	When the hearing officer holds the hearing record open for additional evidence from either or both parties.
Continued absence	A basis for deprivation in the determining of eligibility for CW. Continued absence exists when the natural parent is physically absent from the home and the nature of the absence constitutes a substantial severance of marital and family ties which deprives the child of at least one of the natural parents.
Continuity (AD)	Related to duration; e.g., something continues throughout someone's childhood.
Contracting rural county (CW)	A rural county that contracts with the state CMSP for some medical services. The funding comes from the state, not the county, and is not from Medi-Cal.

Controlled substance	Any drug whose availability is restricted by federal or state law, including, but not limited to narcotics, stimulants, depressants, hallucinogens, and marijuana.
Conviction	Occurs when a person pleads guilty to a criminal charge, is found guilty by a jury verdict or is found guilty by a judge following a plea of no contest.
County Position Statement (SHD)	A written statement that the county must provide to the claimant before the hearing which explains why the action was taken.
County Representative	A county employee who is responsible for preparing and/or presenting the county's position at state hearings.
County Welfare Department	CWD - The county agency responsible for the administration of public assistance and social services programs.
Court trustee	A person or agent, appointed by a court of law, holding legal title to property or money in order to administer it for a beneficiary.

CPLS	California Parent Locator Service
CPS	Child Protective Services
CRCB	See Criminal Record Clearance Bureau
Criminal action (CCL)	A legal action taken against a person for violation of the criminal law.
Criminal Record Clearance Bureau (CCL)	CRCB - The unit in CCL that processes Child Abuse Index Check and criminal records for state-licensed facilities.
Criminal Records Exemption	Written permission by CRCB or a county licensing agency allowing a person with a criminal conviction to be present in a facility licensed by the Department.
CS/WEA	See Community Service/Work Experience Activities
CSRA	Community Spousal Resource Allowance

Rehearing	A state hearing in which an adopted decision is reviewed. A rehearing may be requested within 30 days of receipt of the adopted decision when one of the parties is dissatisfied.

Relocation Family Grant (CW)	RFG - The maximum amount of aid payable to an AU when no member of the AU has lived in California for 12 consecutive months immediately prior to the date of application.

Reporting household (CW, FS)	Households receiving cash aid and/or food stamps are required to give CWD periodic reports about their current status. Share of Cost (Medi-Cal)	SOC - The amount a person or family must pay or promise to pay each month toward the cost of health care services before Medi-Cal will pay. The SOC may change when the monthly income changes.
	A person's or a family's net income in excess of the maintenance need that must be paid or obligated before the person or family receives Medi-Cal.
SHD	State Hearings Division. Formerly known as AAD.
SHSS	State Hearings Support Section
SIU	Special Investigative Unit
Sliding fee scale	A method of determining the amount of a fee to be charged according to each individual's ability to pay.
SLMB (Medi-Cal)	See Specified Low-Income Medicare Beneficiary
Small family home	A home that provides care to a relatively small number of children.
SOC (Medi-Cal)	See Share of Cost
Social Security Administration	SSA - The federal agency responsible for the administration of social insurance programs such as retirement insurance, survivors' benefits, disability insurance, Medicare, etc.
Social services	The composite of services programs funded under Title XX of the Social Security Act and any other applicable funding source. These programs include Information and Referral, In-Home Supportive Services, Protective Services, etc.
Social Worker	A county employee who is responsible for providing access to social services programs for public assistance recipients.
Special Circumstance Allowance Program	A state-funded, county-administered program which provides cash assistance to aged, blind, and disabled recipients of the SSI/SSP Program for expenses related to certain nonrecurring special needs. The categories of assistance include losses due to a natural catastrophe, moving expenses, home repairs, home modifications and payment to prevent foreclosure.

Special needs children adoption	The adoption of children with special needs whose adoption without financial assistance would be unlikely because of adverse parental background; ethnic background; race; color; membership in a sibling group which should remain intact; mental, physical, medical, or emotional handicap; or age three years or more.
Specified Low-Income Medicare Beneficiary	SLMB - Federal law requires that state Medicaid programs pay Medicare costs for certain elderly and disabled persons with low incomes and very limited assets. This program is for persons whose incomes are slightly higher than the national povery level, but not more than 10 percent higher. If qualified, the state is required to pay the monthly Part B premium. The person will continue to be responsible for Medicare's deductibles and coinsurance and for charges for health care services and items not covered by Medicare.
Speedletter	A questionnaire the county sends the claimant requesting different types of information (e.g., housing composition # speedletter).
Spend down	The process of reducing or converting excess property assets in order to become eligible for public assistance.
Sponsor	A person who executed an affidavit(s) of support or similar agreement on behalf of an alien as a condition of the alien's entry or admission into the United States as a permanent resident.
Sponsored alien	An alien whose entry into the United States was sponsored by a person or any public or private agency or organization who, as a part of this sponsorship, executed an affidavit of support or similar agreement on behalf of the alien (who is not the child or spouse of the sponsor) as a condition of the alien's entry into the United States. An alien lawfully admitted for permanent residence into the United States as an immigrant as defined under the Immigration and Naturalization Act.
SS.	An abbreviation used in that part of a record, pleading, or affidavit called the "statement of the venue." Commonly translated to read "to-wit" and supposed to be a contraction of "scilicet".
SSA	See Social Security Administration
SSGP	State Supplemental Grant Program
SSI/SSP linked Medi-Cal	Medi-Cal coverage when a person is eligible for Medi-Cal because he/she is eligible for SSI/SSP benefits.
SSI/SSP (Program)	See Supplemental Security Income/State Supplementary Payment (Program)

State CMSP (Medi-Cal)	Medically necessary benefits for eligible adults not on Medi-Cal who live in contracting rural counties.
State Disability Insurance	SDI - Temporary payments for persons who have become disabled. SDI payments are made from employee wage deductions and are administered by EDD.
State hearing	An informal administrative hearing whereby a dissatisfied claimant may obtain an impartial state review of an action taken by the County Welfare Department (or the California Department of Health Services on certain Medi-Cal issues). CDSS is responsible for the administration of the hearing process and the conducting of each hearing.
State Interim Assistance Reimbursement Authorization	An authorization for the state to reimburse the intermim assistance (General Assistance/General Relief) a county gave the client while he/she waited for CAPI to determine if he/she was eligible for CAPI aid and the amount of that CAPI aid.
Statement of Facts (CCL)	A report from a licensing office requesting revocation of a license, denial of an application or exclusion of an employee from a facility.
Statement of Issues (CCL)	A formal, written statement, or pleading, prepared by the Legal Division which sets forth the grounds upon which an initial license application has been denied by the local licensing office.
Statewide Automated Child Support System	SACSS - A federally-mandated statewide child support reporting system that links all counties' family support division records to the Department of Child Support Services.
Statewide Automated Welfare System	SAWS - A system that automates the major public assistance programs, including CW, FS, and Medi-Cal, while ensuring uniform application of program policy and client services.
Step-parent	The person who is married to the parent of a child and who is not the natural parent of that child.
Step-parent adoption	The adoption of the children of one's spouse.
Step-Parent Unit	SU - An individual or group of individuals which may include step-parent and spouse, their separate and common children, and any other persons living in the home who may be claimed by the step-parents as dependents for federal income tax purposes when they are not in the Family Budget Unit (FBU).
Stipulation (CS)	An agreement between the parties to an action. All FSD stipulations are submitted to the court. The court accepts the terms of the agreement and makes an order.
SU	See Step-Parent Unit

SUA (FS)	Standard Utility Allowance
Subsidized child care (CC)	Child care for low-income families provided on a sliding fee scale and funded by the California State Department of Education.
Supervised Job Search (CW WTW)	An organized method for CW WTW clients to seek work, which includes access to phone banks in a clean, well-lighted place, answering job orders, and receiving direct referrals to employers. Supervised Job Search is overseen, reviewed, and critiqued by an employment counselor to identify problems a client might have in obtaining employment.
Supplemental Security Income/State Supplementary Payment (Program)	SSI/SSP - The public assistance program designed to provide financial aid to eligible aged, blind or disabled individuals. The Social Security Administration determines eligibility and amounts of entitlement. The SSI/SSP Program is administered by the SSA and is funded at both state and federal levels.
Supportive Work (CW WTW)	A welfare-to-work activity, and form of subsidized employement, in which all or part of the participant's cash assistance grant and/or grant savings resulting from employment is diverted to an intermediary service provider to partly or wholly offset the payment of wages and/or the costs of providing training to the participant.
Suspense month (CW)	The ineligibility for aid for one month. (The case is on hold, not discontinued.)
Suspicious death (CCL)	Death of a client of a care facility which is not clearly the result of natural causes or in which the causes are unknown.

Title XX	The Section of the Social Security Act which governs the social service programs.

A facility shall be deemed to be an unlicensed care facility if it is maintained and operated to provide nonmedical care, is not exempt from licensure, and any one of the following conditions exists: the facility is providing care and supervision, is held out as or represented as providing care and supervision to more than one client, accepts or retains residents who demonstrate the need for care and supervision, or represents itself as a licensed care facility.
UAM - A male, 18 years of age or older, living in the household of a CW family that is not related by blood or marriage to that family.

Work Pays Program	A program established to promote work for welfare recipients. Serves as a first step toward self-sufficiency by allowing recipients to keep most of their income from work.
Work Readiness Screening	An evaluation to determine if the person is ready to work.

Writ of execution (CS)	A court order instructing the sheriff or marshal to seize property to satisfy a court judgement.
