Workplan for 1997 - 1998 for Local Child Care Planning Council and Staff

The following is the workplan adopted by the Local Child Care Planning Council on July 9, 1997 to implement the Recommendations as contained in the Local plan submitted to the State Department of Education on June 10, 1997 following adoption by the Sacramento County Board of Supervisors and the Sacramento County Board of Education on May 20, 1997. The format contains 1.) a restatement of the recommendation, 2.) tasks to be completed, 3.) who is responsible and 4.) date for implementation/completion.

RECOMMENDATIONS

FEDERAL BLOCK GRANT

- Continue the approval process for five planning areas for distribution of Federal Block Grant funds as described in Attachment A1
- Approve the use of the certificate (Alternative Payment) program countywide, regardless of Local Plan Area to assure continuity of care
- Delete the priority for Direct Service for Homeless Children, as they tend to be considered Children at Risk and have first priority call on Federal Block Grant Funds, as at risk children.

The recommendations regarding the allocation of Federal block Grant Funds were forwarded to the State Department of Education, Child Development division in June 1997.

Tasks to be completed - monitor approval of same by CDD - track date of receipt and forward information to: Local Child Care Planning (LCCP) Council, Board of Supervisors and County Board of Education. Others to be notified include Penelope Clarke, Cheryl Davis and Alan Boyd or other designee in the City of Sacramento.

SUPPLY EXPANSION:

- Recruit and train 125 new teachers and teacher aides to staff expanded child care centers for 1,500 additional children.

This recommendation is the primary responsibility of the Community Colleges and their collaborators.

- * Develop and set up tracking mechanism(s) to document recruitment and training efforts and the numbers who respond to recruitment; enter training and complete necessary training for both teacher and teacher aide position(s)

There are 91,840 children between birth through age 12 whose parents currently receive AFDC. In order to determine the number of additional children needing licensed child care as a consequence of welfare reform the following adjustments were made to the total number of AFDC children: a reduction of 20.09% for those in two parent families in Sacramento County, assuming that one parent will care for the child(ren); a subsequent reduction of 19.6% to account for families already working and whose children are already in care; and a reduction of 70% leaving a remainder of 30% representing the work participation requirement for single parents in 1998. That amount combined with the 19.6% already working represents the 50% work participation rate required for single parent AFDC/TANF recipients by 2002. The final reduction of 51% was made based on the national average of children for whom parents utilize other than licensed child care. The resulting figure is the conservative estimate of the number of children (by age) needing licensed child care in 2002.
