IMMIGRATION SERVICES FUNDING
TENTATIVE AWARD ANNOUNCEMENT**

The California Department of Social Services (CDSS), Immigration Branch is pleased to announce it has offered funding to 62 nonprofit organizations for Immigration Services for Fiscal Year 2015/16. These offers total \$14,460,000 for the contract period of January 1, 2016 through June 30, 2017. Senate Bill (SB) 79 (Statutes of 2015, Chapter 5.6) authorized the CDSS to award funding to qualified nonprofit organizations to provide services to immigrants who reside in the state of California.

Immigration services include the following five service categories: (1) Services to Assist Applicants seeking Deferred Action for Childhood Arrivals (DACA) or other immigration remedies; (2) Services to Assist Applicants seeking Deferred Action for Parents of Americans and Lawful Permanent Residents (DAPA) or other immigration remedies; (3) Services to Assist Applicants seeking Naturalization; (4) Legal Training and Technical Assistance Services; and (5) Education and Outreach Activities.

The percentage of funding for the five service categories are described below:

- 59% for Application Assistance – DACA/Other Immigration Remedies
- 6% for Application Assistance - DAPA/Other Immigration Remedies
- 16% for Application Assistance – Naturalization
- 3% for Legal Training and Technical Assistance
- 16% for Education and Outreach
