SUBJECT: AID TO FAMILIES WITH DEPENDENT CHILDREN-FOSTER CARE
(AFDC-FC) CALIFORNIA NECESSITIES INDEX (CNI) INCREASES
AND OTHER RATE INCREASES

The purpose of this ACL is to provide the adjusted schedules of rates that reflect the CNI increase of 2.54 percent for fiscal year (FY) 2015-16. The CNI increase is applicable to out-of-home placements in the AFDC-FC Program. The California Department of Social Services (CDSS) will issue an ACL each year adjusting the rates to reflect changes in the CNI.

Non-federal and federal Kinship Guardianships (Kin-GAP) and State AFDC-FC Non-Related Legal Guardians (NRLG) prior to May 1, 2011

Effective July 1, 2015, the 2.54 percent CNI increase applies to the Foster Family Home (FFH) basic rate for Kin-GAP cases when dependency was dismissed prior to May 1, 2011, and for NRLG cases in which guardianship was established prior to May 1, 2011, and is reflected in Table A below:

Effective July 1, 2015, a 1.27 percent CNI increase applies only to the 12-14 age categories of the Orange County grandfathered FFH basic rate for cases when dependency was dismissed prior to May 1, 2011 and is reflected in Table A-1 below:

*WIC Section 11461(d)(2)(A) provides that for grandfathered rates greater than the schedule of basic rates, only “one-half of the percentage (CNI) adjustments” shall be applied.

Foster Family Homes, Non-Relative Extended Family Members (NREFM), Kin-GAP and Non-Related Legal Guardianship (NRLG)

Effective July 1, 2015, the 2.54 percent CNI increase applies to the FFH basic rate for a licensed or approved FFH, an approved home of a relative, an approved home of a NREFM, a Title IV-E Tribal licensed or approved home, Kin-GAP cases in which dependency was dismissed after May 1, 2011, and NRLG cases in which the guardianship was established after May 1, 2011, and is reflected in Table B below:

Non-Minor Dependents (NMDs) Ages 18 and Up

All NMDs residing in a Supervised Independent Living Placement (SILP) will receive the basic foster care rate of \$859 per month. The Specialized Care Increment (SCI) cannot be paid to NMDs in a SILP. Parenting NMDs can receive the infant supplement when residing in a SILP.

Dual Agency Rates

Effective July 1, 2015, the 2.54 percent CNI increase applies to the Dual Agency rate and is reflected in Table C below:

Foster Family Agencies (FFAs)

Effective July 1, 2015, the 2.54 percent CNI increase applies to the FFA basic portion of the rates only and does not change the remaining components of the FFA treatment program rate as outlined in the Manual of Policies and Procedures section 11-403. As required by regulation, a minimum of the basic rate and the child increment are to be passed on to the FFA certified home for each child each month. The FY 2015-16 FFA rates are reflected in the following Tables D and E:

Intensive Treatment Foster Care/Multidimensional Treatment Foster Care (ITFC/MTFC)

The SB 1013 authorized an interim increase in the ITFC/MTFC rates, changed the service hours and rate levels and increased the minimum amount paid to the certified foster parent. The interim rate increase was in effect for three FYs beginning on July 1, 2012 through June 30, 2015, by an amount equal to the CNI computed pursuant to WIC section 11453. The rate for FY 2015-16 ITFC/MTFC rates will remain the same as of the effective date of July 1, 2014, and is reflected in Table F below:

Additionally, children may not be placed at a Rate Level I or II for more than six months unless it is determined to be in the best interest of the child by the child’s county interagency review team or the county placing agency, FFA and the child’s certified foster parents. Extensions may be granted in six month increments.

Group Homes (GHs)

Effective July 1, 2015, the 2.54 percent CNI increase applies to each GH Rate Classification Level (RCL) and is reflected in Table G below:

Wraparound

Effective July 1, 2015, the 2.54 percent CNI increase applies to the Wraparound rates and is reflected in Table H below:

Out-of-State Group Homes

The rate paid for California out-of-state (GH) placements is the rate established by the rate-setting authority of the other state. The county cannot claim federal financial participation for any rate amount exceeding the current FY's RCL 14 or exceeding the rate determined by the rate-setting authority of the state in which the facility is located. The county is responsible for determining if any non-allowable costs are included in the rate and ensuring that only allowable costs are claimed for federal Title IV-E AFDC-FC reimbursement. Allowable costs are defined as food, clothing, shelter, daily supervision, school supplies, a child's personal incidentals and liability insurance with respect to a child, reasonable travel to the child's home for visitation and reasonable travel to the child's school of origin. For out-of-state GH placements, allowable costs also include reasonable administration.

Specialized Care Increment

In accordance with WIC section 11461(e)(4)(C)(i), the SCI will not receive a cost-of-living adjustment (COLA) in FY 2015-16. However, a county may choose to apply a COLA to its SCI. Consistent with the realignment of funding, there will be no state share-of-cost for any adjustment.

Infant Supplement

The infant supplement rates are to remain at the levels approved effective January 1, 2008. If applicable, youth who are in guardianships receiving AFDC-FC benefits are also entitled to receive the Infant Supplement. The Infant Supplement rate is reflected in Table I below:
