Attachment A provides the following information: 1) the base population that meets the conditions in the referenced methodology and the corresponding number of available 20 percent extensions in each CWD for the current period from July 2016 through December 2016, and, 2) the estimated targets per CWD since January 2015.

If a CWD disagrees or has more relevant data to support different target figures, the CWD shall submit data and arguments to SB104120Percent@dss.ca.gov, within thirty days of the release of this ACL.
