This letter informs counties of the final base caseload and funding amounts and the Fiscal Year (FY) 2015-16 allocation for the Approved Relative Caregiver (ARC) Funding Option Program. A total of \$30.1 million General Fund (GF) is available pursuant to Senate Bill 79 (Chapter 20, Statues of 2015).

The enclosed attachment display the county specific allocation for the ARC program. In consultation with the County Welfare Directors Association, the funds were distributed as follow:

 The Final True-Up base distribution was calculated based on the county specific ARC caseload submitted by counties, as outlined in <u>CFL No. 15/16-07</u>. For those counties who did not submit an ARC caseload, CDSS used a Child Welfare Services/Case Management System and Med-Cal Eligibility Determination System data match from July 2014 to develop the base caseload. - The FY 2015-16 Initial ARC Allocation distribution was calculated by multiplying the eligible caseload with the Foster Care basic rates and the regional CalWORKs Maximum Aid Payment levels in effect July 1, 2014, as outlined in ACL No. 14-44.
- A minimum ARC GF base of \$10,000 is distributed to participating counties, where the calculated methodology for the ARC county GF fund level is below \$10,000.
- This initial ARC allocation distribution takes into consideration the Cost of Living Adjustment impact, which was based on the foster family home basic rate by age group and the CalWORKs regional Map rates effective July 1, 2015.
- The remaining \$1.1 million is distributed based on each county's percent to total of the \$29 million allocation distribution.

Appropriate adjustment will be made during the year-end closeout to redistribute county specific unspent funds to those counties who overmatch their allocation.

## Assistance Claiming:

Effective with the March 2015 claiming month, five new aid codes are available for use on the CA 800 ARC claim, which will be utilized to capture assistance costs associated with the ARC program. Please refer to <u>CFL No. 14/15-52</u>, for further claiming instructions.
