This errata informs counties of the revised Maintenance of Effort (MOE) Requirement for the In-Home Supportive Services Program (IHSS).

County Fiscal Letter No. 15/16-38 inadvertently displayed the incorrect preliminary Fiscal Year (FY) 2015-16 IHSS County MOE amounts.

The attachment displays the revised preliminary FY 2015-16 IHSS County MOE amounts for the following counties: Alameda, Imperial, Inyo, Marin, Mariposa, Modoc, Nevada, Plumas, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Clara, Sierra, Stanislaus, Tuolumne and Ventura.

The methodology for the preliminary FY 2015-16 IHSS County MOE remains the same and is calculated as follows:

The full annualized wage and health benefit increase in FY 14-15 (the hourly increase multiplied by the number of FY 2011-2012 eligible hours) with the applicable 3.5 percent inflation factors applied is added to the FY 2014-15 IHSS MOE with the 3.5 percent inflation factor applied to obtain the FY 2015-16 IHSS MOE base.

An additional 3.5 percent inflation factor is applied to the FY 2015-16 IHSS MOE base to obtain the preliminary FY 2015-16 IHSS MOE.
