SUBJECT: MARTINEZ v. SCHWARZENEGGER COURT ORDER

AFFECTING STATE PARTICIPATION IN-HOME SUPPORTIVE SERVICES (IHSS) PROVIDER WAGES AND HEALTH BENEFITS

**REFERENCE: ALL COUNTY LETTER 90-19** 

This All County Information Notice notifies counties of the recent court order in the case of *Martinez v. Schwarzenegger.* 

On February 20, 2009, Senate Bill X3 6 (Chapter 13, Statutes of 2009) was enacted, which amended Welfare and Institutions Code section 12306.1 to reduce the maximum state participation in negotiated In-Home Supportive Services Individual Provider wages and benefits from \$12.10 per hour to \$10.10 per hour. This reduction was to take effect on July 1, 2009. On June 26, 2009, the federal district court for the Northern District of California issued an injunction prohibiting the department and other state agency defendants from implementing the above reduction in maximum state participation. The maximum state participation in wages and benefits will remain at \$12.10 per hour as long as the injunction remains in effect.
