The purpose of this letter is to inform County Welfare County Departments of the release of the increased CalWORKs Minimum Basic Standards of Adequate Care Tables in ACL 13-48 dated June 11, 2013. All counties may use the Region 2 Table to assist in assigning a monetary value upon in-kind assistance (i.e., assistance that is not in the form of cash) provided to a noncitizen by the sponsor or other individuals to determine indigence in the CalFresh Program. Refer to ACLs 11-06 and 11-06E for more information on sponsor deeming and indigence.
