SUBJECT: REMOVAL OF THE SOCIAL SECURITY NUMBER FROM ALL

FEDERAL DEPARTMENT OF TREASURY CHECKS

AND

SOCIAL SECURITY ADMINISTRATION FIELD OFFICE INTERIM ASSISTANCE REIMBURSEMENT LIAISONS

The purpose of this All-County Information Notice (ACIN) is to inform counties that effective January 2004, social security numbers (SSN) will no longer be printed on checks issued by the Federal Department of the Treasury.

This includes Social Security, Supplemental Security Income/State Supplementary Payment, and Interim Assistance Reimbursement (IAR) checks. The removal of the SSN from all Treasury checks is part of the Department of Treasury's efforts to protect the privacy of the individual's SSN and help reduce the opportunity for identity theft.

While the SSN will no longer be printed on the IAR checks, it will still appear on the IAR Form SSA-L8125, Notice of Interim Assistance, which the Social Security Administration (SSA) sends to Interim Assistance (IA) agencies.

Since IAR is a time-sensitive process that requires precise handling, we recommend counties review their internal procedures to ensure that the SSA-L8125s, and the IAR checks, are associated and routed to appropriate staff promptly. If an IA agency does not receive the corresponding SSA-L8125 with the IAR check, they should notify the SSA servicing field office within five calendar days, so that the field office can prepare and issue a manual notice. When contacting the field office, the IA agency should provide the twelve-digit check and serial number located in the upper right-hand corner of the paper check.

In an effort to facilitate a smooth transition and ensure communications between county IA agencies and SSA field offices, attached to this ACIN is an updated list of SSA Field Office IAR Liaisons, by county. The role of the IAR field office liaison is to ensure that eligibility and payment information is verified and provided to the IA agency as needed. If you do not know which field office to contact, or have a problem obtaining the needed information, you should contact the IAR liaison in the field office nearest youragency.
