SUBJECT: DISASTER UNEMPLOYMENT ASSISTANCE DUE TO FREEZE IN JANUARY, 2007 IN THE FOOD STAMP PROGRAM (FSP)/CalWORKs

The purpose of this notice is to transmit information regarding Disaster Unemployment Assistance (DUA) provided to individuals who have suffered job loss or endured unemployment because of the freeze in January of this year in California. The filing deadline, originally April 13, is extended through May 25, 2007, by the U.S Department of Labor, acting in response to a request from the State Employment Development Department (EDD).

The DUA program provides benefits of up to \$450 a week for up to 26 weeks. It covers individuals who have the legal right to work in the United States but are not eligible for regular unemployment benefits, including, but not limited to, individuals who have exhausted their regular unemployment benefits or individuals who are self-employed.

DUA became available March 13, 2007, after President Bush replied to a request from Governor Schwarzenegger to declare certain California counties disaster areas. President Bush declared a major disaster in 16 counties in Central and Southern California: Fresno, Imperial, Kern, Kings, Los Angeles, Madera, Merced, Monterey, Riverside, San Bernardino, San Diego, San Luis Obispo, Santa Barbara, Stanislaus, Tulare, and Ventura counties.

Treatment of DUA Income in the FSP

The unemployment assistance income derived from the DUA program is treated as excluded income when determining food stamp eligibility and benefit levels as provided in MPP 63-507(a)(10).

Treatment of DUA Income in CalWORKs

For CalWORKs purposes, earnings to individuals participating in disaster relief unemployment under DUA shall not be considered income for purposes of determining CalWORKs eligibility and grant determination under MPP 44-111.6(i).

County Welfare Departments can determine whether a FSP/CalWORKs applicant/recipient is receiving DUA or regular unemployment insurance benefits (UIB) by accessing computer information maintained in EDD files (WIC 10606.1(b)). These files are available online to county eligibility workers. The online system will show whether the applicant/recipient is receiving DUA, shown as "DUA" or UIB, shown as "UI". The online system will also show the benefit amount.
