Transportation and Parking

Sacramento

Location: The meeting location is located in downtown Sacramento at 721 Capitol Mall, Room 242 A, B and C, Sacramento, CA. 95814

Transportation: For those of you travelling by airplane:

Rental cars:

Most of the major rental car companies are located at the airport. You have to take the rental car shuttle (there is one that serves all of the companies) to the rental car area, but it's only about five minutes from the terminal. There is a gas station located at the airport to fill up before turning the car back in.

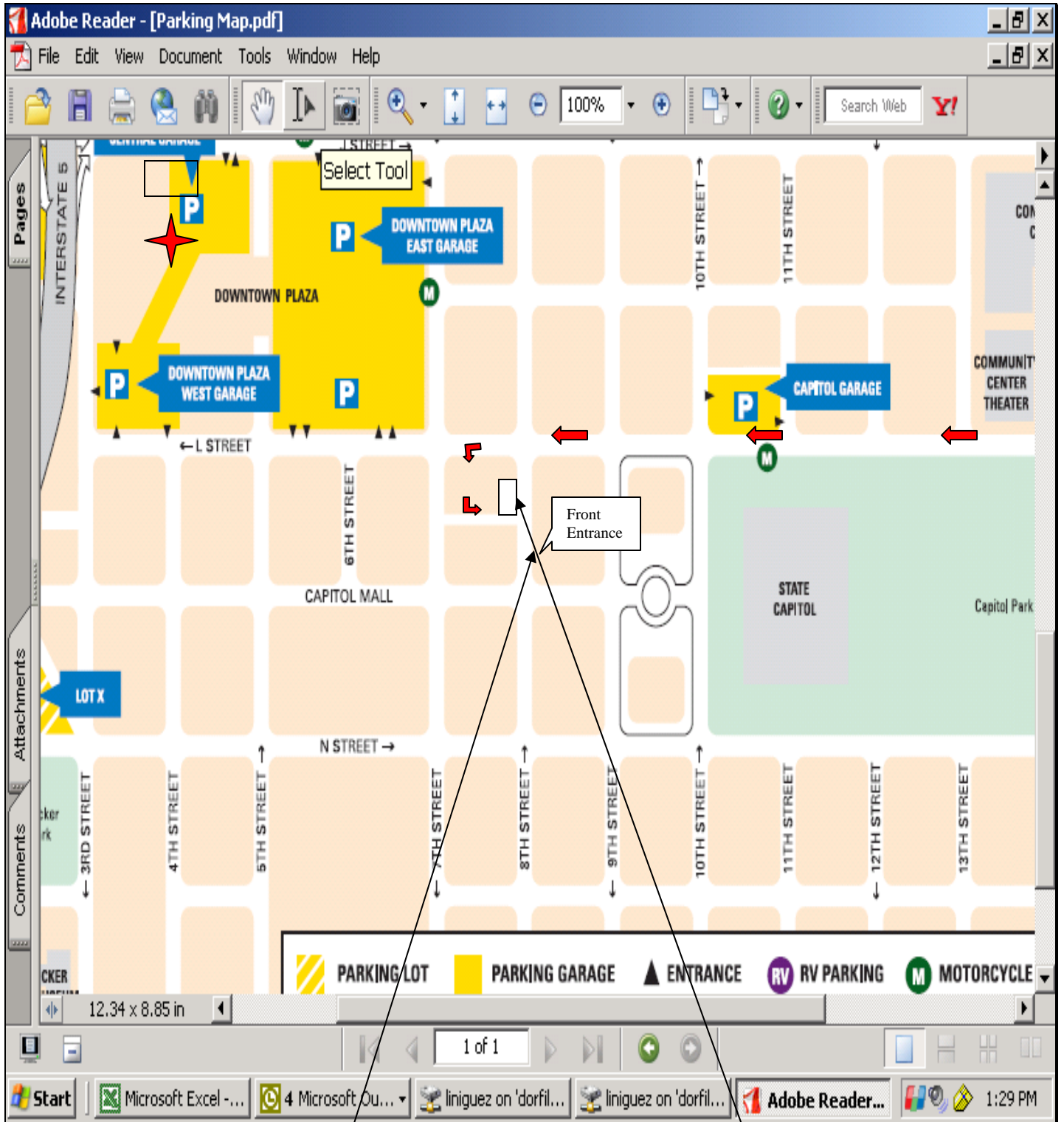
Shuttle:

The Super Shuttle is also available to downtown Sacramento. It is approximately \$26 round trip from the airport. Parking in downtown Sacramento is difficult and expensive, and the shuttle is a good alternative. It can take 30 to 35 minutes to get to the airport via the shuttle from downtown, depending on how many stops they have, so plan your pick-up times accordingly.

Taxis:

Taxis are also available at the airport. Approximate cost is \$30 to \$40 (one way).
