

The CDS Division has scheduled a Statewide Public Assistance Network (SPAN) workshop during the week of July 28, 1980 in Sacramento. The Systems/Program Requirements (New Logical) Report will be presented and discussed. An overview of the workshop material and the process will be given to the County Welfare Directors Association Board of Directors on July 10, 1980 from 1:30 p.m. to 3:30 p.m. at the Sacramento Inn to provide general information to enable the county to determine which program experts should attend the workshops. The workshop material will be mailed to all County Welfare Directors the week of July 14, 1980. The material is a detailed analysis of program requirements in each welfare program area: AFDC-FG, AFDC-BHI, AFDC-U, Food Stamps, Medi-Cal, Special Adult Programs, Social Services, Child Support, Fair Hearings, Quality Control, Fiscal and Multi-Program Reporting.

The workshop will provide for a review of the analysis material produced by State/County teams on what is required in each program and what some elements are that could/should be included in a successfully operating new system. In order to achieve a balanced number in attendance, the workshop has been scheduled for three days, July 29, July 30 and July 31, 1980 at the Sacramento Community Convention Center, 1100 - 14th Street, Sacramento.

The July 29 workshop is primarily for State/Agency Personnel. The July 30 workshop is primarily for county personnel. By primarily, we mean the workshops will be focused on State or County level concerns, respectively. You may attend the July 29 workshop if that is the only date you or assigned staff are available. The July 31 workshop is primarily for other agencies and also for state or county personnel who could not make the 29th or 30th workshop. We hope to gain your input informally through discussion during individual workshops and formally through written feedback from each county by August 15, 1980.


