SUBJECT: FOOD STAMP COUPON ALLOTMENT TABLE

Attached is an advance copy of the revised FNS Food Stamp Coupon Allotment Table for 1-20 households which will be effective for allotments issued in July 1980. Please accept our apologies for not providing you these tables sooner. However, SDSS just received the 1-8 household tables last week and we are providing the expanded tables to you as quickly as possible. Please note that there has not been a change to allotment levels (Thrifty Food Plan); these tables reflect only the increase in the maximum income limits and new monthly income increments due to new USDA rounding procedures.

In addition to the attached table, the following is a list of the new Maximum Income Standards which are also effective beginning July 1, 1980 for all eligibility determinations:



We realize that there is little lead time to implement this new table. We urge counties to implement the new tables if possible. However, if you are unable to implement the new tables on time, we recommend that counties use the January 1980 tables currently in MS 63-503.6; expand these tables to reflect the new maximum income standards for those new applications received beginning July 1, 1980, and implement the new tables on August 1. If this is not possible, use the attached table beginning August 1, 1980. Review all applications to be denied in July due to excess income and hold those that have income less than the new maximum income limits. If households are found to be eligible under the new income limits, retroactive benefits must be granted for July.

We have also attached instructions to be used when the benefit determination is made without the use of the tables. If you cannot implement the tables by July 1, please notify your Food Stamp Program Operations Analyst as soon as possible.

## BENEFIT DETERMINATION WITHOUT THE TABLES

To determine the coupon allotment households shall receive:

1. Multiply the household's net monthly income by 30 percent.
2. Take the above figure and round up to the next dollar if the cents are \$ .50-.99. If the cents are \$ .00-.49 round down.
3. Take the result obtained in step 2 from the Thrifty Food Plan for that size household.
