

#### SUBJECT: IMPLEMENTATION OF AFDC PROGRAM CHANGES ENACTED IN THE BUDGET AND COMPANION LEGISLATION

REFERENCE: ACL 92-78

The purpose of this letter is to help you prepare for upcoming changes in the AFDC Program. As you know, the recently enacted State Budget and the implementing legislation made several changes to the AFDC Program. We have already provided you with materials and instructions to implement the first of these changes - the 4.5 percent MAP reduction, which takes effect October 1, 1992 (see All-County Letter Number 92-78).

#### CHANGES ENACTED IN THE BUDGET

The second set of changes, which could take effect as early as December 1, 1992, will require federal waivers. We requested those waivers on September 17, 1992. These changes are the 1.3 percent MAP reduction, the elimination of the 100-Hour Work Rule for recipients, and a California Relocation Grant. In addition, we have requested waivers of the time limit on the \$30 & 1/3 earned income disregard as part of this waiver package. Since the 1992-93 Budget contains no funding for the cost of the \$30 & 1/3 disregard, however, actual implementation will be contingent on the availability of state funds (for example, as part of the 1993-94 budget) and on a finding that this provision will not cause the overall waiver package to result in a net federal cost.



Draft regulations to implement the Budget changes are attached. We are preparing forms, notices, and instructions for you to use in implementing these changes, and we anticipate providing these materials to you by early October. We will keep you informed on the status of the waivers and our implementation schedule.

#### WELFARE REFORM DEMONSTRATION PROJECT

As you know, we have already received federal waivers to implement the California Welfare Reform Demonstration Project (WRDP). This project will only be implemented if the voters approve the Government Accountability and Taxpayers Protection Act (GATPA) in the November 3, 1992 election. We would then provide implementation materials as soon as possible.

If enacted, the WRDP changes will take the place of the Budget changes discussed above and would take effect as soon as January 1, 1993.

#### REGIONAL GRANTS

As we indicated in an earlier All County Information Notice, the Budget required us to seek waivers to implement a regionalized schedule of grants in the SSI/SSP Program. If this waiver is approved, we will also seek approval to implement regionalized grants in the AFDC Program. Counties should take no steps to implement the AFDC regional grants at this time. We will keep you informed of our progress in negotiating the necessary waivers.

#### EDP SYSTEM REPROGRAMMING

We will provide specific instruction as soon as possible on the approval process that we plan to use for reprogramming of county systems to implement the changes enacted in the Budget. We recommend that your planning include all the Budget-approved items including the 30 and 1/3 provision.

#### TRAINING

We do not now plan to do training in October. In early November, we will reassess with county input the need for training. Page Three

41-440 FEDERAL AFDC-U UNEMPLOYED PARENT PROGRAM

The requirements of Section 41-440 apply to all principal earners who establish deprivation based on unemployment whether the individual is included or excluded from the assistance unit.

.1 Background

Pursuant to Assembly Bill 979, Chapter 587, Statutes of 1992 (Budget Act of 1992), Senate Bill No. 724, Chapter 97, Statutes of 1991, and Senate Bill No. 485, Chapter, xx, Statutes of 1992, the State Department of Social Services has requested and received federal approval for a California Demonstration Project entitled the Assistance Payments Demonstration Project. This Project enables California, in accordance with its federally mandated Terms and Conditions, to implement certain new AFDC provisions.

The Assistance Payments Demonstration Project components are provided in Division 89. They include work incentive provisions, MAP reductions and a relocation grant restriction.

#### HANDBOOK ENDS HERE

.2 Control Group

An exception to the application of the Division 89 Assistance Payments Demonstration Project provisions shall apply to those applicants and recipients who are designated by the Demonstration Project as members of the Project's control group. This designation shall be accomplished pursuant to the Project's mandated parameters outlined in the Federal Terms and Conditions as approved by the Secretary of the Department of Health and Human Services on September 30, 1992.

.42 Grant Adjustment

Upon determination of the lesser amount of either the California computed actual grant amount or the prior state MAP, the grant will be adjusted for partial month proration and overpayments, as applicable.

The county shall apply the RFG rule until any member of the AU has resided in California for twelve consecutive months.

.44 RFG Example

Mom and her three children arrive in California from Mississippi in April. Four months later (August), they apply for AFDC. The RFG rule will apply to the AU for eight months. (Twelve month residency requirement minus four months in California equals eight RFG months). Their RFG period will end March 31st of the following year.

After the AU received aid for one month, the children's father moves into the home (September). He is the unemployed principal earner and there is federal eligibility. The father has been in California for ten months and was living in Nevada prior to coming to California.

Since the father lived in California longer than anyone else in the AU, the AU will only have two remaining RFG months, which includes the first month of aid for the father. Therefore, the AU's new RFG period will end October 31st.

The county will use Nevada's MAP which is higher than Mississippi's MAP when applying the RFG rule.
