REVISED FOOD STAMP FORMS: DFA 377.4 "FOOD STAMP NOTICE OF CHANGE", AND DFA 377.7F "FOOD STAMP REPAYMENT NOTICE FOR AN INTENTIONAL PROGRAM VIOLATION (IPV) OR STATUS CHANGE FROM INADVERTENT HOUSEHOLD ERROR (IHE) TO AN IPV"

This letter transmits copies of the revised DFA 377.4 (6/96), "Food Stamp Notice of Change", and the DFA 377.7F (6/96), "Food Stamp Repayment Notice for an Intentional Program Violation (IPV) or Status Change from Inadvertent Household Error (IHE) to an IPV". These forms have been revised to be used when changing from an IHE overissuance collection to an IPV overissuance collection.

The DFA 377.4 is a multiple purpose "Food Stamp Notice of Change" form that can now be used also when the IHE becomes an IPV and is collected at a higher rate. A paragraph has been added to the Change in Benefits section to reflect this revision. The DFA 377.7F is a "Food Stamp Repayment Notice for an IPV" form that has been modified to also reflect a status change from IHE to IPV. This Repayment Notice is to be used also when a claim is changed from an IHE to an IPV and causes a change to the total amount of the claim, the period of time covered or recomputes the claim disallowing earned income deductions. A paragraph has been added to reflect this change.
