SUBJECT: IMPLEMENTATION OF THE READOPTION PROVISIONS FOR

INTERCOUNTRY ADOPTIONS - SENATE BILL (SB) 1393

(CHAPTER 809, STATUTES OF 2006)

REFERENCE: ALL COUNTY INFORMATION NOTICE (ACIN) NO. I-12-08

This ACL is the certificate described in Family Code section 8919(c).

Background

The SB 1393 amended Family Code section 8919 to include the requirements that must be met in order for a readoption order to be issued by a California Superior Court. The bill also established alternative requirements for readoption when the original adoption occurred in a country whose adoption standards have been certified by the California Department of Social Services (CDSS) as meeting or exceeding those of California.

Subsequent to the passage of SB 1393, the United States of America (U.S.) ratified the Hague Convention on the Protection of Children and Co-Operation in Respect of Intercountry Adoptions (Hague Convention), on April 1, 2008. The Hague Convention and implementing federal regulations establish uniform adoption standards between Convention countries¹. Accordingly, CDSS will certify that the adoption standards of Convention countries meet the adoption standards of the State of California if the adoption was finalized after April 1, 2008. ¹ Family Code section 8900.5(f) defines "Convention Country" as a country that is a party to the Convention and with which the Convention is in force for the U.S.

Alternative Method of Readoption

Family Code section 8919(c)³ establishes an alternative method for readoption. The alternative method is a streamlined readoption process that omits several requirements for readoption as described in ACIN I-12-08⁴.

Specifically, the alternative method for readoption requires the following documents to be filed with the court:

- 1. Filing of an Adopt 200–Adoption Request (Adopt-200)⁵ with the California Superior Court in the petitioner's county of residence;
- 2. Filing of a VS 44–Court Report of Adoption, the form required to generate a birth certificate from the state of California⁶;
- 3. At least one post-placement visit report by a California adoption agency licensed by CDSS to provide intercountry adoption services⁷;
- 4. A copy of this ACL certifying that the adoption standards of the Convention country meet the standards of this state;
- 5. The adoption decree, order, or certificate from the Convention country where the adoption was completed;
- 6. The child's birth certificate from the country of the child's birth;
- 7. The child's visa, issued by the Department of Homeland Security;
- 8. Certified translations of all documents listed above that are not in English.

The alternative method for readoption set forth in Family Code section 8919(c) allows the adoptive family to complete and file the Adopt 200, VS 44, the attachments listed above and any additional local court forms, or contract with a licensed intercountry adoption agency to complete the readoption paperwork.

Certified Countries

The CDSS is authorized to certify adoption standards in foreign countries pursuant to Family Code section 8919(c). The Haque Convention on Intercountry Adoptions and
