SUBJECT: WRAPAROUND RATES FOR AID TO FAMILIES WITH DEPENDENT CHILDREN – FOSTER CARE AND THE CALIFORNIA ALLIANCE OF CHILD AND FAMILY SERVICES v. CLIFF ALLENBY, et al. COURT ORDER

REFERENCE: ALL COUNTY LETTER NO. 10-15, ISSUED MARCH 15, 2010

The purpose of this letter is to clarify the impact of the California Alliance of Child and Family Services Court Order on Wraparound rates. The District Court ordered the California Department of Social Services (CDSS) to adjust group home rates paid under California's Rate Classification Level (RCL) system. Wraparound reimbursement rates are included in the RCL rates and, therefore, are included in the Court Order increase.

*Previous* Wraparound RCL rates, per Welfare and Institutions Code, 18254, were:

RCL	Non-Federal Child	Federally-Eligible Child*
10/11	\$5,291.00	\$2,317.00
13	\$6,294.00	\$2,757.00

**Current** Wraparound RCL rates, per Welfare and Institutions Code, 18254, are as follows:

RCL	Non-Federal Child	Federally-Eligible Child*
10/11	\$7,016.00	\$3,073.00
13	\$8,319.00	\$3,644.00

\*The federal rate is minus the federal share, which is 56.2 percent of the RCL rate.
