SUBJECT: CALIFORNIA WORK OPPORTUNITY AND RESPONSIBILITY TO KIDS

(CalWORKs): COST OF LIVING ADJUSTMENT (COLA) INCREASE TO THE MINIMUM BASIC STANDARD OF ADEQUATE CARE (MBSAC)

#### MBSAC INCREASE

The purpose of this letter is to inform counties of an increase to the CalWORKs MBSAC levels effective July 1, 2010. W&I Code Section 11453 provides that the CalWORKs MBSAC levels shall be adjusted annually to reflect any increases or decreases in the cost of living. This year's COLA increases the MBSAC and Income In-Kind levels by 1.57 percent. The new MBSAC levels are to be used in determining applicant financial eligibility for those families that apply for CalWORKs on or after July 1, 2010.

Per W&I Code Section 11453(c) (6), beginning in the 2010-11 fiscal year, no adjustment to the maximum aid payment levels shall be made unless otherwise specified by statute.

The new CalWORKs MBSAC Payment Standards Chart for Region 1 and 2 is enclosed to assist in implementing these changes. New Income In-Kind levels are included in this chart as these amounts also increased as a result of the MBSAC COLA.

### RETROACTIVE ELIGIBILITY FOR DENIED APPLICATIONS

The new MBSAC levels are to be used in determining applicant financial eligibility for those families that apply for CalWORKs on or after July 1, 2010. Since the effective date for the MBSAC COLA is July 1, 2010, counties are instructed to review only previously denied applications which were denied solely for failing the applicant financial eligibility income test for July 2010 due to the higher MBSAC level.

Counties must make any necessary retroactive and all prospective changes effective as soon as administratively possible to implement the increase in the MBSAC levels and retroactively approve those applications, if appropriate. Please refer to the attachment for the MBSAC and In Kind Income levels effective July 1, 2010.

# REFUGEE CASH ASSISTANCE (RCA) AND TRAFFICKING AND CRIME VICTIMS ASSISTANCE PROGRAM (TCVAP)

These implementation instructions for the MBSAC COLA and the Income In-Kind changes shall also apply to RCA and TCVAP applicants and recipients.
