- REFERENCE: Welfare and Institutions Code Sections 16121(a); All County Letters 11-42E, 08-01, AND 01-55

This letter is to provide information and instructions on the 2011-2012 Budget Act, Assembly Bill (AB) 106 (Chapter 32, Statutes of 2011). The provisions of this bill relate to the basic Adoption Assistance Program (AAP) rates and the recent changes in the basic Foster Family Home (FFH) rate methodology determined by the United States District Court, in the case of the <u>California State Foster Parent Association v. William</u> <u>Lightbourne, et al, (U.S. Dist. Ct. No. C 07-08056 WHA).</u> As a result of the court's decision, Welfare and Institutions Code Section 16121(a) was modified to reflect the new rate methodology and rate structure, and allows for each rate structure to receive a California Necessities Index (CNI) increase. The negotiated AAP rate continues to be based on the child's needs and the circumstances of the family and may include the Specialized Care Increment (SCI), if eligible. The Specialized Care rate is calculated by adding the SCI to the basic rate; therefore, recipients who receive this rate will also receive an increase due to the increase to the basic rate. AB 106 did not address the Dual Agency rates.

### I. <u>AAP Basic Rates</u>

A. Initial AAP agreements signed on or after October 1, 1992, through December 31, 2007 and the adoption finalized before May 27, 2011: Use the FFH rate structure in effect December 31, 2007 to determine the basic AAP rate. These children are eligible to receive the age-related increase and the CNI increase starting with the state fiscal year 2011-2012.

B. Initial AAP agreements signed on or after January 1, 2008 through December 31, 2009 and the adoption finalized before May 27, 2011: Use the FFH rate structure in effect January 1, 2008 to determine the basic AAP rate. These children are eligible to receive the age-related increase and the CNI increase starting with the state fiscal year 2011-2012. If the adoption finalized on or after May 27, 2011, section D of this ACL is applicable and these children continue to remain eligible to receive the age-related increase. C. Initial AAP agreements signed on or after January 1, 2010 through May 27, 2011 and the adoption finalized on or before May 27, 2011\*\*\*: Use the FFH rate structure in effect on January 1, 2008 to determine the basic AAP rate. These children are not eligible to receive the age-related increase; this may not exclude any increases based on the reassessment of the child's needs. These children are eligible for the CNI increase starting with the state fiscal year 2011-2012.

# D. Initial AAP agreements signed before or after May 27, 2011 and the adoption finalized on or after May 27, 2011:

Use the FFH rate structure in effect May 27, 2011 to determine the basic AAP rate for the month of June 2011. In addition, these children are eligible for the CNI increase starting with the state fiscal year 2011-2012. These children are not eligible to receive the age-related increase; this may not exclude any increases based on the reassessment of the child's needs. An amended AAP

agreement must be signed reflecting the State-Wide FFH rate increase effective May 27, 2011.

### E. Initial AAP agreements signed on or after July 1, 2011:

Use the FFH rate structure in effect July 1, 2011 to determine the basic AAP rate. These children are not eligible to receive the age-related increase; this may not exclude any increases based on the reassessment of the child's needs. These children are eligible for the CNI increase starting with the state fiscal year 2012-2013.

# II. County and CDSS Adoption District Office Responsibility

Counties and adoption district offices shall adjust monthly AAP basic rates to include an annual CNI increase should one occur, effective July 1st. The adjustment must be documented by sending AAP recipients a Notice of Action (NOA) reflecting the AAP basic rate change. A copy of the NOA must be placed in the AAP case file for documentation purposes. While CNI increases do not require an amended AAP agreement, all other changes to the AAP benefit continue to require an amended agreement.
