SUBJECT: MAINTENANCE AND RETENTION OF STATEWIDE FINGERPRINT

IMAGING SYSTEM (SFIS) CLIENT RECORDS IN COUNTY CASE FILES

This letter clarifies policy for the California Work Opportunity and Responsibility to Kids (CalWORKs) and Food Stamp programs regarding the retention and disclosure of SFIS data, including fingerprint and photo images. SFIS fingerprint and photo images shall not be printed out and put in the CalWORKs program and Food Stamp program case files. State law and regulations mandate that SFIS data can only be used in the detection and prevention of receipt of duplicate aid and the prosecution of that type of welfare fraud. Due to the confidential nature of this data, any SFIS record kept outside the SFIS system itself shall be retained only in a county's Special Investigative Unit (SIU) or Fraud file. This practice will ensure that a file is accessed only by SIU or Fraud staff in the context of fraud prevention and prosecution and not by other county staff in the course of day-to-day business.

As stated above, SFIS data can only be used for the detection and prevention of receipt of duplicate aid and the prosecution of that type of welfare fraud. Therefore, copies of fingerprint and/or photo images shall not be made available to recipients for their personal use.

The policies outlined in this letter supercede and clarify any prior written or oral information provided on this subject.
