## SUBJECT: IMPLEMENTATION OF THE FINAL RULE ON ANTICIPATING INCOME AND REPORTING CHANGES IN THE FOOD STAMP PROGRAM – EFFECTIVE NOVEMBER 1, 2003

## REFERENCE: United States Department of Agriculture (USDA), Food and Nutrition Service (FNS) Administrative Notice (AN) 03-23 dated May 1, 2003.

The purpose of this letter is to transmit implementing instructions and proposed state regulations to County Welfare Departments (CWDs), for changes to food stamp regulations that are a result of final federal rules on Anticipating Income and Reporting Changes. These changes are being implemented through emergency regulations, which will become effective November 1, 2003. The changes shall be applied to all new applicants, to the current change reporting caseload, and to the monthly reporting and retrospective budgeting caseload as of November 1, 2003. Counties will be held harmless from Quality Control (QC) errors for a period of 120 days from the effective date.

The attached proposed regulations make changes in the following areas:

## CHANGE REPORTING HOUSEHOLDS

<u>Unearned Income Reporting</u> (63-504.421(c)(1)) and (63-505.512 new)

• The reporting threshold for unearned income will be increased from \$25 to \$50 for change reporting households. These households are required to report an unearned income change of more than \$50 except for changes in Public Assistance (PA) or General Assistance (GA) and food stamp cases jointly processed by the same eligibility worker. If GA and food stamp cases are not jointly processed by the same eligibility worker, the household is responsible for reporting changes in GA of more than \$50.

## Earned Income Reporting (63-505.511)

• Change reporting households with earned income, in addition to reporting a change in the source of income (starting, stopping, or changing jobs when the change is accompanied by a change in income), will now be required to report when a change of more than \$100 occurs since the last time the household's allotment was calculated. These households can be certified for no more than six months.

## MONTHLY REPORTING HOUSEHOLDS (63-503.232(c)(2))

### Income Only in the Month Received

In monthly reporting and retrospective budgeting (MRRB) households, the following technical change needs to be made in procedures for handling certain recurring income. The CWDs shall budget recurring income received once or *twice a month* in the month that it is intended to cover. The CWDs shall not vary the budgeting of such income merely because it is received during another month as the result of changes in mailing cycles or pay dates, *or because weekends or holidays* result in an additional or missed payment.

## FORMS ASSOCIATED WITH THE ACL

The following forms will be revised to coincide with the regulation changes: 1) The DFA 377.5 (Food Stamp Household Change Report) and 2) the FS 23 (How to Report).

## DFA 377.5 Food Stamp Household Change Report (Recommended Form)

This is a recommended form that Nonassistance Food Stamp households can use to report mandatory or voluntary changes in writing. This document will have changes, in section 1 titled **INCOME CHANGES**, to coincide with the new reporting thresholds for unearned and earned income. The remainder of the form (sections 2 through 12) will remain unchanged.

## FS 23 How To Report (Required Form)

This is a required form that is provided to the Food Stamp household at Certification. This document will have two bullets added, on page 2, to advise/explain the new reporting thresholds in change reporting. The remainder of the form will remain unchanged.

## **AVAILABILITY OF NEW FORMS FOR ORDERING**

Counties shall use the new forms as of November 1, 2003.

#### (c) Income Only in the Month Received (Continued)

(2) The CWD shall budget stable earned and unearned income which is received on a regular basis as a single monthly or semi-monthly payment for the month such income is intended to cover. Households receiving such income shall not have their monthly income varied merely because mailing or payment cycles, or because weekends or holidays may cause two payments to be received in one month and none in the next month. - .5 Reporting Changes for Households Excluded from Monthly Reporting Requirements
  - .51 Household Responsibility to Report

The CWD shall not impose any food stamp reporting requirements on nonmonthly reporting households except as provided in Sections 63-505.511 through .5167. Certified households shall report the following changes in circumstances:

- .511 Changes in the sources of income, and in the amount of gross monthly income of more than \$25. including starting or stopping a job or changing jobs, if the change is accompanied by a change in income. In addition, provided that the household is certified for no more than six months, changes in the amount of earned income of more than \$100 per month since the last time the allotment was calculated.
- .512 Changes in the amount of unearned income of more than \$50.
  - (a) Changes in the public assistance or the general assistance grant are not required to be reported. Since the CWD has prior knowledge of all changes in these grants, action shall be taken on the CWD information. <u>However, if general assistance and food stamp cases are not jointly</u> <u>processed, the household is responsible for reporting changes of more than \$50.</u>
