The purpose of this erratum is to update the two FFY 2004 FSET allocations sent to counties on October 3, 2003 in ACL 03-51 and e-mailed October 23, 2003. We apologize for any inconvenience this may have caused. Counties must use the allocations in this erratum when developing their 2004 FSET county plans. The attached Enclosure I supersedes Enclosure I in ACL 03-51 and the allocations e-mailed on October 23, 2003.

It was necessary to update the original allocations transmitted in ACL 03-51 dated October 3, 2003 due to receipt of updated non-assistance food stamp caseload information. Subsequent to that update e-mailed on October 23, 2003, two counties withdrew from the FSET program for 2004. This action required yet another redistribution of federal FSET funds.
