SUBJECT: CORRECTION TO ALL COUNTY LETTER 05-40 (FORMER CalWORKs RECIPIENTS CURRENTLY ENROLLED IN STAGE ONE CHILD CARE AND HAVE EXHAUSTED THEIR 24 MONTHS OF ELIGIBILITY [CW 2197 (12/05)])

REFERENCE: ACL 99-63, DATED SEPTEMBER 7, 1999, PUBLICATION OF CALIFORNIA WORK OPPORTUNITY AND RESPONSIBILITY TO KIDS (CalWORKs) CHILD CARE REGULATIONS

ACL 05-11, DATED JUNE 8, 2005, FORMER CalWORKs RECIPIENTS WHOSE CHILDREN ARE TIMING OUT OF STAGE ONE CHILD CARE [CW 2197 (7/05)]

The purpose of this Erratum is to provide revisions to All County Letter (ACL) 05-40, dated December 16, 2005. On page two of the report form's instructions, Definitions, "No Longer on Aid", the NOTE incorrectly states: "Data for this category **does not** include families who have just reached their CalWORKs 60-month time limit." (Emphasis added.)

On the CW 2197 Report, the "No Longer On Aid" category **does** contain those families who have just reached their CalWORKs 60-month time limit. Safety Net cases (aid codes 3A and 3C) should be included on the CW 2197.

This is not the case for the CW 115 and CW 115A Child Care Monthly Reports, where the two data sets, (1) No Longer On Aid and (2) Safety Net are reported separately.

Consequently, the number of recipients entered in Part B of the CW 2197 will be compared to the number of recipients reported on the CW 115/115A, Part A, **cells 3, 4, 8 and 9** and not just CW 115/115A cells 3 and 8 as erroneously stated on the CW 2197 report form and in the Comments section of the instructions.

At a later date, the automated version of the CW 2197 form will be revised accordingly. We apologize for any inconvenience this may have caused. To facilitate this revision, a later submission date is established. Please submit this data by February 20, 2006.
