SUBJECT: FOOD STAMP PROGRAM - FOOD STAMP POLICY TRANSMITTALS 1972, 1973 and 1974

REFERENCE:

Attached are six separate listings of All-County Letters identifying policy issues which are current and those which are outdated or have been incorporated into the California Food Stamp Manual. There is an "active" and "inactive" listing for each of the years 1972, 1973, and 1974.

The "active" listings contain food stamp policy that is currently in effect. An All-County Letter may be listed as "active" even if only one item from the letter is currently valid. Such items as identified on the "comments" section shall be the only portions of the letter considered in effect.

Manualization of all "active" policy letters is planned (except for items of a special nature, such as temporary instructions, etc.).

The "inactive" listings contain letters in which all policy contained therein is entirely outdated (or incorporated).

Inactive letters should be maintained for Quality Control, Fair Hearings, and audit purposes. The attached listings are useful in maintaining such a file.

Counties should maintain at least one centralized file of both active and inactive All-County Letters.

Counties are encouraged to attempt completion of this central file by review and collection of letters held by all county administrative staff since a printed state stock of these letters is nonexistent. If no copies of some particular policy letter(s) can be found, please request to Mike Martin of the Food Stamp Policy Coordination Bureau at (916) 445-6907.


