TO: ALL COUNTY WELFARE DIRECTORS

SUBJECT: APPROPRIATE EMPLOYMENT OR TRAINING OPPORTUNITIES FOR REFUGEES
(MPP Section 69-205.5)
REFERENCE: ACL NO. 81-90

This letter is to provide clarification of what is to be considered as appropriate employment or training opportunities for refugees receiving cash assistance under Manual of Policies and Procedures (MPP) Division 69.

The State Department of Social Services has contracted with public and private nonprofit agencies in each of fourteen regions throughout the state to provide employment-related services (English-as-a-Second Language, Vocational English-as-a-Second Language, Vocational Training and Employment Services) to refugees. One or more service providers have been designated in each region to act as a Central Intake Unit (CIU) for the region. The CIUs are responsible for processing the applications (accepting applications, determining initial eligibility, making referrals to service providers within the region, etc.) for these employment-related services (see attached list of providers).

Training offered by these service providers is to be considered appropriate for purposes of MPP Sections 69-205.5 and 69-205.8. The Office of Refugee Services is in the process of revising MPP Section 69-205.5 to mandate CWD referrals of refugees to these service providers. This effort is being coordinated through CWDA. In the interim, CWDs are encouraged to: (1) refer refugees applying for or receiving Refugee Cash Assistance (RCA) to the service providers for employment-related services; and (2) contact the CIUs within their region to develop a temporary referral system.

Please note that the information contained in this letter does not apply to AFDC-eligible refugees who are governed by AFDC regulations. CWDA may refer AFDC-eligible refugees on a voluntary and informal basis to service providers; however, should the AFDC-eligible refugee not cooperate with the service provider or accept the referral, no sanctions may be applied.
