SUBJECT: STATISTICS ON AFDC FG/U CHILDREN AND CHILDREN IN FOSTER CARE  
NEEDED TO IMPLEMENT THE EDUCATION CONSOLIDATION IMPROVEMENT  
ACT OF 1981, OCTOBER 1984

## REFERENCE:

This letter transmits reporting instructions for the collection of 1984 data for allocations under the Education Consolidation Improvement Act of 1981 (ECIA). Attached statistical Forms CA 802 and 803 will be used for compiling data required by Chapter I of the ECIA.

The study month for the ECIA report on AFDC children and foster care children will be October 1984. Only federally eligible AFDC FG/U children and all non-institutionalized foster care children aged 5 through 17 (born in the period November 1, 1966 through October 31, 1979) in families receiving cash grants during October 1984 may be reported. All grants made for the month of October 1984 are to be reported even though the actual check was issued in the prior month. Each county must use the integrated payroll. No sampling or estimating may be used in preparing these reports.

The form and instructions for reporting on AFDC FG/U children are attached and reflect those changes appropriate to process the October 1984 ECIA reports. A list of federally eligible children aged 5 through 17 in AFDC families receiving grants of \$850.01 or more is required, as requested in the instructions outlined in Report Item 3 on the reverse side of Form CA 802. There is no need to submit a list of federally eligible children in families receiving grants less than this amount.

The reporting of children in foster care is to be done separately for in-county and out-of-county children. In-county children are those funded by your county living in your county. Out-of-county children are those that are funded by your county but living in another state or county. Again, reportable children are those aged 5 through 17. No supportive list is required for foster children. Do not report children aided by another state or county in your county totals.

The due date for these reports is November 15, 1984.


Grants under Chapter I of the Education Consolidation Improvement Act of 1981 (ECIA) are to provide services for educationally disadvantaged children. Distribution of these funds is made by the California State Department of Education to the county school districts.

To assist the State Department of Education (SDOE) in the allocation of ECIA, Chapter I funds, the county welfare department is to release on a computer or manual listing the address of each AFDC FG/U child, aged 5 through 17, in AFDC families who are receiving a grant of \$850.01 or more and \$850.00 or less. The determining factors applied by the SDOE in appropriating funds to the individual schools are based on residence given and the fact they are children of AFDC FG/U families receiving grants below the given grant level for the year of reporting. It is not a requirement, for purposes of preparing the ECIA annual report to the school district, that the name of the school attended by the child be given.

Division 19, Confidentiality of Information Manual of Policies and Procedures, Section 19-004.52, states: "Information concerning the number of AFDC families living within a particular school district requested to support entitlement to funds under the Education Consolidation Improvement Act of 1981 (ECIA) may be released to authorized representatives of the school district. A signed agreement with the school district stating that the confidential information obtained will only be used for purposes of fund claiming under the ECIA and that the district understands that there is a criminal penalty for release or use by the school district for any other purpose shall be obtained. This prohibition includes the use of the confidential records to identify applicants or recipients to school teachers and administrators." Welfare offices are to disclose as little information as possible to meet the surveyor's needs. Addresses may not be retained after the survey is completed, and no one but the surveyors, themselves, may have access to the information.

Since the Statistical Services Branch is set up with microfiche equipment, counties may elect to transmit ECIA report data via microfiche.

**INSTRUCTIONS FOR FORM CA 802**

**REPORT ITEM 1. ALL AFDC FG/U FAMILIES WITH CHILDREN AGED 5-17 AND CHILDREN AGED 5-17:**

Enter in Item 1b, Column 1, by amount of AFDC FG/U grant classification (Item 1a), the total number of families with at least one federally eligible child, aged 5-17. Exclude from the count of families all cases with no children aged 5-17, nonfederally eligible children aged 5-17, and all zero grant cases. Report only those cases receiving a money payment for the month of October 1984 even if the check was issued in the prior month.

Enter in Item 1b, Column 2, the total number of federally eligible children aged 5-17 in those families. Exclude all children less than 5 or more than 17 years of age (even if they are members of an included family).

**REPORT ITEM 2. ALL AFDC FG/U FAMILIES REGARDLESS OF FEDERAL ELIGIBILITY, AGES OF CHILDREN OR AMOUNTS OF GRANT:**

Enter in Item 2a (provided from the October 1984 integrated payroll) the total number of AFDC FG/U families regardless of federal eligibility, ages of children or amounts of grant.

**REPORT ITEM 3. SUPPORTING LIST ATTACHED:**

For the families and children reported receiving a cash grant of \$850.01 or more, prepare a supporting list with the following information listed in case number sequence under the following headings:

The October 1984 AFDC FG/U grant is defined as the cash payment shown on the October integrated payroll.

Report separately the In-County total number of children (Item 1.a.) and the Out-of-County total number of children (Item 1.b.) aged 5 through 17 years (born November 1, 1966, through October 31, 1979) in noninstitutional foster care supported by public funds. Out-of-County foster children are those children aided by your county, but living in another state or county. Do not report children aided by another state or county. Include all children living in noninstitutional foster care under all public-funded programs, i.e., public agency foster homes; foster homes where care is purchased by public agencies; Title IV, Part A (the AFDC Foster Care Program [AFDC-FC in California]); Title IV, Part B (the CWS Program [only Specialized Child Protective Services in California]); and placements ordered by courts if care is paid by public funds. Do not include children residing in institutions. (For the purpose of this report, a children's institution is a group facility for children under 18 years of age, operated by a person, association, or corporation which accepts for 24-hour care more than 15 children under 18 years of age or a smaller number if the facility is institutional in character, i.e., has a defined staffing structure.) They are not funded under Public Law 95-480. Enter the total number of reportable children in Items 1, 1.a., and 1.b., as appropriate, below.

This report should be as of October 31, 1984. If another date in October is more convenient for compiling the data, it may be used and specified below; however, the child may not have been reported in the AFDC FG/U totals on Form CA 802.

This report is due in the Statistical Services Branch by **November 15, 1984**.
