  - (e) (1) "Eligible Recipient" means any blind or disabled individual who is a recipient of SSI<sub>2</sub>+SSP, <u>CAPI</u>, SSDI, or IHSS, or any combination, and who uses the services of an assistance dog. (Continued)
  - (i) "In Home Supportive Services" (IHSS) "IHSS" means the that Program (as enacted by program provided for under Division 9, Chapter 3, Article 7 of the Welfare and Institutions Code (commencing with Section 12300 and further defined in MPP Section 30-700.1).
    - (2) "Income" means income as defined in the Code of Federal Regulations, Title 20, Part 416, Subpart K. (Continued)
  - (r) (1) "Resources" means resources as defined in the Code of Federal Regulations, Title 20, Part 416, Subpart L.
  - (s) (1) "CDSS" means the California Department of Social Services. (Continued)
    - (5) "SSDI" "Social Security Disability Insurance" (SSDI) means that program the federal Social Security Disability Insurance (SSDI) Program provided for underpursuant to Title II of the federal Social Security Act (42 U.S.C. Section 401, et seq.).
    - (6) "SSI" "Supplemental Security Income" (SSI) means that program the federal Supplemental Security Income benefits provided for under pursuant to Subchapter 16 (commencing with Section 1381) of Chapter 7 of Title XVI of the federal Social Security Act (42 U.S.C. of the United State Code Section 1381, et seq.).
    - (7) "SSP" means "State Supplementary Program" (SSP) means that program provided for under Division 9, Part 3, Chapter 3 of the Welfare and Institutions Code Chapter 3 (commencing with Section 12000). (Continued)

## .2 Eligibility (Continued)

- .24 Be receiving <u>aid or services from one or more of the following programs: SSI, SSP, CAPI, SSDI, or IHSS.</u> Supplemental Security Income, State Supplementary Payment, In-Home Supportive Services, Social Security Disability Insurance or any combination of these four programs.
  - .241 Recipients of SSDI must have income and resources equal to or less than the federal poverty level, as defined in MPP Sections 46-430.1(i)(2) and (r)(1). (Continued)

## .3 Application (Continued)

- .31 For recipients of SSI, SSP, <u>CAPI</u>, or IHSS, application shall be made on Form ADSA 1 (Rev. 9/98) (Rev. 6/01) to the California Department of Social Services, Assistance Dog Special Allowance Program. The application shall be signed under penalty of perjury.
- .32 For recipients of SSDI, application shall be made on Form ADSA 1B (Rev. 5/2000)(Rev. 6/01) to the California Department of Social Services, Assistance Dog Special Allowance Program. The application shall be signed under penalty of perjury. (Continued)
- .34 Applicants shall provide any and all information and documentation requested by the CDSS in order to verify compliance with Welfare and Institutions Code Sections 12553 or 12554. (Continued)

- .41 For recipients of SSI/SSP or IHSS the monthly allowance shall be \$50.
- .42 For recipients of SSDI the monthly allowance shall be \$35. (Reserved)
- .5 Redeterminations (Continued)
  - .52 Each recipient shall complete and return the ADSA Renewal Application Form ADSA 1A (Rev. 10/98) (Rev. 4/01) to CDSS by the due date shown on the form. (Continued)
    - .531 Ceases to be a recipient of benefits under SSI<sub>x</sub>/SSP, <u>CAPI</u>, SSDI<sub>x</sub> or IHSS. (Continued)
