PURPOSE

The purpose of this ACL is to provide the sharing ratios for the following foster care placements: Foster Family Agencies (FFA), Intensive Services Foster Care (ISFC), Short-Term Residential Therapeutic Programs (STRTP), Group Homes (GH), Community Treatment Facilities (CTF) and Transitional Housing Placement Plus Foster Care (THP+FC). The sharing ratios are used by counties to identify the non-federal portion of their payments when they are claiming expenditures.

FFA SHARING RATIOS

ISFC SHARING RATIOS

The LOC 4 sharing ratio was applied to the ISFC program, see Table B above. This will be an interim sharing ratio that will be used until the Department receives the cost data needed to establish a final sharing ratio.

GROUP HOME, STRTP AND CTF SHARING RATIOS

Effective January 1, 2019 (FY 2018-19), the sharing ratios in Table C will be applied to the GH (RCL) Rate Classification Level, STRTP and CTF programs.
