REFUGEE COORDINATOR LETTER (RCL) NO. 00-17

To: County Refugee Coordinators

The federal Office of Refugee Resettlement recently notified the Refugee Programs Branch (RPB) that California's application for continuation funding, in the amount of \$1.7 million, under the Discretionary Grant for Services to Elderly Refugees has been approved. The enclosed spreadsheet provides county allocations for projects funded under this grant. The allocation amounts, which remain the same as those in Federal Fiscal Year (FFY) 1999/2000, were determined according to the number of refugees aged 60 and over in each eligible county as a percentage of the total number of older refugees in all eligible counties. Data was obtained from the ORR data system and includes refugee arrivals into California during the period from 1983 to 1999. All refugee-impacted counties from which project proposals were received in FFY 1999/2000, in addition to two organizations providing services in counties not designated as refugee-impacted, were considered eligible.

Counties are again required to include, as an appendix to their County Refugee Services Plans, a brief (one- to two-page) description of the services to be provided with Elder Refugee Discretionary continuation funds. The project description must include measurable goals and outcomes (e.g., type of service(s) to be provided, number of elderly refugees to whom services will be provided, etc.). Counties should bear in mind that extensive coordination of activities among refugee service providers, mainstream providers of services to the elderly, and local Area Agencies on Aging (AAAs) is a condition of receipt of this grant. In addition, counties are reminded of the five areas identified as priorities for service under this grant. These include: 1) the provision of culturally appropriate meals, both at senior centers and for the homebound elderly; 2) translated information on mainstream programs and services for the elderly; 3) the provision of interpretation services necessary for accessing needed services; 4) the provision of transportation, and accompaniment, when appropriate, to senior centers, medical appointments and to meet social service needs; and 5) group seminars on available services.

In accordance with the enclosed Standard Terms and Conditions for this grant, Program Progress Reports are required on a semi-annual (every six months) basis. Reports should be submitted to the RPB according to the following schedule.

It is imperative that all reports are complete and submitted in a timely manner as incomplete reports or untimely submittal could jeopardize future funding.

Upon review of the progress reports covering the first semi-annual reporting period, we have determined that more specific information on local coordination efforts is needed. Therefore, the reporting format for this grant is being modified to better collect this and other information. The revised format and reporting instructions will be transmitted in an upcoming RCL.

If this is a multi-year project and it is not the final budget period, the grantee is advised that future awards for continuation of this project will be dependent upon the availability of Federal funds, satisfactory progress by the grantee, and ACF's determination that continued funding is in the best interest of the Federal government.

Grantees shall liquidate all obligations incurred under the award not later than 90 days after the end of the project period. The only exceptions to this rule are the basic Head Start grants with an indefinite project period. For these grants, liquidation of obligations should occur not later than 90 days after each budget period. In either case, an unobligated balance from a prior budget period does not authorize a grantee to obligate funds in excess of the total federally approved budget reflected on the FAA for the current budget period.

The DHHS Inspector General maintains a toll free number, **800-HHS-TIPS** (800-447-8477), for receiving information concerning fraud, waste or abuse under grants and cooperative agreements. The grantee will take all necessary affirmative steps to ensure that small, minority and woman-owned business firms are utilized when possible as sources of supplies, services, equipment and construction. To the extent practicable, all equipment and products purchased with funds made available through this award should be American-made.

Failure to submit reports (i.e., financial, progress, or other required reports) on time may be the basis for withholding financial assistance payments, suspension, termination or denial of refunding. A history of such unsatisfactory performance may result in designation of "high risk" status for the recipient organization and may jeopardize potential future funding from DHHS.

Under Section 508 of Public Law 103-333, the following condition is applicable to all Federal awards:

"When issuing statements, press releases, requests for proposals, bid solicitations and other documents describing projects or programs funded in whole or in part with Federal money, all grantees receiving Federal funds, including but not limited to State and local governments and recipients of Federal research grants shall clearly state (1) the percentage of the total costs of the program or project which will be financed with Federal money, (2) the dollar amount of Federal funds for the project or program, and (3) the percentage and dollar amount of total costs of the project or program that will be refinanced by nongovernmental sources."

For purposes of this award each item of equipment with an acquisition cost of less than \$5,000 is included under supplies, is allowable as a direct cost of this project, and does not require prior approval of the Grants Officer. Conversely, an item of equipment with an acquisition cost of \$5,000 or more is NOT considered an allowable project cost without prior written approval of the Grants Officer.
14. The Grantee shall comply with all provisions of OMB Circular A-133 (revised June 24, 1997), "*Audits of States, Local Governments and Non-Profit Organizations*."
