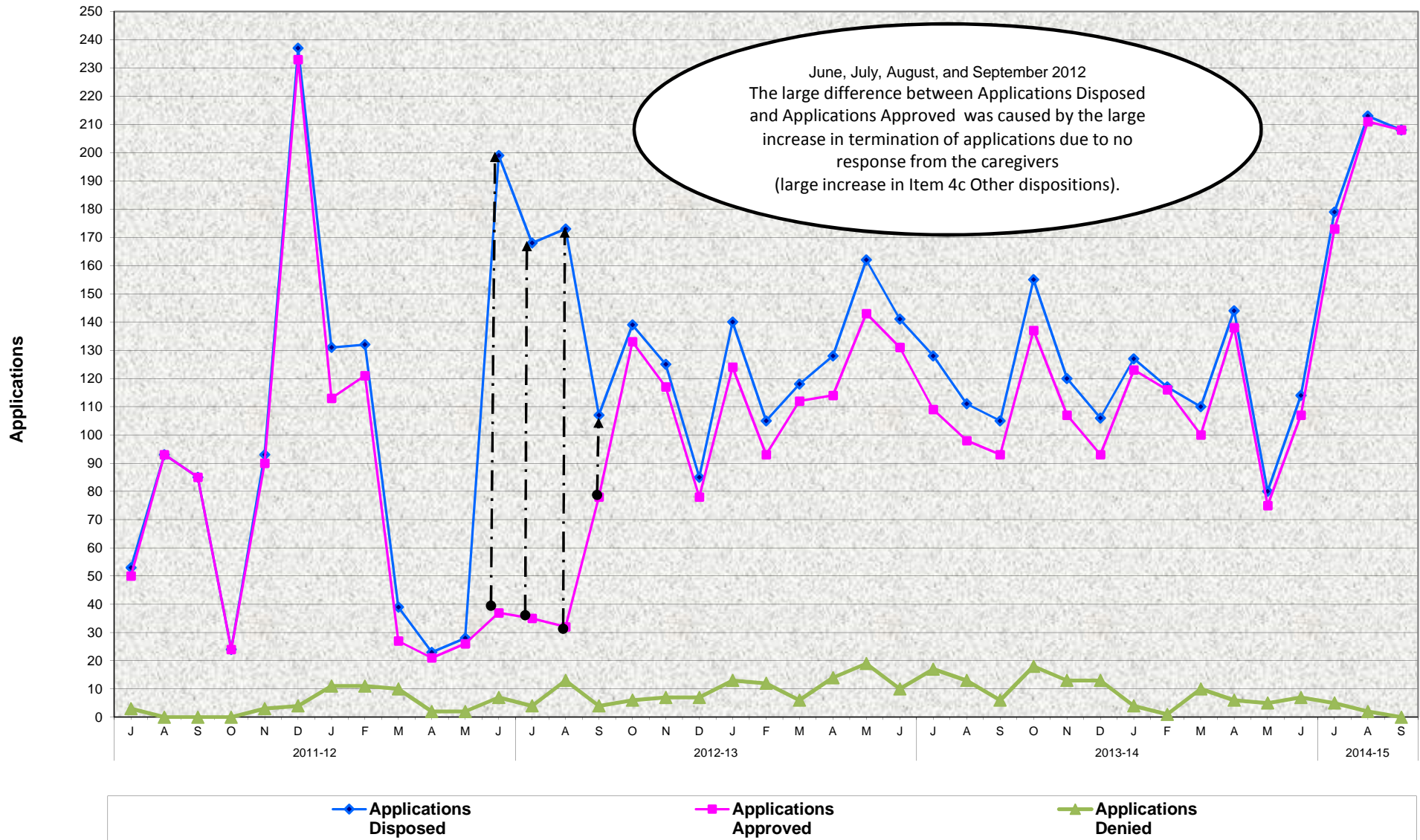

● **Applications Disposed:**

Kin-GAP Federal applications disposed decreased 2.3% between August 2014 and September 2014.
Kin-GAP Federal applications disposed increased 98.1% between September 2013 and September 2014.

● **Applications Approved:**

Kin-GAP Federal applications approved decreased 1.4% between August 2014 and September 2014.
Kin-GAP Federal applications approved increased 123.7% between September 2013 and September 2014.

● **Applications Denied:**

Kin-GAP Federal applications denied decreased 100.0% between August 2014 and September 2014.
