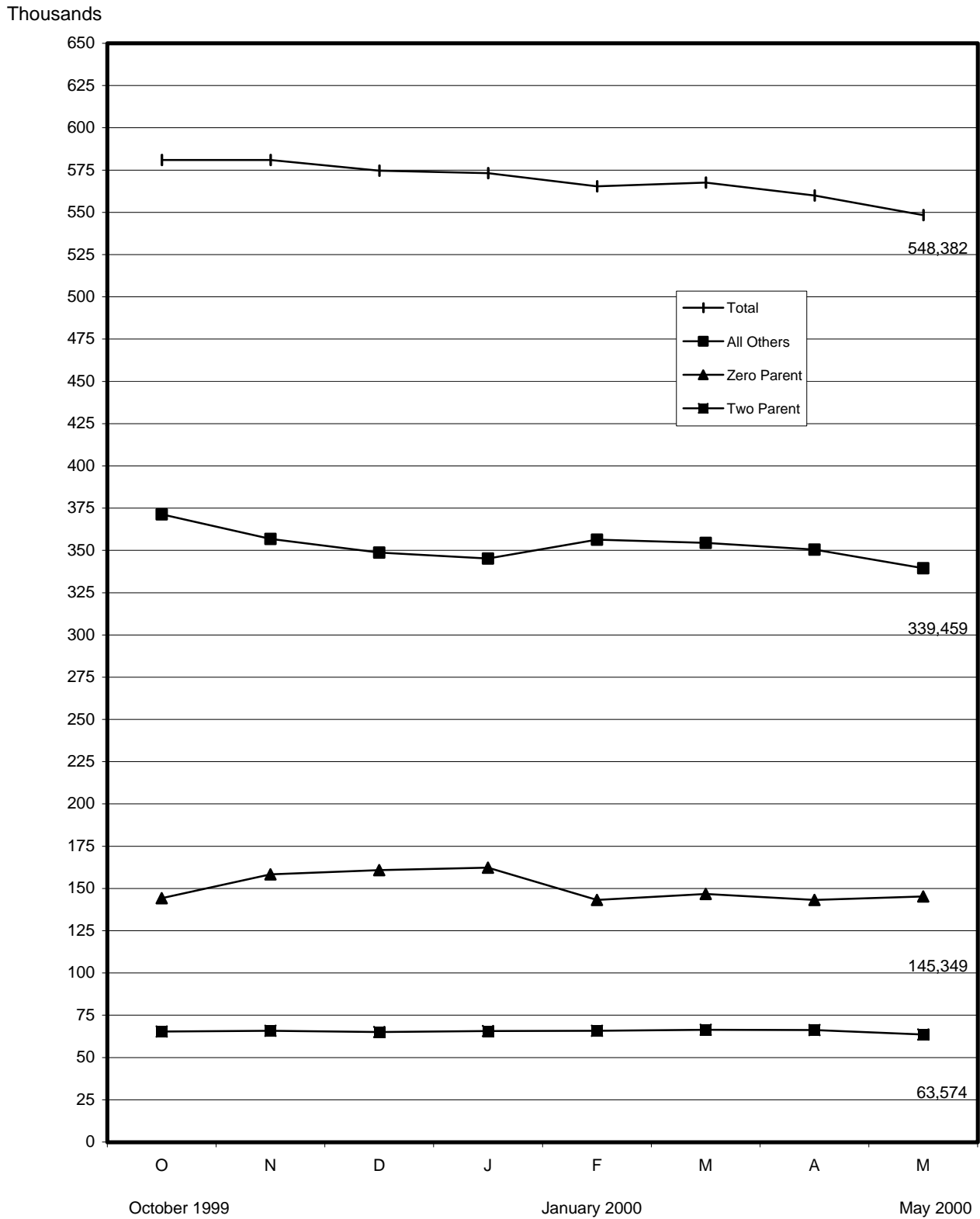

CalWORKs Caseload by Category October 1999 - May 2000

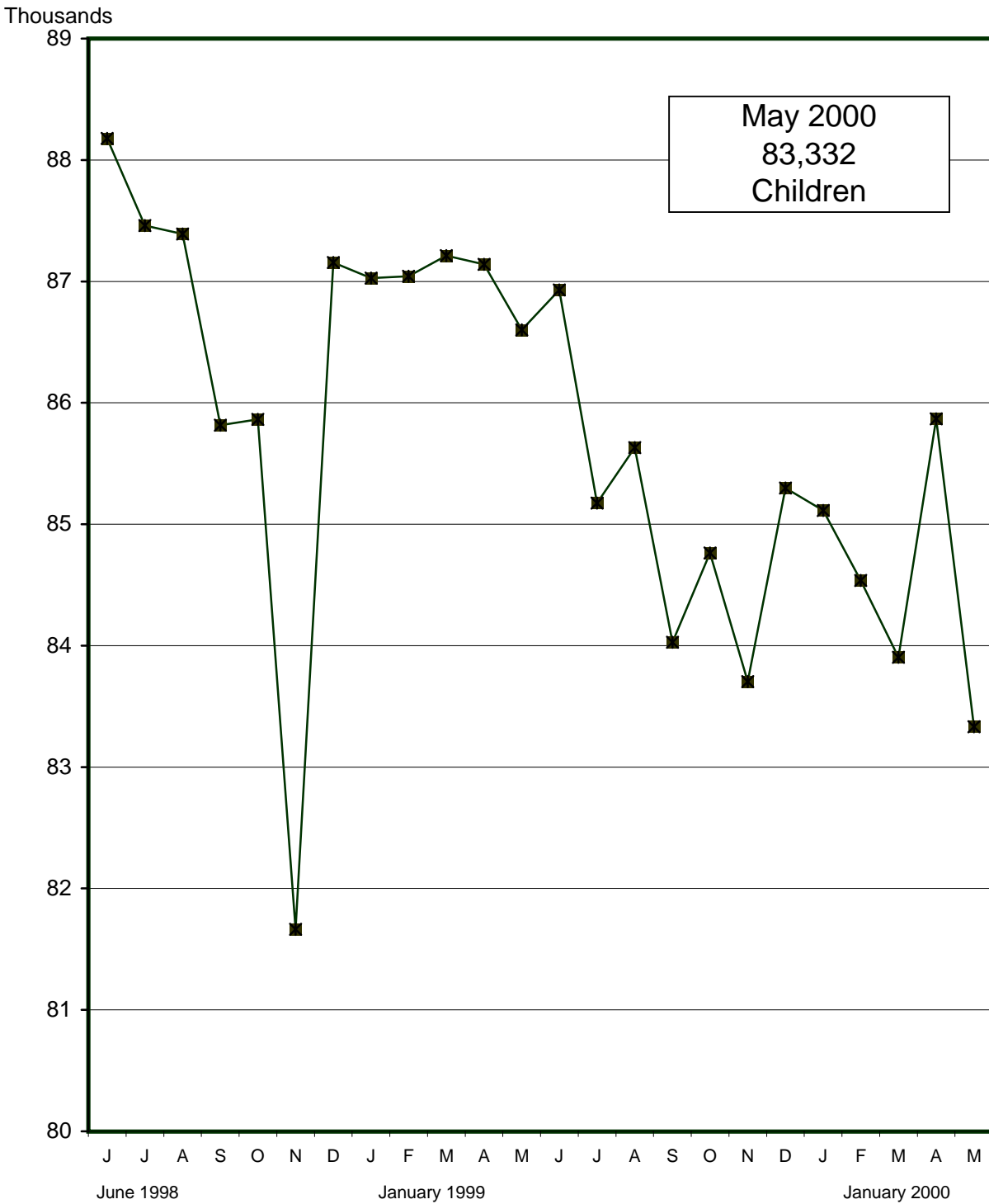

June 1998 - May 2000



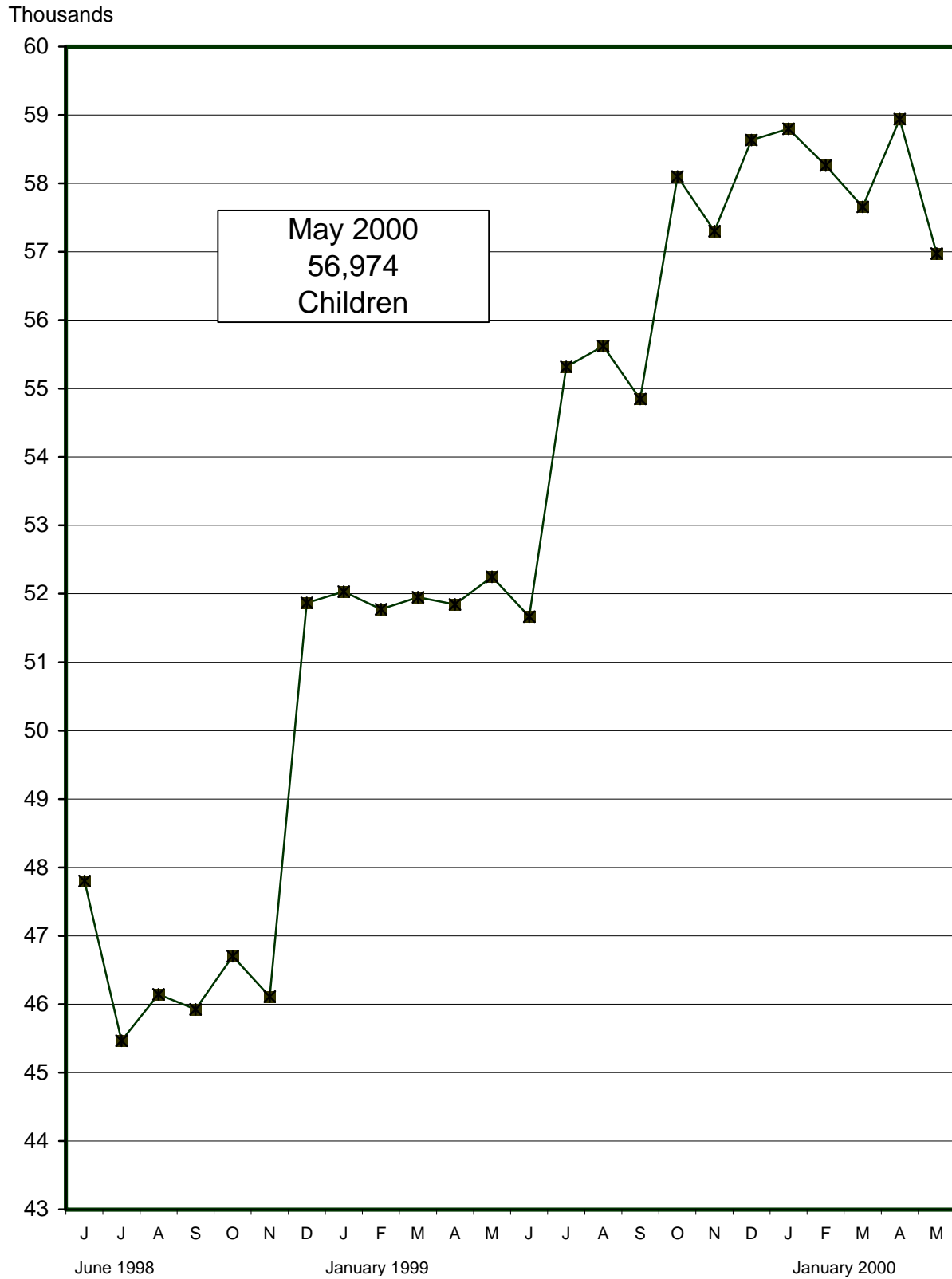

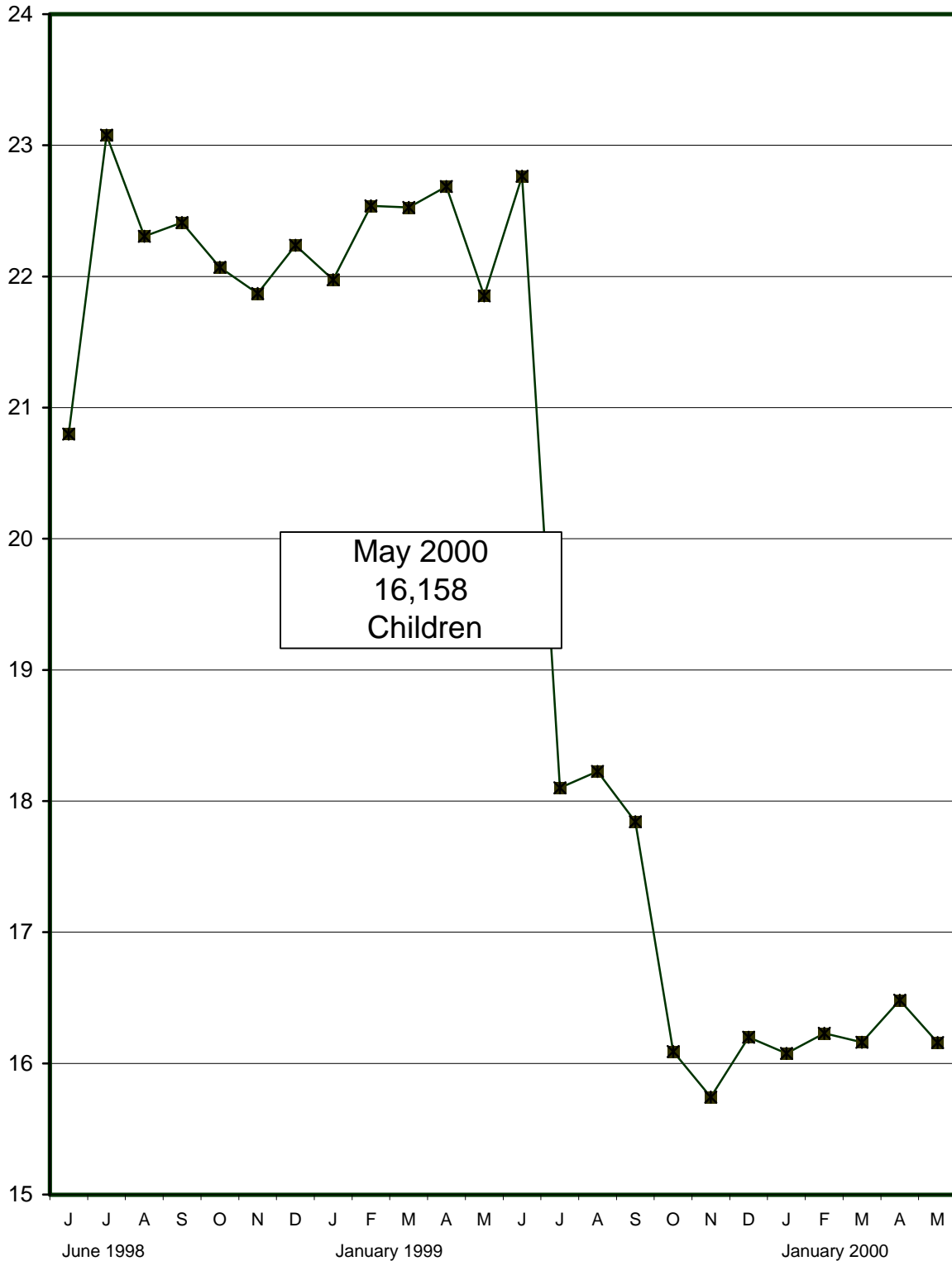

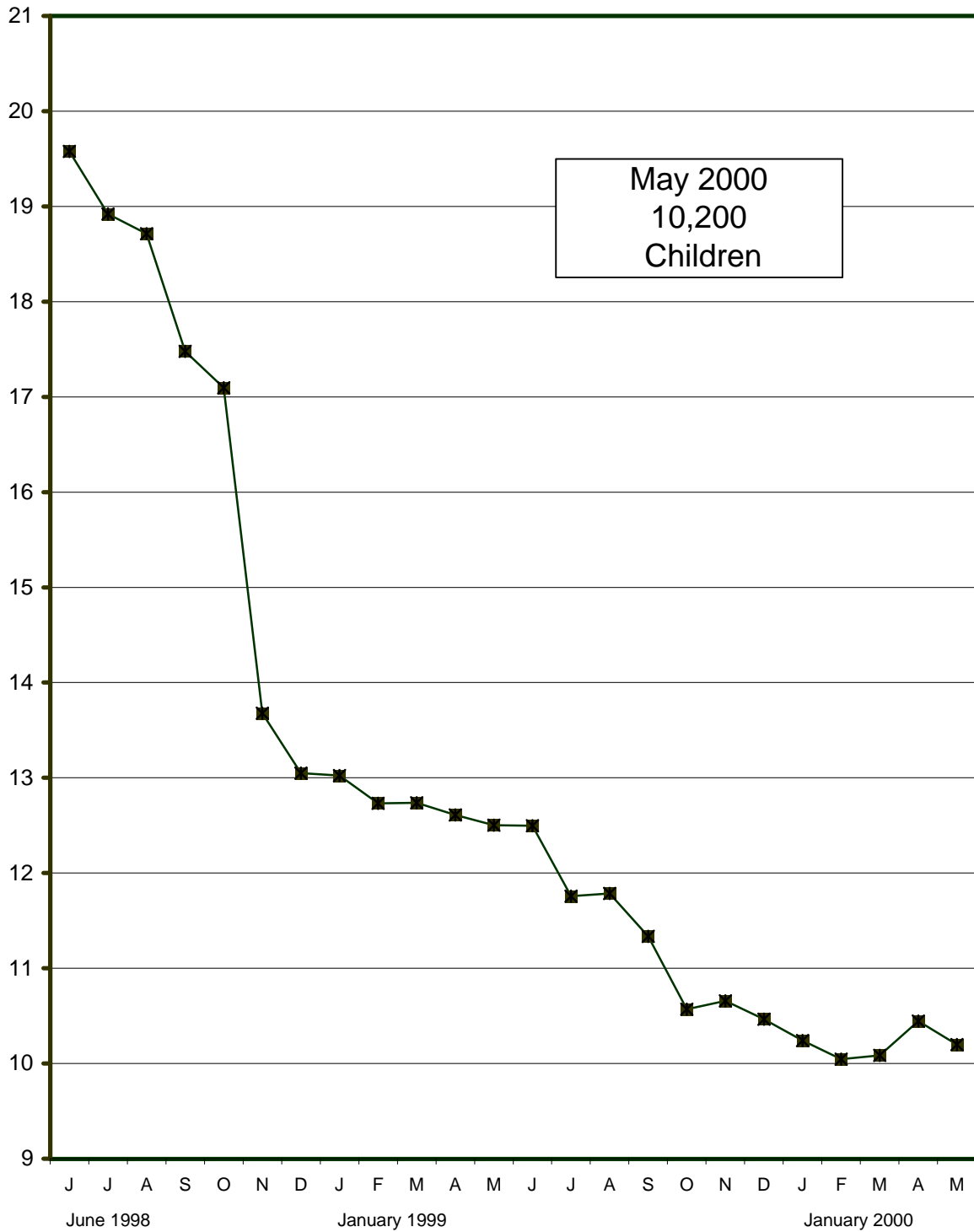

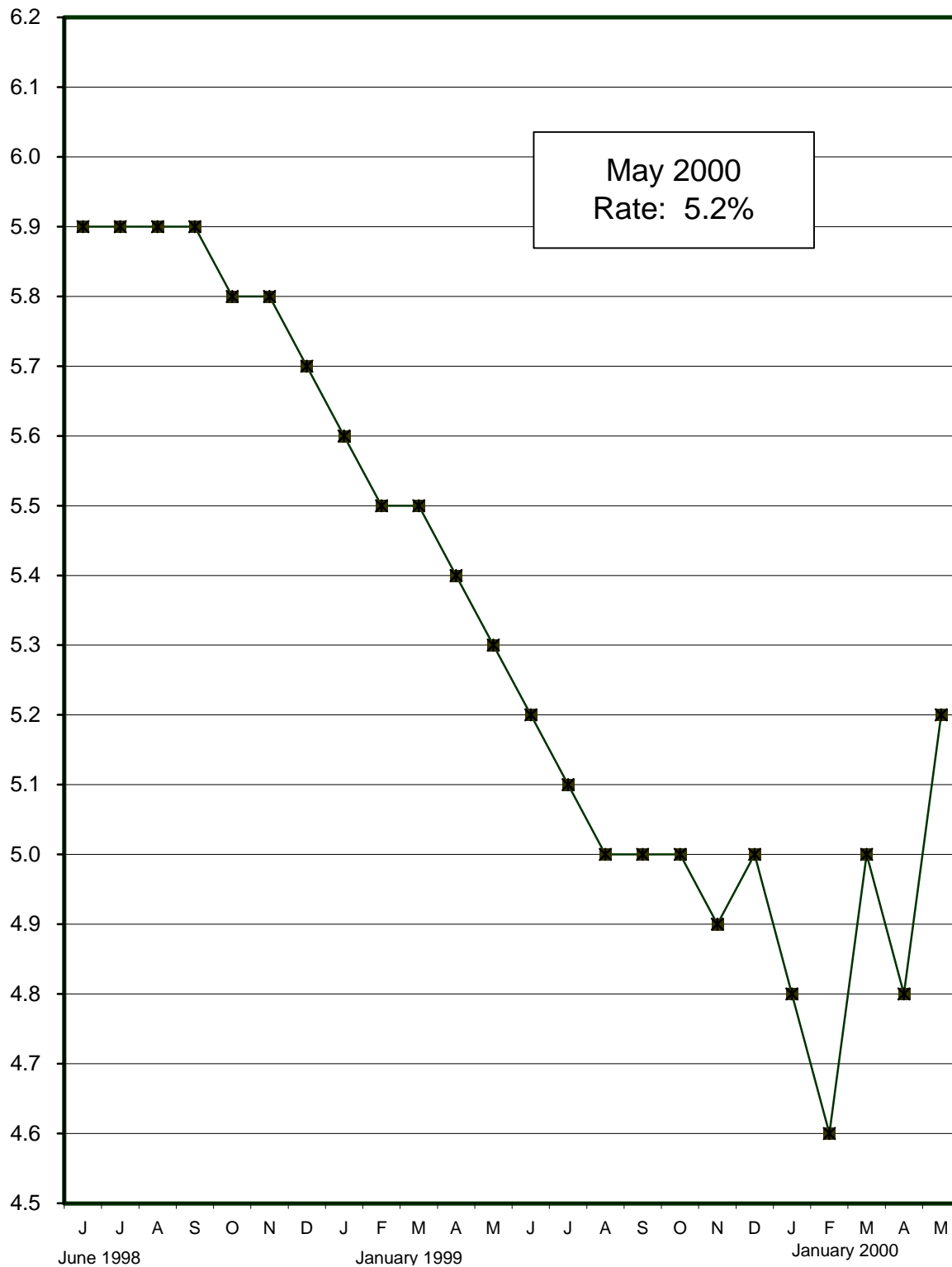

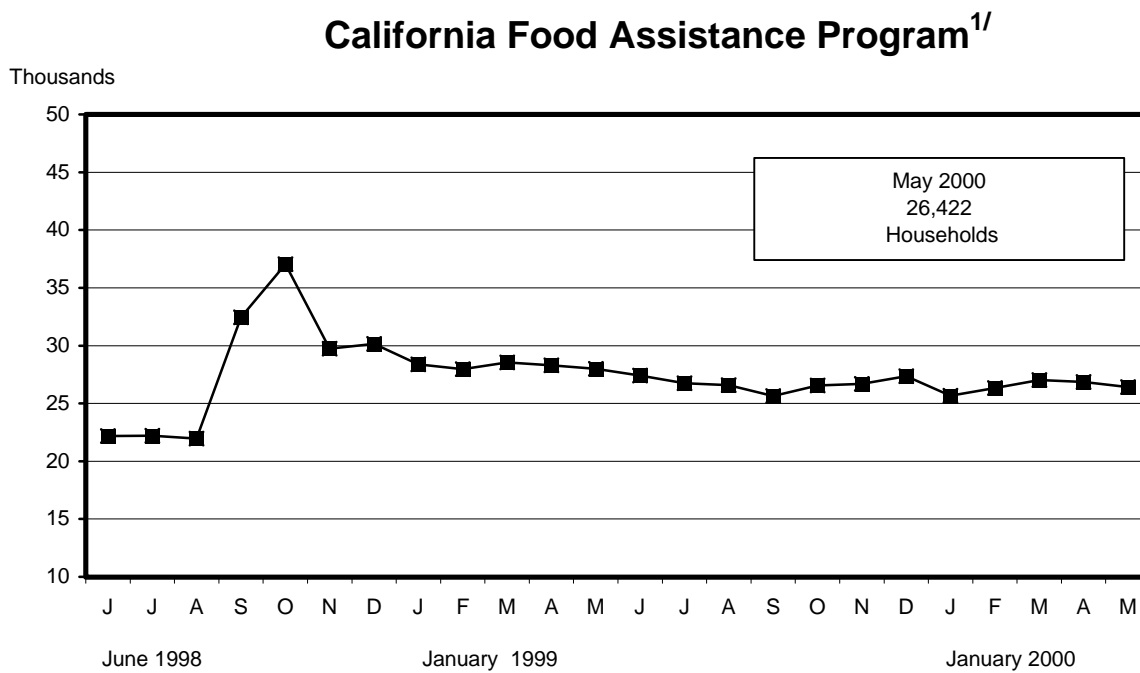
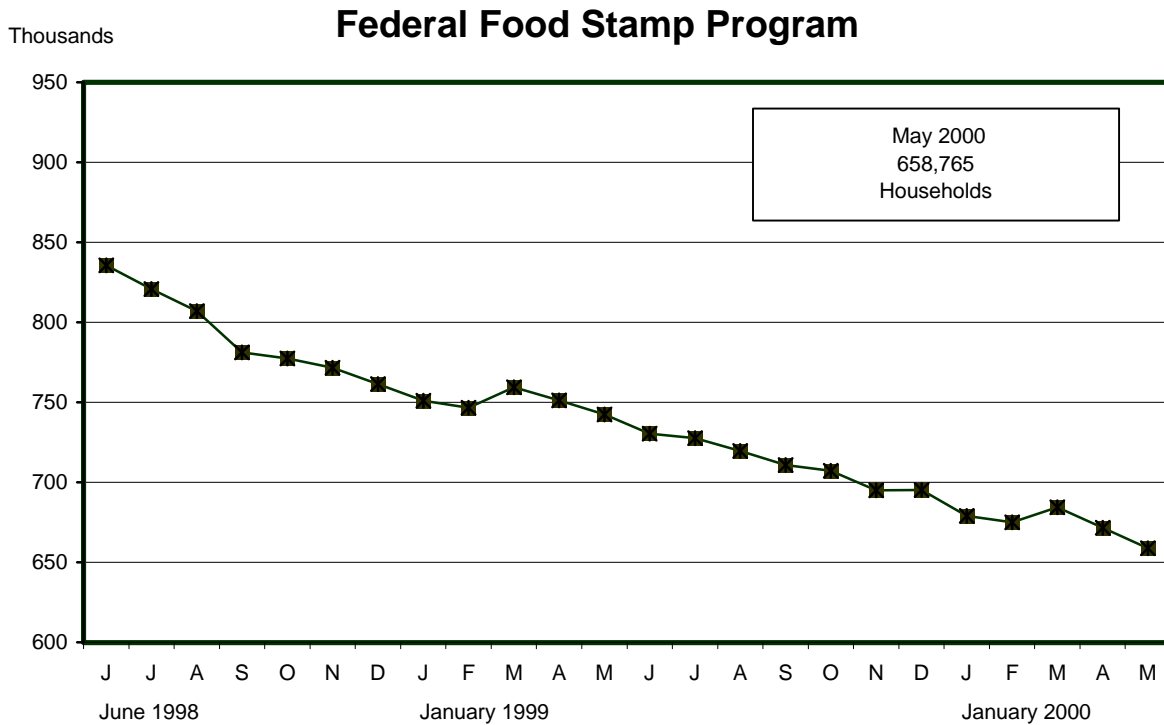

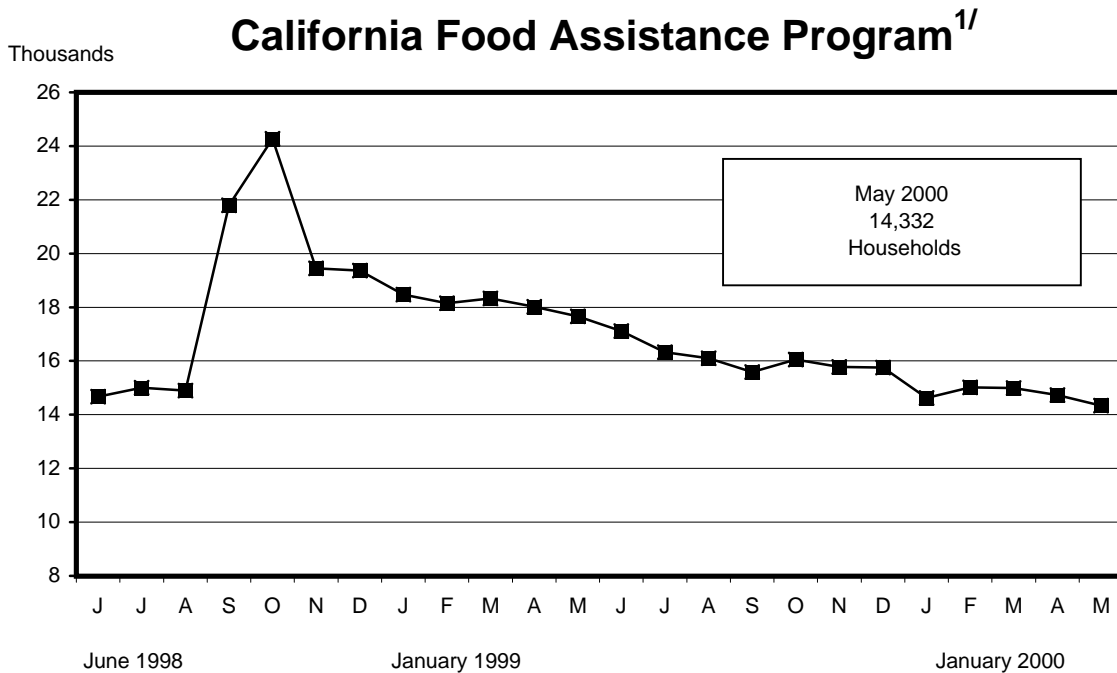
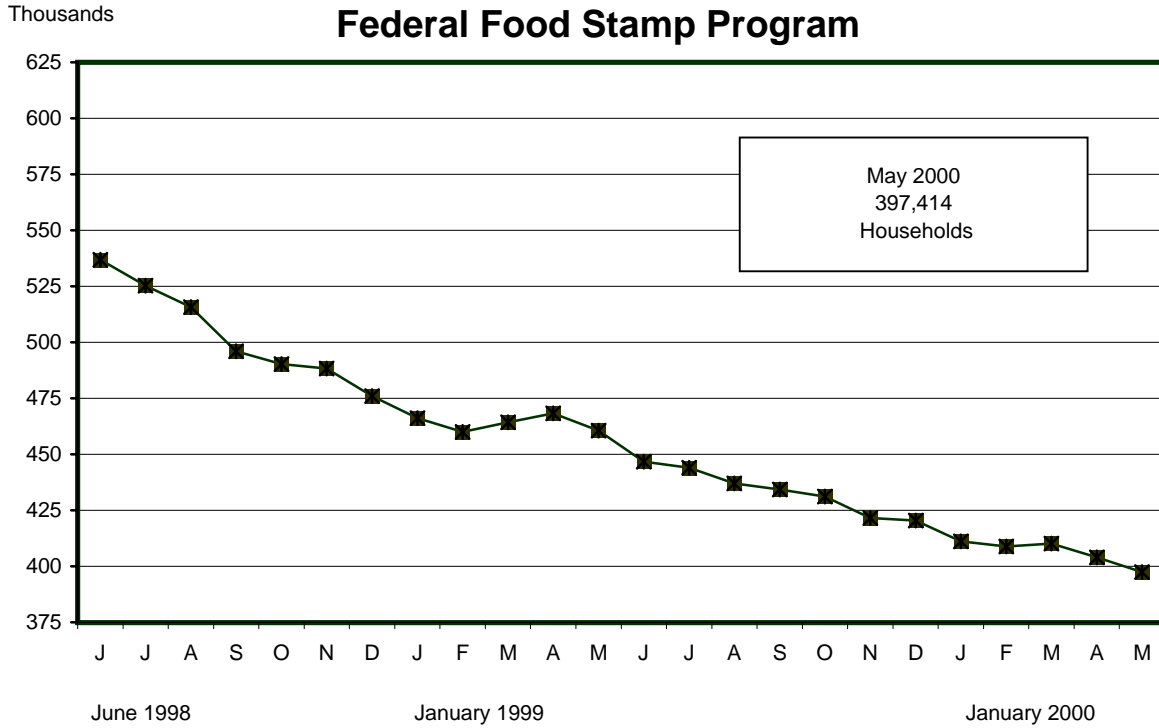


Food Stamp Program Public Assistance and Non-Assistance Households June 1998 - May 2000

Food Stamp Program Households Also Receiving Public Assistance June 1998 - May 2000

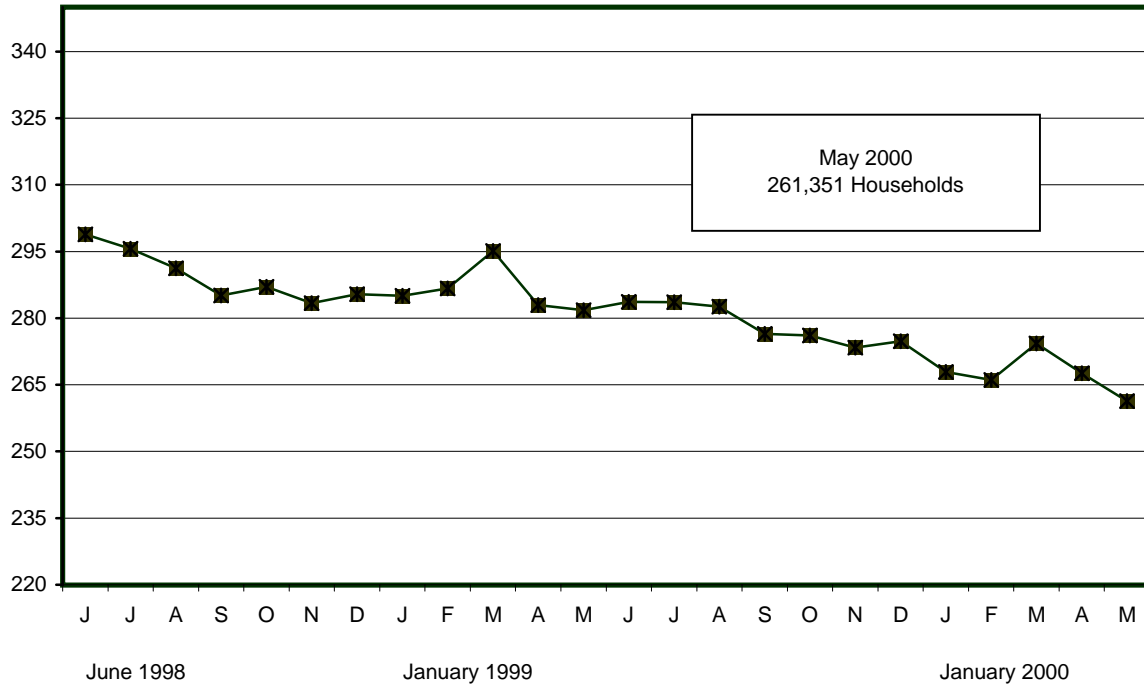

Food Stamp Program Non-Assistance Households June 1998 - May 2000

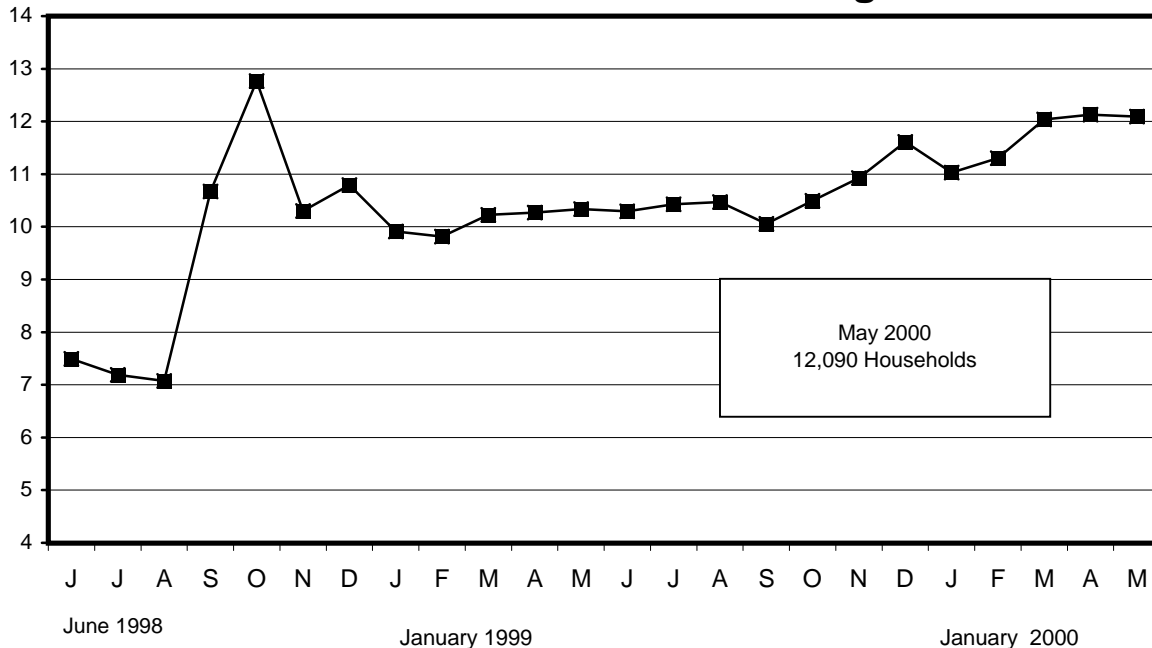
