

January 1996 - January 2001




Federal and Non-Federal Children in Foster Care by Facility Type ^{1/}

January 1996 - January 2001




Supplemental Security Income/State Supplementary Payment Cases January 1996 - January 2001




General Relief Number of Persons January 1996 - January 2001




California Unemployment Rate Seasonally Adjusted January 1996 - January 2001



Federal Food Stamp Program Public Assistance and Nonassistance Households January 1996 - January 2001




California Food Assistance Program (CFAP) Public Assistance and Nonassistance Households September 1997 - January 2001



In-Home Supportive Services Number of Unduplicated Paid Cases January 1996 - January 2001




Adult Protective Services Cases Opened During the Month September 1999 - January 2001
