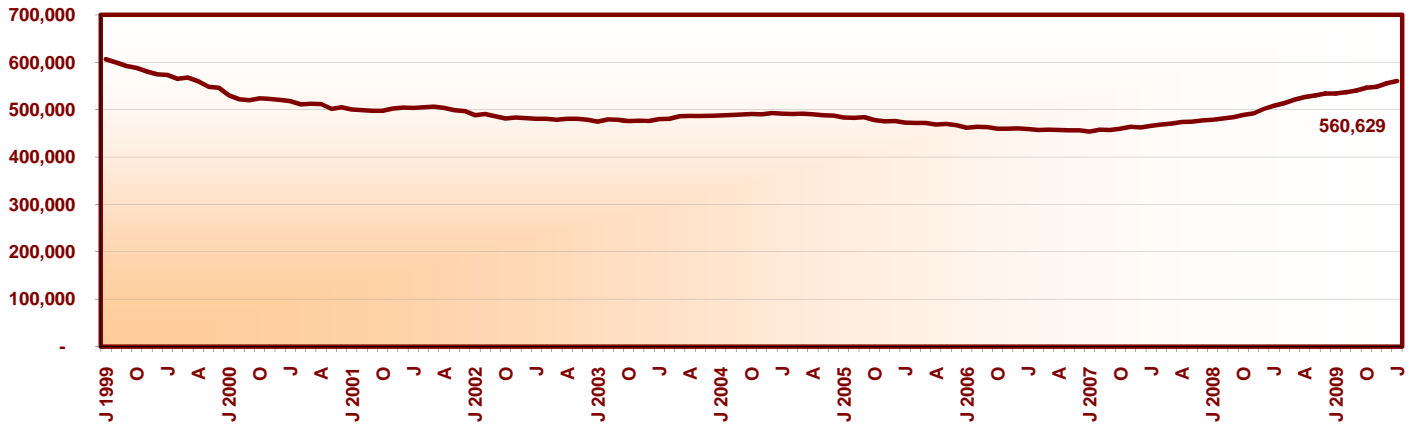

Monthly Caseload Trend Graphs with Current Month Value Displayed

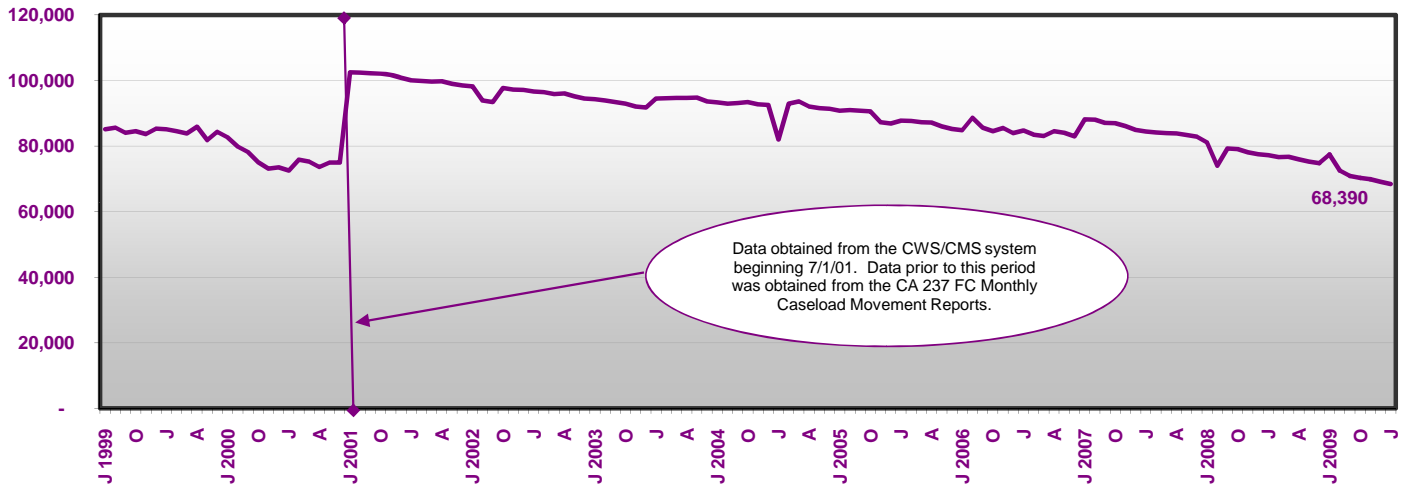

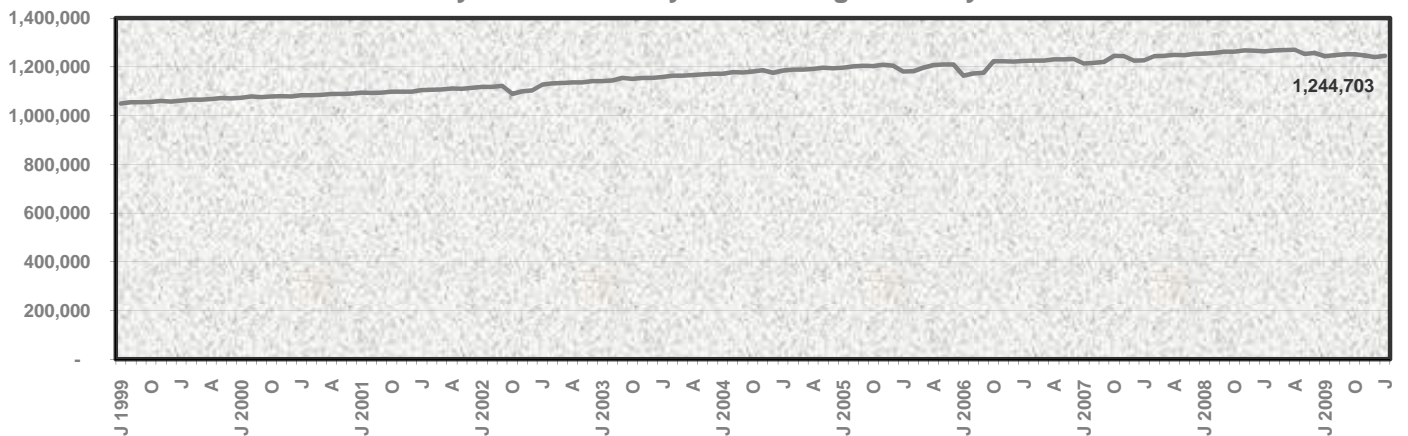
AFDC/CalWORKs Monthly Caseload - July 1999 through January 2010

SSI/SSP Monthly Caseload - July 1999 through January 2010



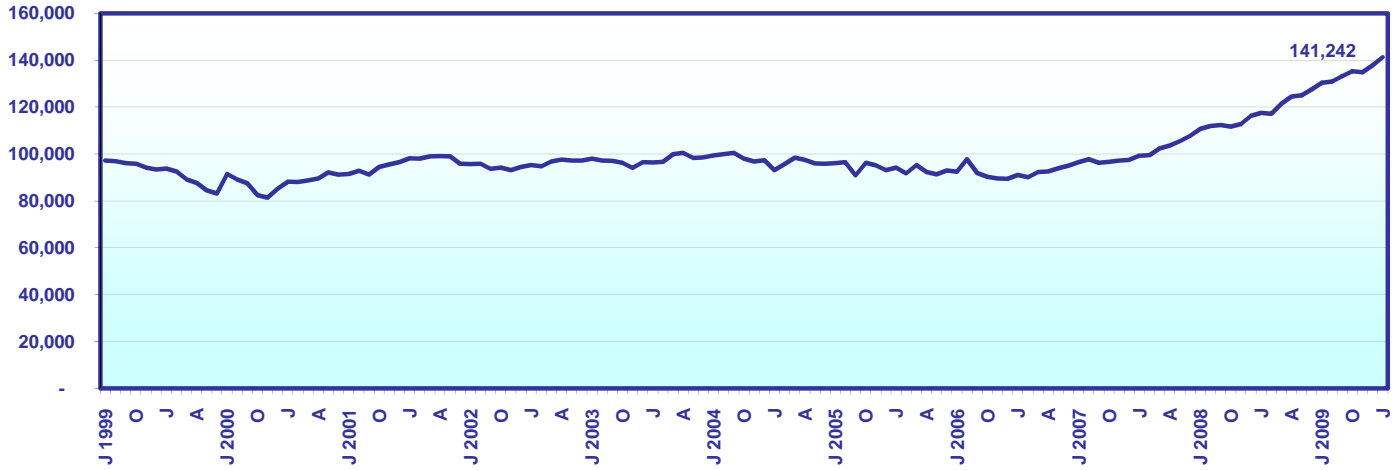

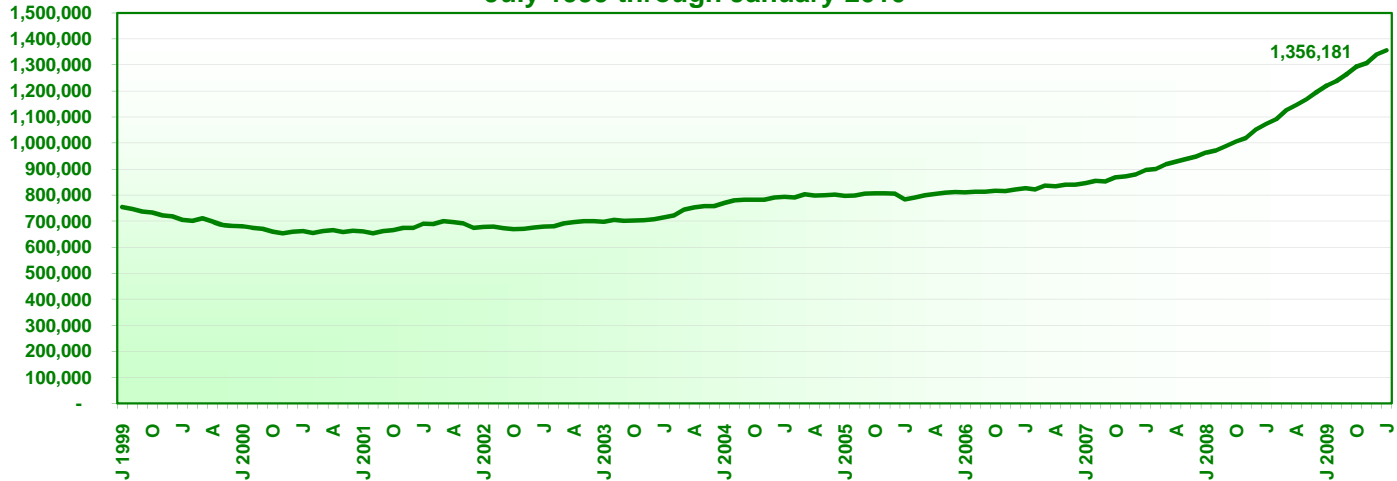

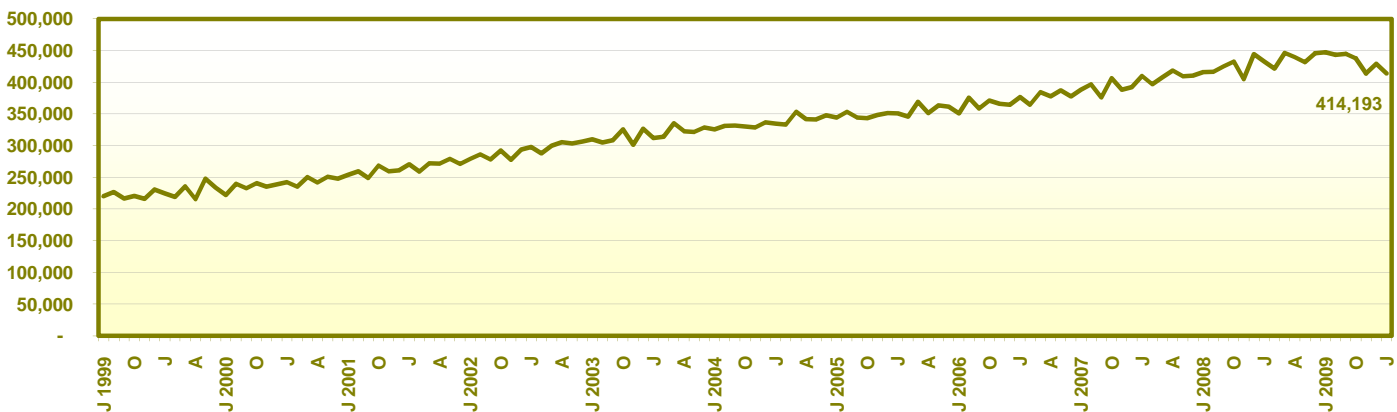
General Relief Monthly Caseload - July 1999 through January 2010
