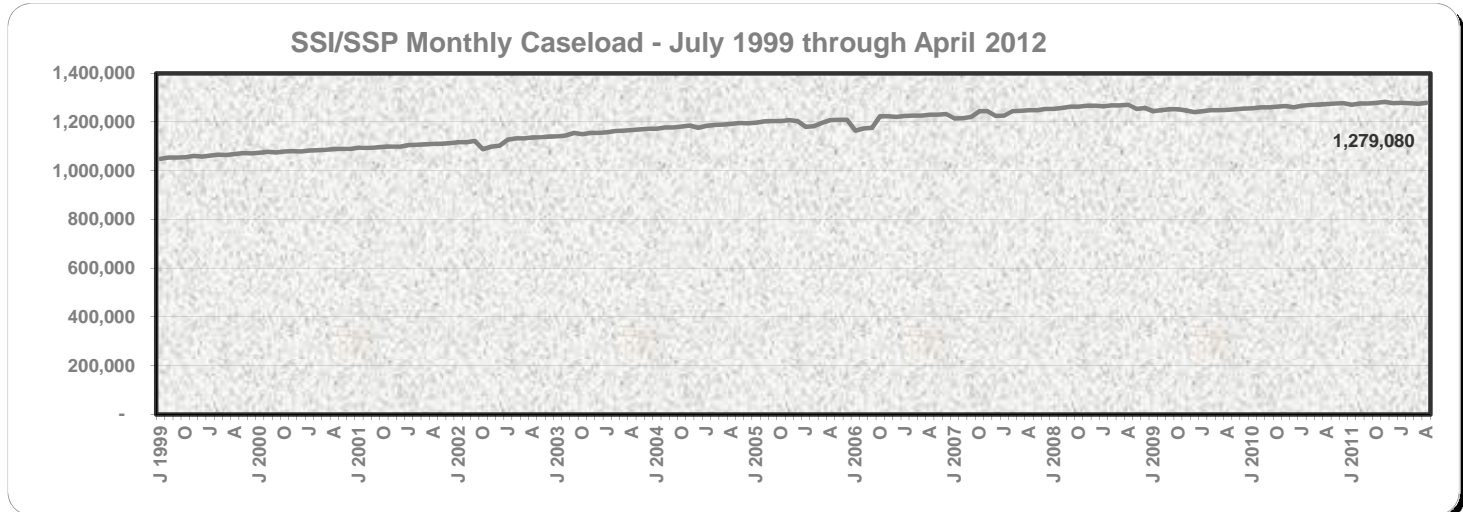
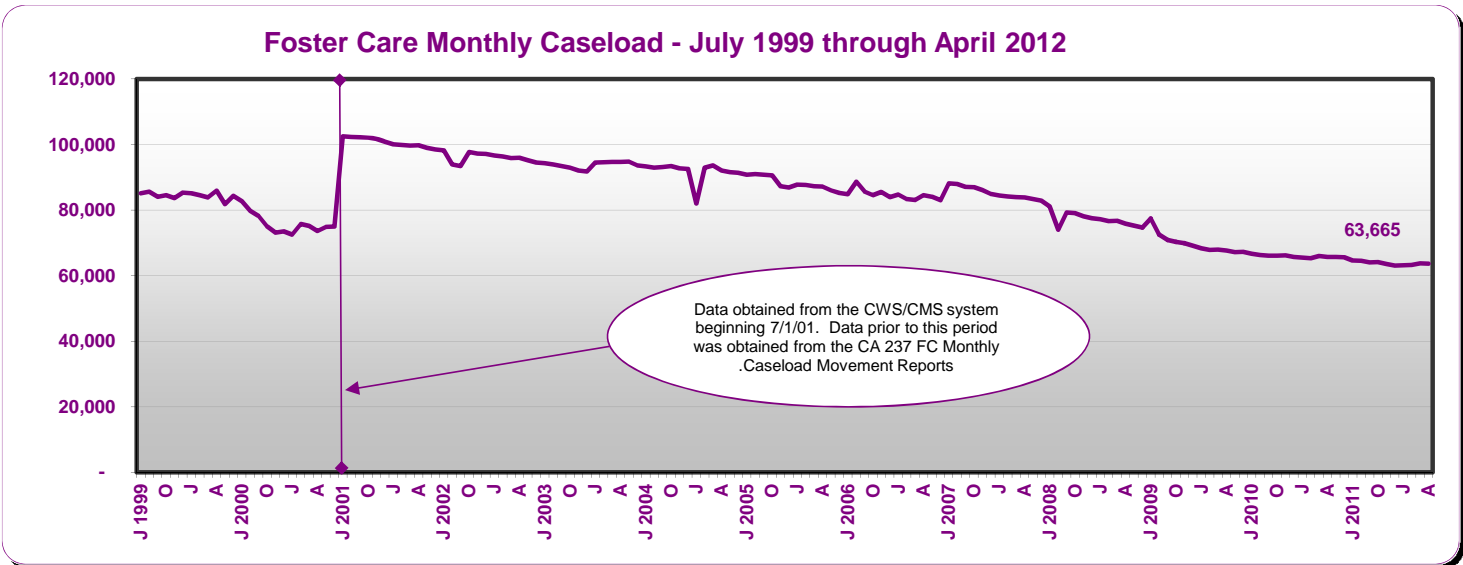
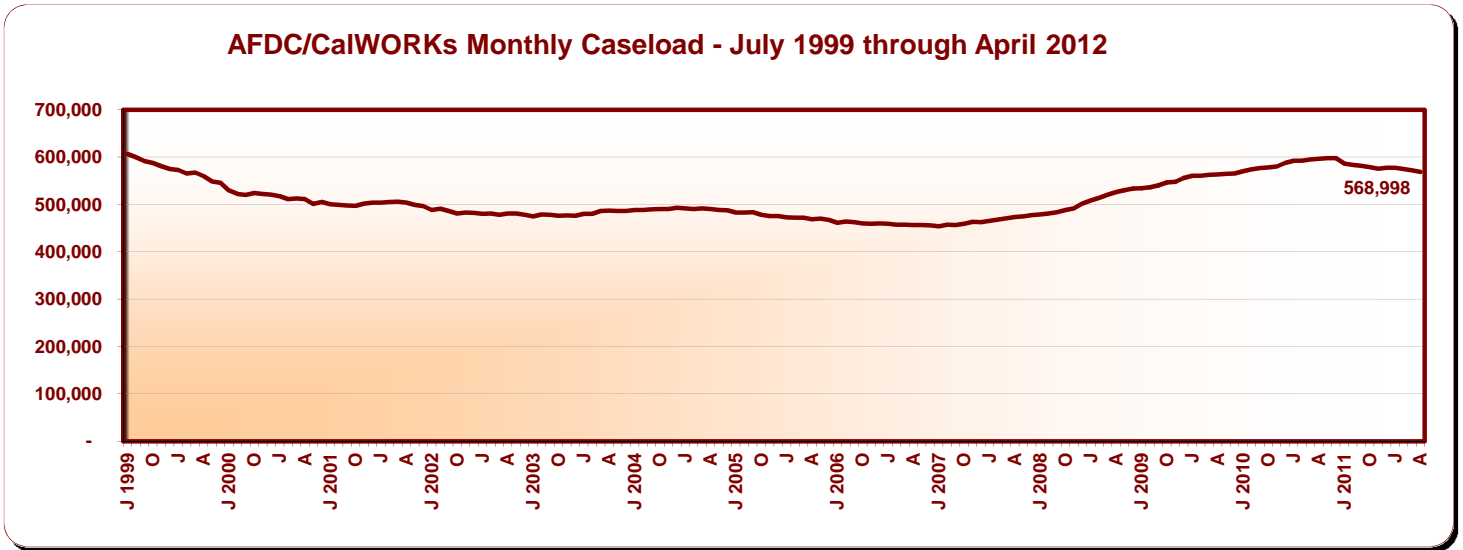

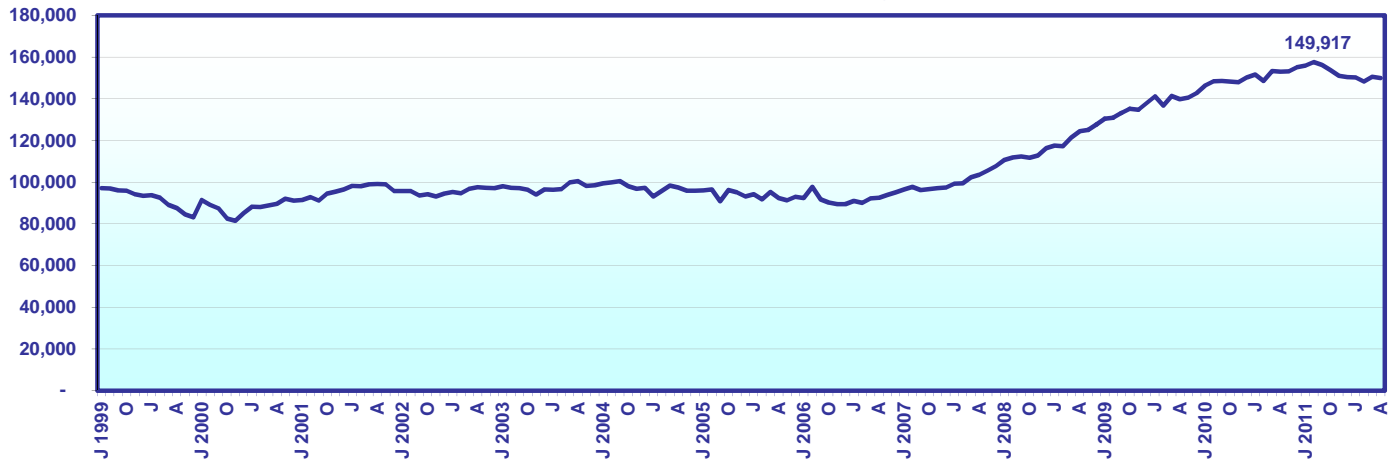

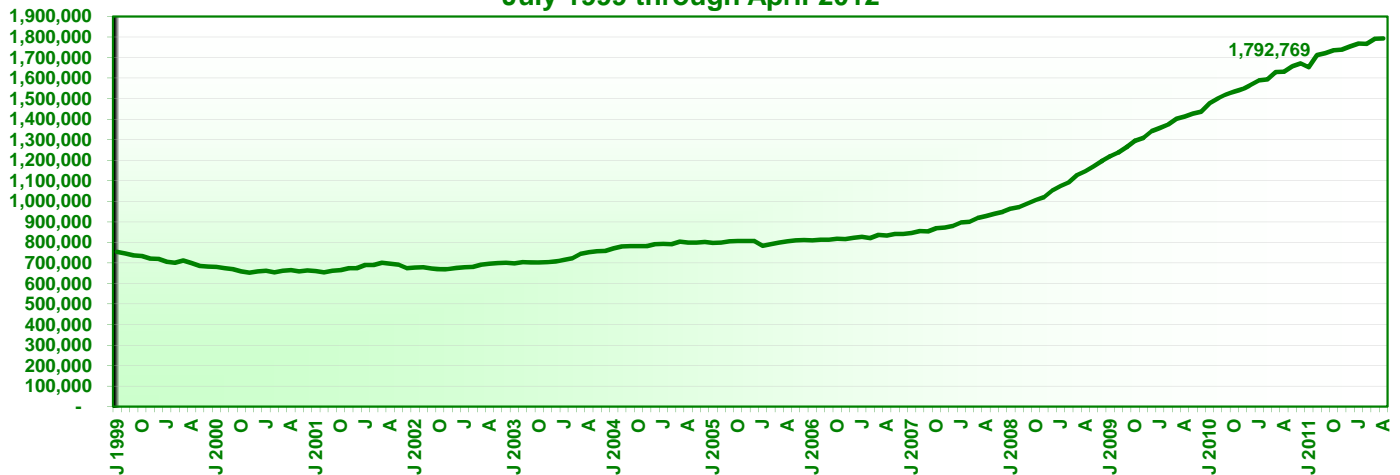

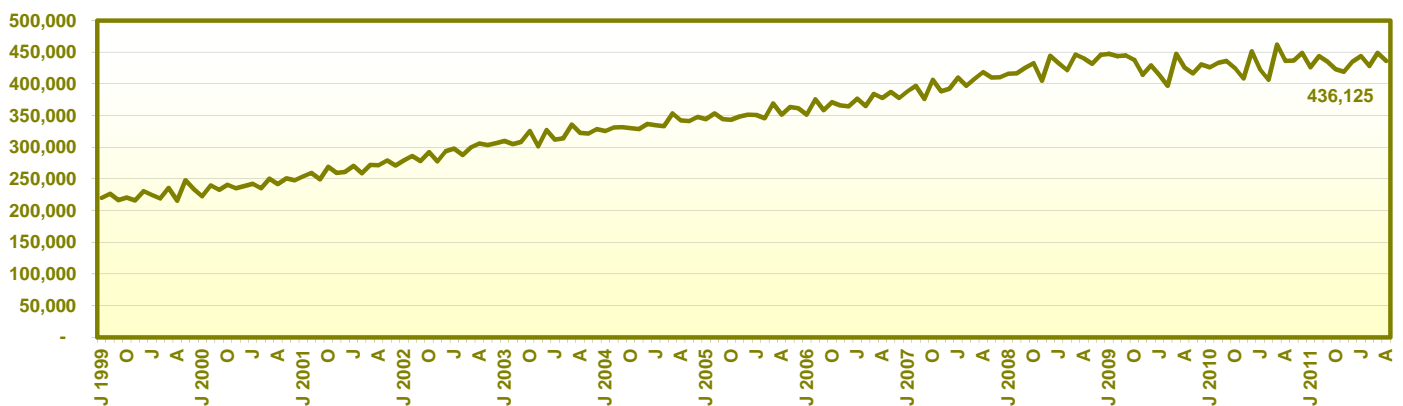
### General Relief Monthly Caseload - July 1999 through April 2012
