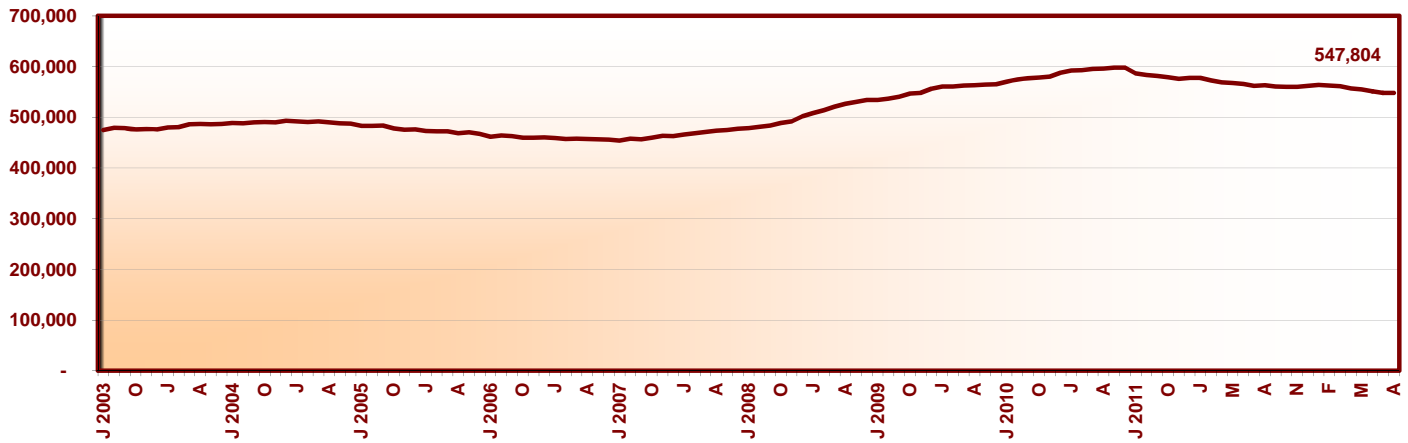

Monthly Caseload Trend Graphs with Current Month Value Displayed

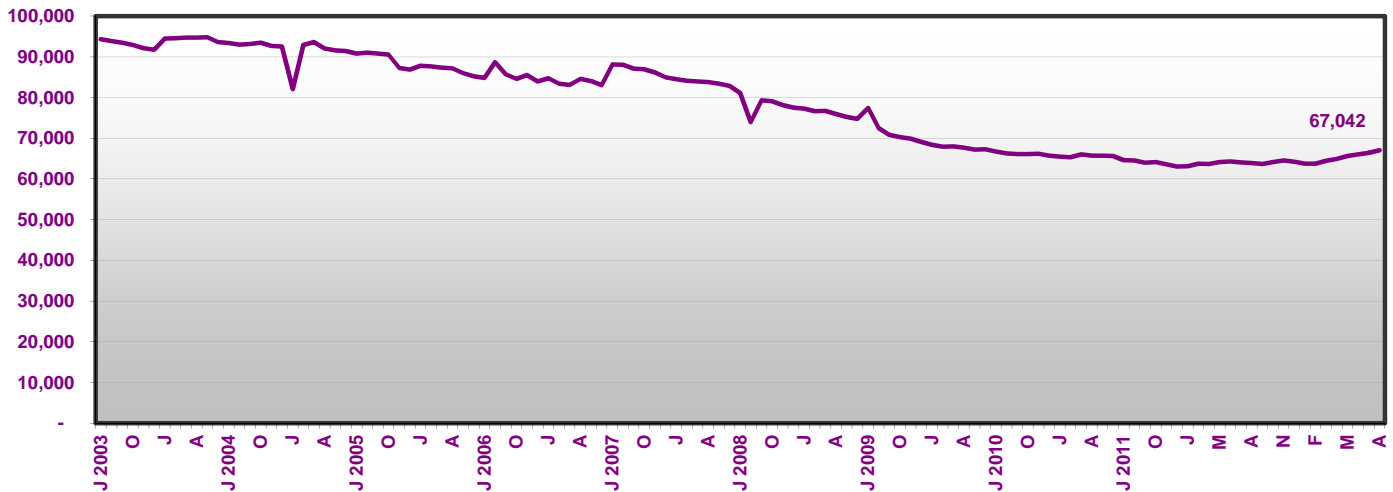

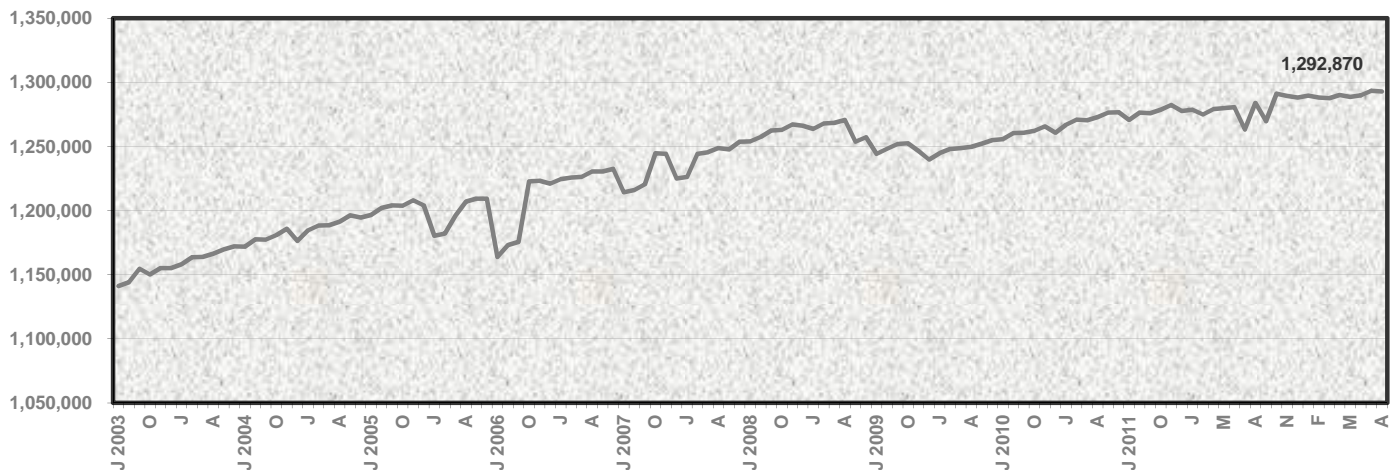
AFDC/CalWORKs Monthly Caseload - July 2003 through August 2013

SSI/SSP Monthly Caseload - July 2003 through August 2013



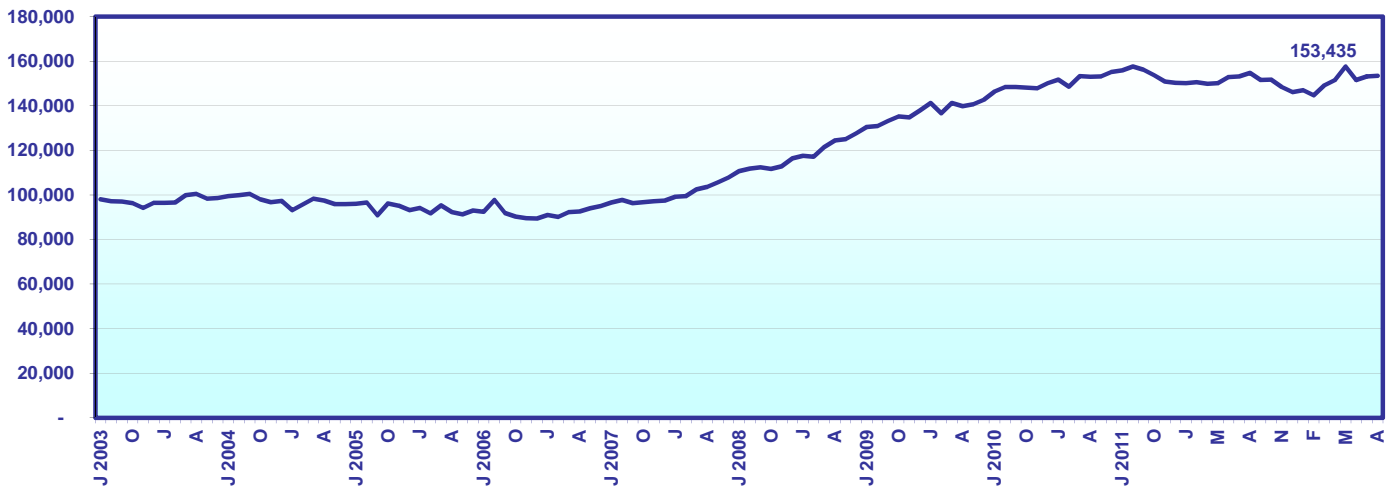

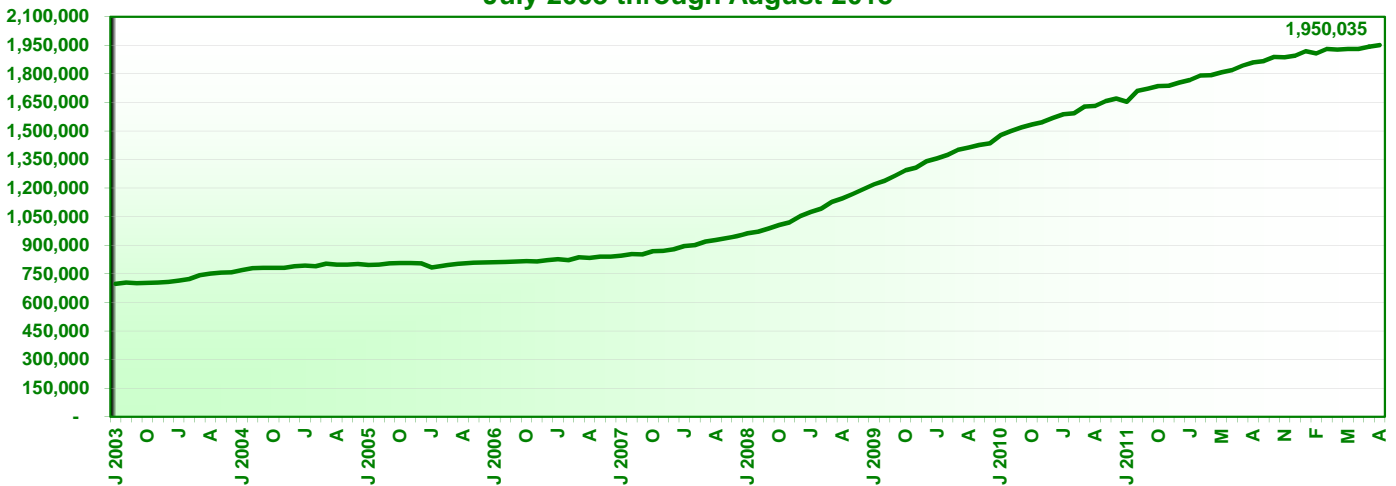

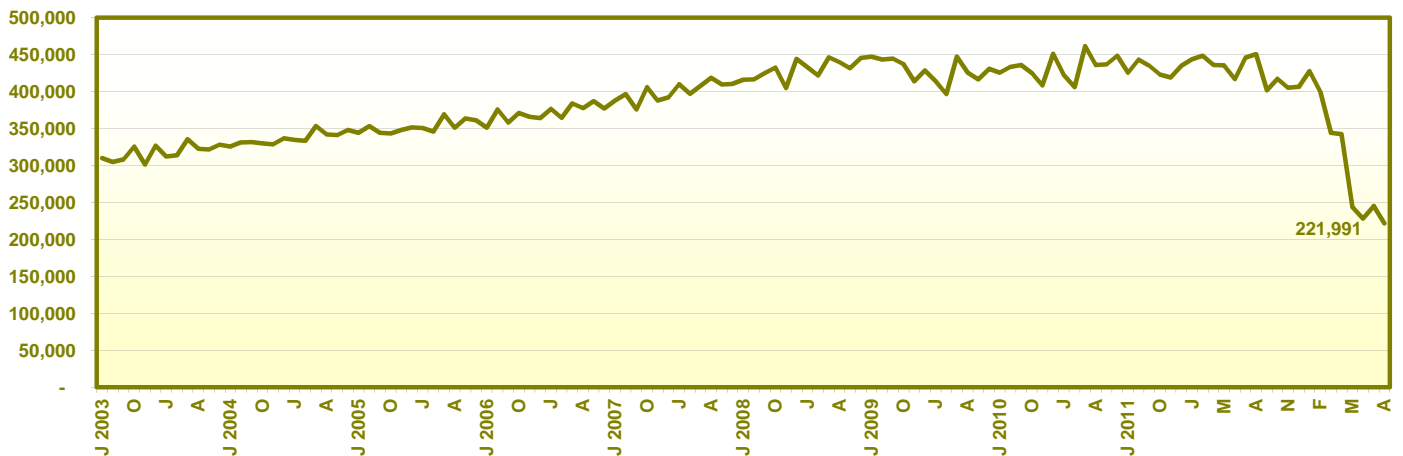
General Relief Monthly Caseload - July 2003 through August 2013
