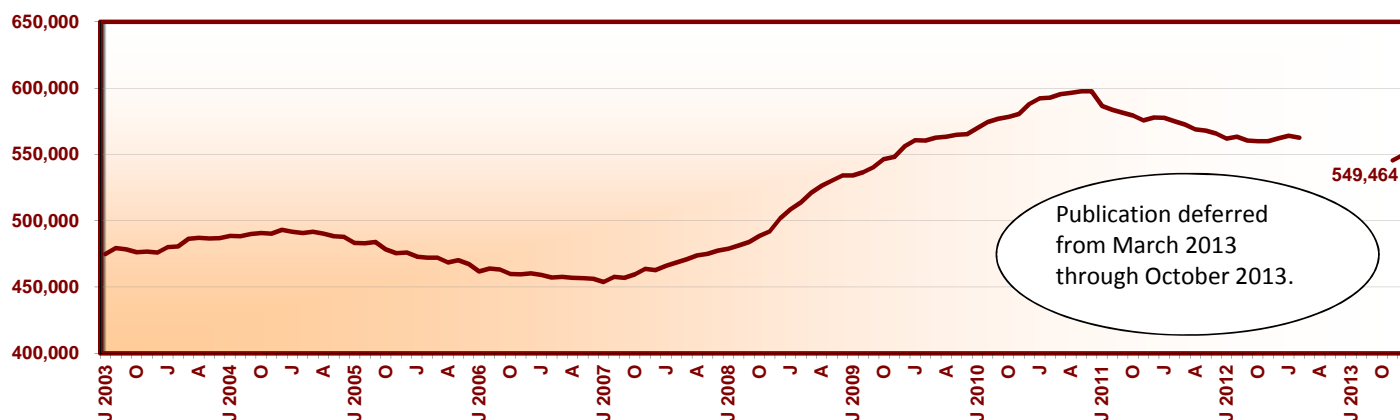

Monthly Caseload Trend Graphs with Current Month Value Displayed

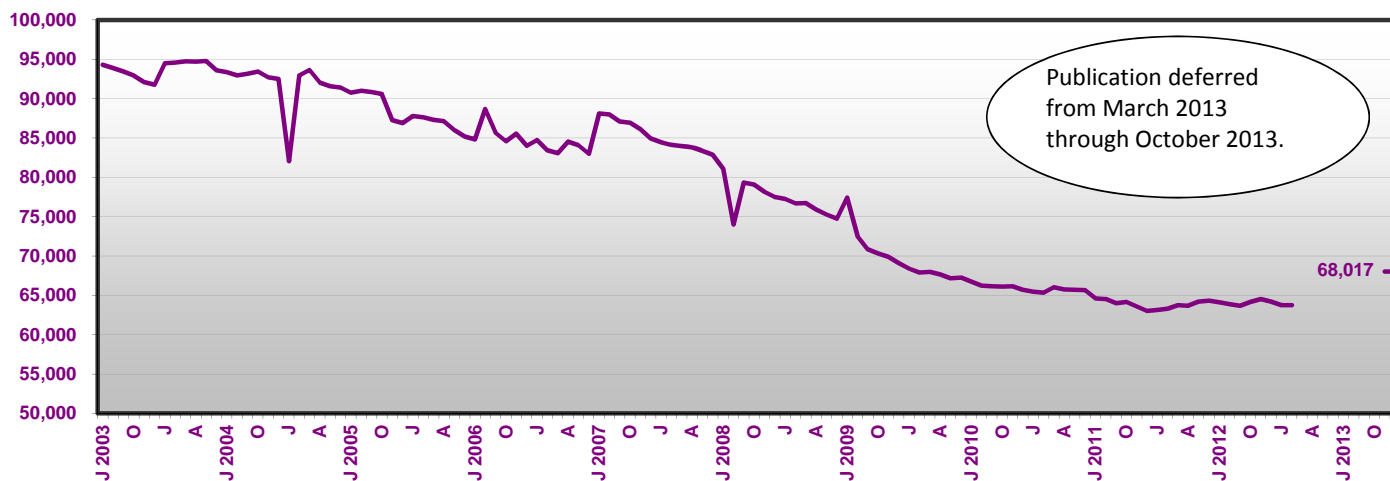

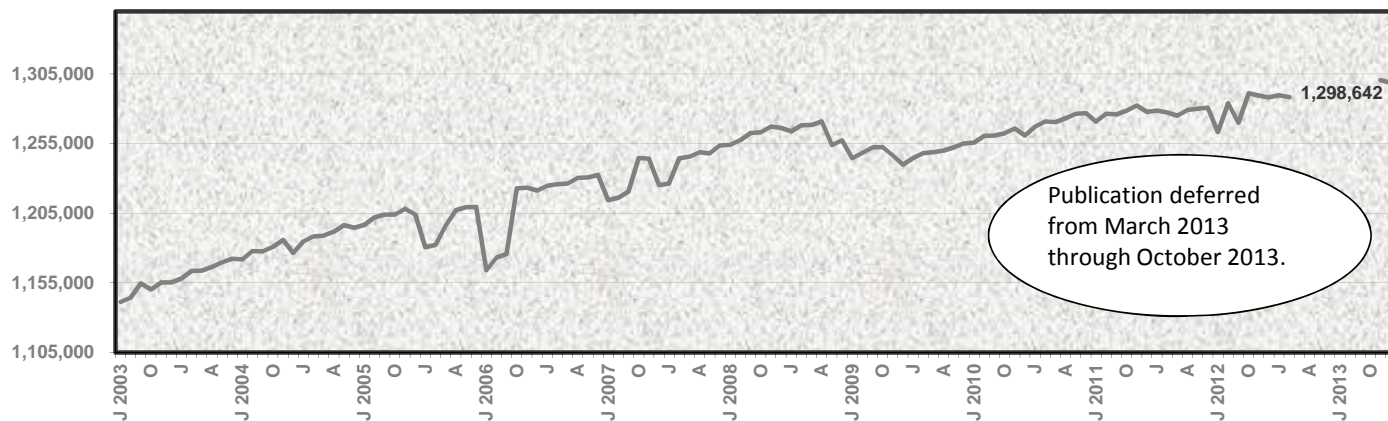
## AFDC/CalWORKs Monthly Caseload - July 2003 through December 2013

## SSI/SSP Monthly Caseload - July 2003 through December 2013



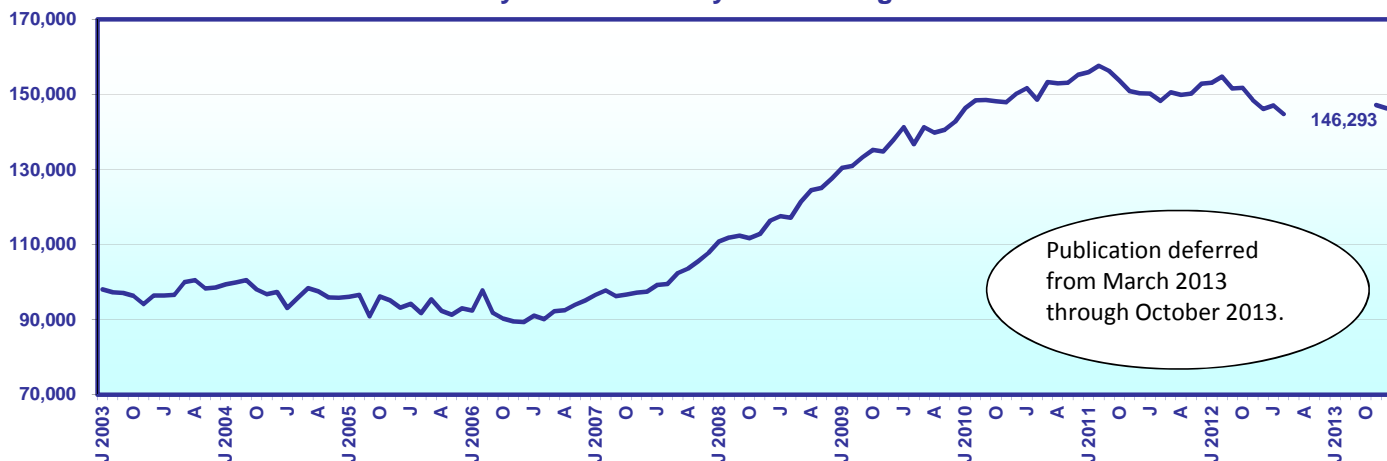

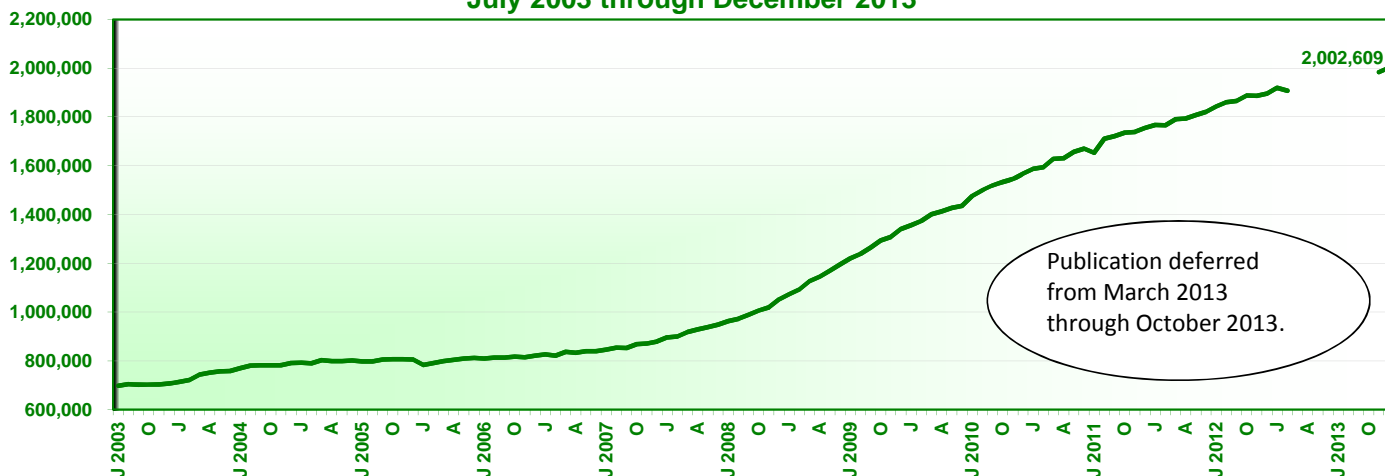

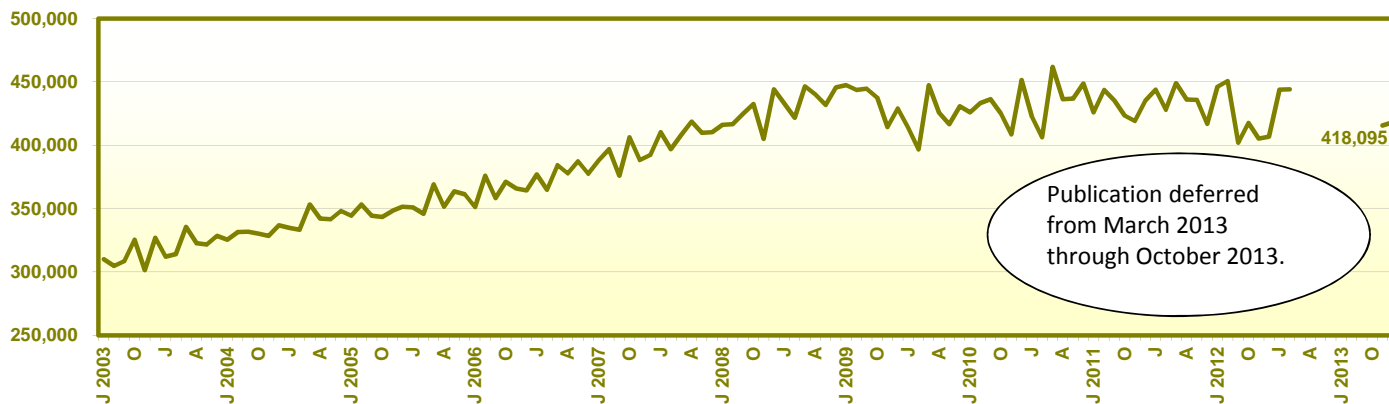
**General Relief Monthly Caseload - July 2003 through December 2013**
