REVISION due to Sutter County: Primary language change from Ilocano to Other Non-English.

Humboldt: FC and CAPI unavailable due to SAWS problems. Combined Asian Indian, Hawaiian and Other Asian or Pacific Islander for column E.

Imperial: Will fax Social Services figures when available.

Los Angeles: Includes the estimated caseload for Pasadena District Office, currently in LEADER pilot. FC (column C) and Child Welfare Services (column D) reported by the Los Angeles County Department of Children and Family Services. Ethnic Origin and Primary Language has "Other" combined in Vietnamese column.

Madera: Will fax Social Services figures when available.

Modoc: Only reported CalWORKs Welfare to Work figures.

Riverside: 1) Social Services is not a required field in State designed CMS system. Unable to identify ethnic origin for 339 cases and primary language for 287 cases. 2) Under CalWORKs Welfare to Work: counts for 1,912 blank values not included. Unable to determine until appraisal is completed.

San Mateo: Under Primary Language Spoken, Other Non-English: These cases did not specify language.

Sutter: GAIN (column F) Punjaki and Afghani in Other Non-English.

Tulare: Romanian in Other Non-English.
