- 1..... 1971-72 - Chapter 578, Statutes of 1971 (SB 796), Welfare Reform Act of 1971, established, effective October 1, 1971, the first uniform statewide schedule of Maximum Aid Payment (MAP) in W & I Code Section 11450 (a), and Minimum Basic Standards of Adequate Care (MBSAC) in W & I Code Section 11452, and automatic cost-of-living adjustments (COLA) based on the Consumer Price Index (CPI) in W & I Code Section 11453.
- 2..... 1972-73 - Chapter 1406, Statutes of 1972, (SB 90), effective June 1, 1973, increased all MAPs by \$2.00 to offset an increase to the state sales tax of one cent on the dollar which was also contained in SB 90.
- 3..... 1973-74 - Chapter 578, Statutes of 1971, (AB 796), provided a 2.83% COLA effective July 1, 1973, reflecting the change in the CPI from March 1972 to December 1972.
- 4..... 1974-75 - The 1974-75 Budget Act package provided a 7.42% COLA effective July 1, 1974, reflecting the CNI change from December 1972 to December 1973.
- 5..... 1975-76 - The 1975-76 Budget Act package provided a 12.18% COLA effective July 1, 1975, reflecting the CNI change from December 1973 to December 1974.
- 6..... 1976-77 - The 1976-77 Budget Act package provided a 8.54% COLA effective July 1, 1976, reflecting the CNI change from December 1974 to December 1975. Chapter 348, Statutes of 1976, (AB 2601), effective January 1, 1977 increased MAPs and MBSACs by an arbitrary 6%.
- 7..... 1977-79 - The 1977-78 Budget Act package provided a 5.24% COLA effective July 1, 1977, reflecting the CNI change from December 1975 to December 1976. For 1978-79, no COLA was allowed. Chapter 292, Statutes of 1978, (SB 154), suspended the statutory 7.71% COLA which reflected the change in CPI from December 1976 to December 1977.
- 8..... 1979-80 - Although the Budget Act of 1979 included funds for only a 14.5% COLA, a 15.16% COLA was applied effective July 1, 1979. This represented a two year catch-up COLA that was based on the December 1976 to December 1978 CPI change. (a one year COLA based on the December 1977 to December 1978 CPI change would have been 6.91%).
- 9..... 1980-81 - The 1980-81 Budget Act package provided a 15.48% COLA effective July 1, 1980, reflecting the change in CPI from December 1978 to December 1979. Chapter 511, Statutes of 1980, (AB 2982), effective January 1, 1981, created a new index to measure cost-of-living changes - the California Necessities Index (CNI). The CNI was based on various components of the CPI that more appropriately reflected the cost-of-living changes to low income families. The identical to the MAPs were reduced 2.48% to a level equivalent to a 13.0% increase over the 1978-80 standards. The 13.0% figure was determined by retroactively computing the CNI change from December 1978 to December 1979.
- 10..... 1981-83 - Chapter 69, Statutes of 1981, (SB 633), effective July 1, 1981 provided for an arbitrary 9.2% COLA in lieu of the statutory 11.1% COLA based on the December 1979 to December 1980 CNI change. MBSAC levels were made MAPs except for families with nine or ten persons which were unchanged from the 1980-81 levels. For 1982-83, no COLA was allowed. Chapter 327, Statutes of 1982, (SB 1326), suspended the statutory 6.2% COLA reflecting the CNI change from December 1980 to December 1981.
- 11..... 1983-84 - Chapter 323, Statutes of 1983 (AB 223) effective July 1, 1983 provided for an arbitrary 4.0 percent COLA in lieu of the statutory 5.7 percent COLA based on the December 1981 to December 1982 CNI change.
- 12..... 1984-85 - The 1984-85 Budget Act package provided a 5.6% COLA effective July 1, 1984, reflecting the CNI change from December 1982 to December 1983.
- 13..... 1985-86 - The 1985-86 Budget Act package provided a 5.7% COLA effective July 1, 1985, reflecting the CNI change from December 1983 to December 1984.

- 14..... 1986-87 - The 1986-87 Budget Act package provided a 5.1% COLA effective July 1, 1986, reflecting the CNI change from December 1984 to December 1985.
- 15..... 1987-88 - The 1987-88 Budget Act package provided a 2.6% COLA effective July 1, 1987, reflecting the CNI change from December 1985 to December 1986.
- 16..... 1988-89 - The 1988-89 Budget Act package provided a 4.7% COLA effective July 1, 1988, reflecting the CNI change from December 1986 to December 1987.
- 17..... 1989-90 - The 1989-90 Budget Act package provided a 4.6% COLA effective July 1, 1989, reflecting the CNI change from December 1987 to December 1988.
- 1990-91 - No COLA was granted. Chapter 456, Statutes of 1990, eliminated the COLA for this fiscal year.
- 1991-92 - No COLA was granted. Chapter 97, Statutes of 1991, (SB 724), froze the MBSAC and required a rollback of MAPs equaling 4.4% which was applied September 1, 1991.
- 18..... 1992-93 - No COLA was granted to MAPs. Chapter 722, Statutes of 1992, (SB 485), increased MBSAC by 1.27% effective July 1, 1992.
- 1992-93 - Chapter 722, Statutes of 1992, (SB485), reduced MAPs by 4.5% effective October 1, 1992.
- 19..... 1992-93 - Chapter 722, Statutes of 1992, (SB485), reduces MAPs by 1.3% effective December 1, 1992. This reduction was also approved in the APDP final terms and Conditions.
- 20..... 1993-94 - Chapter 69, Statutes of 1993, (SB 35), reduced the MAPs by 2.7% effective September 1, 1993. The MBSAC increased by 1.66% effective July 1, 1993. MBSAC increased by 1.18% effective July 1, 1994.
- 21..... effective July 1, 1994.
- 22..... 1996-97 - Statute of 1996, (AB 908) mandated "regionalized grants" establishing "Exempt and Non-exempt" assistance units (AU) and a 2.3% reduction in MAP for "Non-exempt" AU's, while restoring "Exempt" AU's to 1992 MAP levels.
- 23..... MBSAC increased to 100% of CNI.
