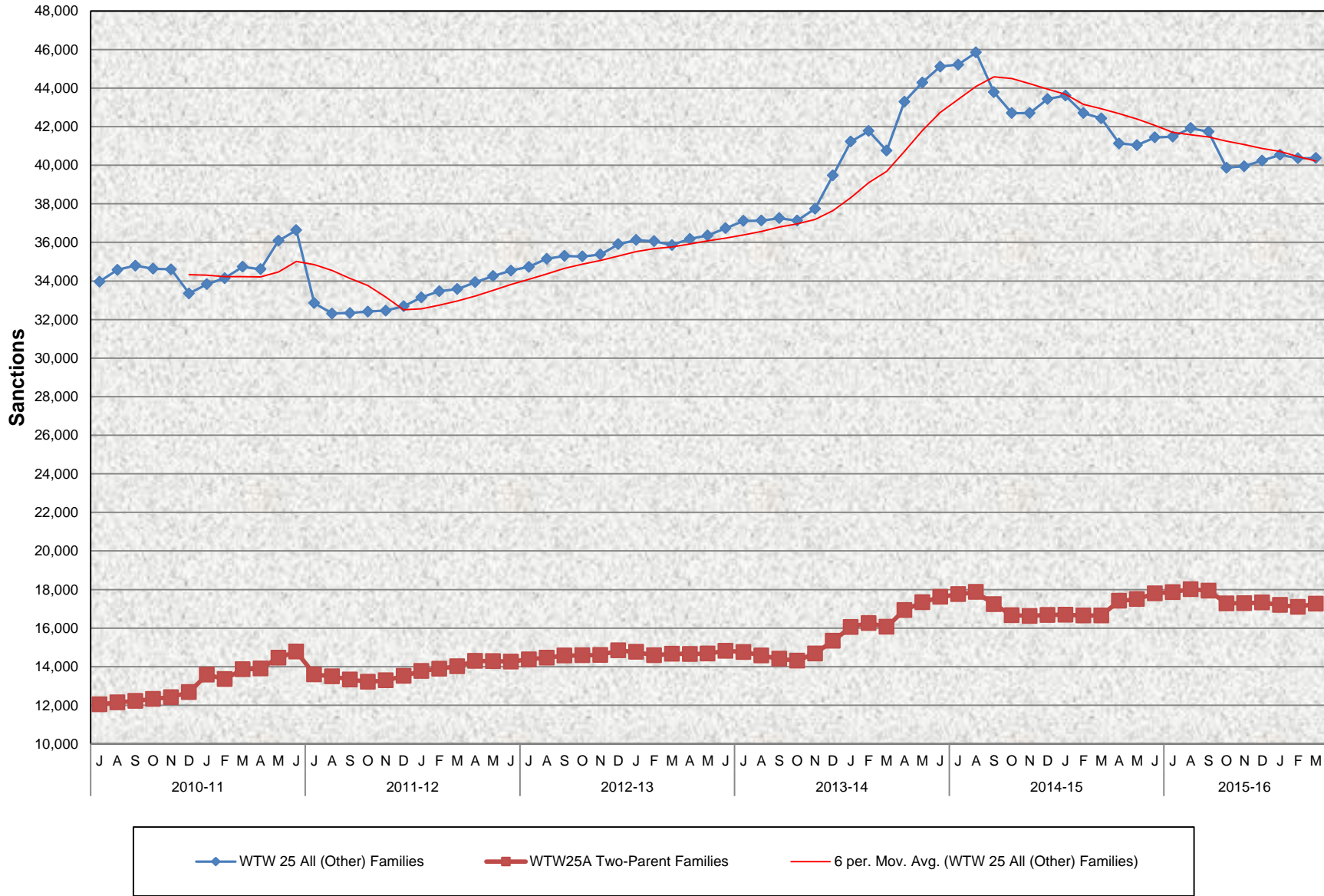

TRENDS

- **The number of CalWORKs adults sanctioned for not participating in the CalWORKs Welfare-to-Work Program increased 0.3% between February 2016 and March 2016.**
0.0% increase in All (Other) Families.
1.0% increase in Two-Parent Families.
- **The number of CalWORKs adults sanctioned for not participating in the CalWORKs Welfare-to-Work Program decreased 2.4% between March 2015 and March 2016.**
4.8% decrease in All (Other) Families.
3.7% increase in Two-Parent Families.
