The purpose of this errata is to revise the citation in [All County Letter \(ACL\) 21-24, released March 4, 2021](#), regarding the interview scheduling for the CalFresh program.

The original and revised language for the impacted section is provided below. Deletions are contained within brackets and marked with a [~~striketrough~~], and additions are contained within braces and in **{bold}**.

The original language on page ten under the “Time-Block” second paragraph reads:

Under this option, the CWD must schedule the interview on a specific date for a designated block of time. For initial application, the interview must be scheduled within 30 days from the date the application is filed per [MPP 63-300.46](#). For recertification, the interview must be scheduled by the 15<sup>th</sup> of the final month of the certification period per [MPP 63-504.61](#).

The revised language reads:

Under this option, the CWD must schedule the interview on a specific date for a designated block of time. For initial application, the interview must be scheduled **{as promptly as possible to ensure eligible households receive an opportunity to participate}** within 30 days from the date the application is filed per [MPP 63-300.46](#). For recertification, the interview must be scheduled ~~[by the 15<sup>th</sup> of the final month of the certification period per [MPP 63-504.61](#)]~~ **{so that the household has at least 10 days after the interview to provide verification before the certification period expires as per [7 CFR 273.14\(b\)\(3\)\(iii\)](#)}**.
