REFERENCE: [TITLE 7 CODE OF FEDERAL REGULATIONS 273.7\(c\)\(9\); PUBLIC LAW 115-334 SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM PROVISIONS OF THE AGRICULTURAL IMPROVEMENT ACT OF 2018; FINAL RULE, EMPLOYMENT AND TRAINING OPPORTUNITIES IN THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM; ALL COUNTY LETTER NUMBER 22-26](#)

The purpose of this All County Letter (ACL) is to inform County Welfare Departments (CWDs) of changes to the “Non-Assistance CalFresh Work Registrants, Able-Bodied Adults Without Dependents (ABAWDs), and Employment and Training (E&T) Program Quarterly Statistical Report” (STAT 47), validations, and instructions as outlined in [ACL No. 22-26](#). The changes are effective immediately upon completion of automation into the eligibility system.

### **BACKGROUND**

The California Department of Social Services (CDSS) is required to submit a “Supplemental Nutrition Activity Program (SNAP) E&T Activity Report”, known as the FNS-583 no later than 45 days after the end of each federal fiscal quarter to the United States Department of Agriculture, Food and Nutrition Services (FNS), in accordance with [Title 7 Code of Federal Regulations \(CFR\) 273.7\(c\)\(9\)](#). In California, this report is known as the STAT 47.

## **REPORTING CHANGES DUE TO STATUTORY AMENDMENT**

The [Agricultural Improvement Act of 2018 Public Law \(P.L.\) 115-334](#), also known as the 2018 Farm Bill was codified by the FNS via release of the [Final Rule, E&T Opportunities in the SNAP](#), on January 4, 2021. The Final Rule made several programmatic changes which impact data and reporting as outlined in [ACL No. 22-26](#), issued on April 1, 2022.

In order to collect the necessary data required by the FNS and comply with recently codified federal regulations, the STAT 47 report has been revised.

## **IMPLEMENTATION**

All CWDs must begin using the revised STAT 47 report upon completion of automation in the California Statewide Automated Welfare System (CalSAWS). Automation is anticipated to be complete within 12-15 months from the release of this ACL. CWDs must continue to submit the current version of the STAT 47 report until automation is complete.

**CONTENT**

The “CalFresh Work Registrant, Able-Bodied Adults Without Dependents, Employment and Training (E&T) Quarterly Statistical Report,” (STAT 47) includes data on the number of CalFresh Work Registrants, Able-Bodied Adults Without Dependents (ABAWDs), and participants in the CalFresh E&T program.

**PURPOSE**

The STAT 47 provides county, state, and federal entities with information needed for budgeting, staffing, program planning, and other purposes. The California Department of Social Services (CDSS) is mandated to submit quarterly reports to the United States Department of Agriculture, Food and Nutrition Services (FNS) 45 days after the end of each fiscal quarter in accordance with [Title 7 Code of Federal Regulations \(CFR\) 273.7\(c\)\(9\)](#).

**COMPLETION AND SUBMISSION**

The County Welfare Department (CWD) is responsible for ensuring that the STAT 47 report is complete and accurate. The CWD must designate an individual as the primary contact responsible for submitting the report to the CDSS, who will certify the report is complete and accurate. The CWD must retain an electronic (Excel) copy of all submitted STAT 47 reports to ensure the CWD’s records coincide with the records on file at the CDSS.

The CWD must submit a revised report if inaccuracies are identified for the applicable month(s) and provide an explanation for the revision in the Revised Report Explanation field. The CDSS may require the CWD to revise current Federal Fiscal Year (FFY) reports and two prior FFYs, if needed. Revisions for additional fiscal years will be evaluated by the CDSS and the CWD to determine whether corrections are needed.

**Submission Schedule**

If portions of the report are completed by entities within or outside the CWD, the designated contact person remains responsible for submitting the report to the CDSS on time with complete and accurate data. The reports must be received by the CDSS on or before the 15<sup>th</sup> calendar day of the month following the end of the federal fiscal quarter. When the 15<sup>th</sup> calendar day of the month following the end of the federal fiscal

quarter is on a Saturday, Sunday, or state holiday, the report is due the next business day.

CWDs are encouraged to review their data on the website each month to confirm the county's data coincides with the data on file at CDSS.

### GENERAL INSTRUCTIONS

Enter in the fields provided at the top of the form; CWD name, version (Initial or Revised) and the report month and year.

Enter the data required for each item. **Do not leave any items blank.** If there is nothing to report for an item, enter "0". If your county does not provide a service/activity or the service/activity is provided but the county is unable to collect or track the data, enter "0" and explain in the General Comments field provided.

Enter in the fields provided at the bottom of the form the contact's name, job title or classification, telephone number, fax number and e-mail address of the person to contact if there are questions about the report. This person may or may not be the person who completed the report. Enter the date the report is submitted. This is the date when the report is e-mailed to RADD.

## COLUMN INSTRUCTIONS

- Column (A) Month 1: Enter the data for the first month of the applicable quarter.
- Column (B) Month 2: Enter the data for the second month of the applicable quarter.
- Column (C) Month 3: Enter the data for the third month of the applicable quarter.
- Column (D) Quarter Total: **This column is automatically calculated.** It is the sum of Columns A, B, and C.

## DEFINITIONS

The definitions below must be applied to the methodology for the STAT 47 report.

### Able-Bodied Adult Without Dependents (ABAWD)

An ABAWD is a CalFresh recipient, age 18 through 49, who is able-bodied without dependent children and does not meet the criteria for an exemption from the ABAWD time limit. ABAWD eligibility for CalFresh is time limited to any three full months of benefits in a 36-month period unless the individual satisfies the ABAWD work requirement, is exempt from the ABAWD time limit, qualifies for an additional three consecutive month period of eligibility, receives a discretionary exemption, or lives in a county or area with a waiver of the ABAWD time limit. Further information on the ABAWD time limit is located in [All County Letter \(ACL\) No. 19-93](#).

### Able-Bodied Adults Without Dependents (ABAWD) Exemptions

Persons are exempt from the ABAWD work requirement if they qualify for one of the CalFresh work registration exemptions at [7 CFR 273.7\(b\)](#) (see list of work registration exemptions below). Individuals are also exempt from the work requirement if they are: under age 18 or over age 49; residing in a CalFresh household that includes a child under 18 years of age, pregnant, medically certified as physically or mentally unfit to work, or participating in an Office of Refugee Resettlement training program for at least half time. Further information on ABAWD exemptions can be located in [ACL 19-93](#).

### ABAWD Discretionary Exemptions

ABAWD discretionary exemptions allow CWDs to extend CalFresh eligibility to ABAWDs who are at risk of losing CalFresh benefits for failing to satisfy work requirements. As of FFY 2020, the Agriculture Improvement Act of 2018 reduced the number of discretionary exemptions to 12 percent of California's annual CalFresh caseload that is subject to the ABAWD time limit. Each discretionary exemption is equal to one full month of CalFresh eligibility for one ABAWD in accordance with the [CFR 273.24\(g\)\(3\)](#).



### ABAWD Waiver

A federally approved waiver of the ABAWD work requirement for areas within California with a high unemployment rate or lack of sufficient jobs.

### CalFresh Work Registrant

CalFresh applicant or recipient who does not qualify for any of the work registration exemptions. Work registrants are not to be confused with ABAWDs or CalFresh E&T participants. ABAWDs are a subset of the work registrant population and CalFresh E&T participants are limited to persons engaged in the CalFresh E&T program.

### CalFresh E&T Component

A CalFresh E&T component is defined as service, activity, or program designed to help CalFresh recipients gain skills, training, or work experience. Components include but are not limited to supervised job search, workfare, work experience, self-employment, education and job retention. Multiple activities may exist under each component. All components must be provided with case management services in accordance with [7 CFR 273.7\(c\)\(4\)](#). One or more components may be offered based on regional need, capacity, and funding availability. A participant may, if available, enroll in multiple components simultaneously or in sequence.

### CalFresh E&T County

A California county that voluntarily offers a CalFresh E&T program as outlined in the CDSS CalFresh E&T Annual Plan.

### CalFresh E&T Participant

A CalFresh E&T participant is defined as a CalFresh applicant or recipient who voluntarily begins at least one part of a CalFresh E&T program including orientation, assessment, case management, or a component. Therefore, all individuals who begin any CalFresh E&T activity, even if they do not engage in further component activities, are categorized as CalFresh E&T participants, and must be captured for reporting purposes. A person who is referred to case management, assessment or orientation but fails to show up is not considered a CalFresh E&T participant for reporting purposes in accordance with [7 CFR 273.7\(c\)\(11\)\(iii\)](#).

### CalFresh E&T Program

The Food and Nutrition Act of 2008 provides that the purpose of the Employment and Training (E&T) program is to provide Supplemental Nutrition Assistance Program (SNAP) participant's opportunities to gain skills, training, work, or experience that will increase their ability to obtain regular employment and meet state or local workforce needs. In California, the program is called CalFresh E&T.

### Federal Fiscal Year

The federal fiscal year (FFY) runs from October 1 through September 30. For example, FFY 2022 began October 1, 2021, and ended September 30, 2022.



### Non-Able-Bodied Adult Without Dependents (non-ABAWD)

A CalFresh recipient that qualifies for one of the ABAWD exemptions defined above in ABAWD Exemptions. For purposes of this report, non-ABAWDs refer specifically to those CalFresh E&T participants who qualify for an ABAWD exemption.

### Non-Qualifying CalFresh E&T Component

A CalFresh E&T component that does not satisfy the ABAWD work rule, such as any job search, supervised job search, or job search training component in accordance with [7 CFR 273.24\(a\)\(3\)\(iii\)](#).

### Qualifying CalFresh E&T Component

An E&T component that satisfies the ABAWD work requirement. Qualifying activities consist of workfare (including the 30-day job search activity that can be assigned prior to workfare), work experience, self-employment training, job retention and education. A job search program, supervised or otherwise, when operated under Title I of the Workforce Innovation and Opportunity Act (WIOA), under section 236 of the Trade Act, or a program of employment and training for veterans operated by the Department of Labor or the Department of Veterans Affairs, is considered a qualifying activity relating to the participation requirements necessary to maintain CalFresh eligibility for ABAWDs in accordance with [7 CFR 273.7\(e\)\(2\)\(i\)](#).

### Work Registration Exemptions

In accordance with [7 CFR 273.7\(b\)](#), an individual is exempt from work registration if they are any of the following:

- Younger than 16 years of age or a person 60 years of age or older; a person age 16 or 17 who is not the head of a household or who is attending school, or is enrolled in an employment training program, on at least a half-time basis;
- Physically or mentally unfit for employment.
- Subject to and complying with any work requirement under Title IV of the Social Security Act.
- A parent or other household member responsible for the care of a dependent child under six or an incapacitated person.
- A participant in a drug addiction or alcoholic treatment and rehabilitation program.
- An employed or self-employed person working a minimum of 30 hours weekly or earning weekly wages at least equal to the Federal minimum wage multiplied by 30 hours; or
- Enrolled at least half-time in any recognized school, training program, or institution of higher education.

### Work Registrant

All CalFresh recipients are subject to work registration unless they qualify for an exemption as defined in [7 CFR 273.7\(b\)](#).

## **ITEM INSTRUCTIONS**

All counties must complete Part A of the STAT 47. In addition, counties that offer the CalFresh E&T program **must** complete Parts B, C, D, and item 49 of the report. Part E is automatically calculated based on entries made in Part D. Part E is used by CDSS in completing the federally mandated quarterly FNS 583 report. Part F of items 47 and 48 must be completed by all counties when completing the Quarter 1 October - December report each year.

### **PART A. WORK REGISTRANT AND ABAWD INFORMATION (All Counties)**

Part A collects unduplicated counts of new work registrants and new ABAWDs who are approved for CalFresh in any month during the quarter. Individuals reported under this part are not counted in future quarters during the same FFY. Work registrants are individuals who do not qualify for a work registration exemption. ABAWDs are individuals who do not qualify for an ABAWD time limit exemption. See definitions section for further detail.

Note: The individuals counted on October 1 as work registrants and/or ABAWDs in part F should not be counted again in this section.

All CWDs in California must report work registration and ABAWD data. This includes CWDs with an approved ABAWD waiver. This part also contains data regarding a county's use of the ABAWD discretionary exemption and is only reported by counties where the ABAWD work requirements are not waived.

1. Unduplicated new work registrants during the quarter: Enter the number of all new individuals in receipt of CalFresh and determined to be work registrants by month during the quarter. **The quarter total is automatically calculated.** This item is an unduplicated count; an individual is counted as work registered in only one month during the FFY (October 1 through September 30). Do not include work registrants from previous quarters. A work registrant should be counted whether they are or are not an ABAWD. [Cells 1-4]
2. Unduplicated new ABAWDs during the quarter (Include in Item 1): Enter the number of all new ABAWDs during the quarter. **The quarter total is automatically calculated.** This is an unduplicated count; an individual is counted as a new ABAWD in only one month during the FFY. Item 2 is a sub-set of Item 1. [Cells 5-8]

The ABAWD population is a subset of the work registrant population. There **should** be fewer ABAWDs than work registrants due to additional exemptions for ABAWDs which are not applicable to work registration. Do **not** include ABAWDs from previous quarters. This count includes ABAWDs living in a county with an ABAWD waiver and those receiving a discretionary exemption.

3. Total number of discretionary exemptions used during the quarter: Enter the number of discretionary exemptions used during the quarter. **The quarter total is automatically calculated.** Counties with an ABAWD waiver should enter "0" (zero). [Cells 9-12]

<b>PART B. NEW INDIVIDUAL CALFRESH E&amp;T PARTICIPANTS (CalFresh E&amp;T Counties Only)</b>
--

Part B gathers an unduplicated count of individuals who participated in CalFresh E&T during the quarter. Participants should only be counted once unless they had a break of more than 90 days in CalFresh E&T participation during two quarters of the same FFY, in which case they will be counted as a new participant after each break of 90 days or more. Participants should be counted:

- Only once for the FFY, unless they had a break of more than 90 days between two quarters in the same FFY.
- In only one month even if they are in more than one E&T component.
- As a new participant each time if there was a break in CalFresh E&T participation of 90 days or more.

Participants should **not** be counted:

- If they participated in CalFresh E&T during previous quarters in the same FFY.
- In future quarters in the same FFY.
- If they were counted on October 1 in part F.

4. New individuals who participated in a CalFresh E&T activity, including orientation/assessment (OA) during the quarter: **This item is automatically calculated.** This is the sum of Items 4a and 4b. [Cells 13-16]
- a. Unduplicated ABAWD participants: Enter the number of new ABAWDs who participated in a CalFresh E&T activity, including orientation/assessment. **The quarter total is automatically calculated.** [Cells 17-20]
- b. Unduplicated non-ABAWD participants: Enter the number of new non-ABAWDs who participated in a CalFresh E&T activity, including orientation/assessment. **The quarter total is automatically calculated.** [Cells 21-24]

<b>PART C. NEW CALFRESH E&amp;T COMPONENT PLACEMENTS (CalFresh E&amp;T Counties Only)</b>
---

Part C gathers an unduplicated count of participants in each CalFresh E&T component during the FFY. A participant **must** be counted only once in the FFY for each component in which they are in unless there is a break in participation of 90 days or more.

For example, a participant in a workfare component in October would be counted in the "Month 1" column in the October – December quarter and for the purpose of this part, the participant would not be counted as a workfare participant in future quarters in the same FFY. If that same participant is in supervised job search in December, one supervised job search placement would be counted in the "Month 3" column in the October – December quarter and the participant would not be counted in supervised job search for future quarters in the same FFY. If that same participant has a break in participation of 90 days or more and returns to the CalFresh E&T program, the individual will be counted as a new participant in parts B, C, and D.

5. New orientation/assessment (OA) participants in the quarter: **This item is automatically calculated.** This is the sum of Items 5a and 5b. [Cells 25-28]
  - a. ABAWD placements: Enter the number of new ABAWDs in orientation/assessment activities. **The quarter total is automatically calculated.** [Cells 29-32]
  - b. Non-ABAWD placements: Enter the number of new non-ABAWDs in orientation/assessment activities. **The quarter total is automatically calculated.** [Cells 33-36]
6. New supervised job search (SJS) participants in the quarter: **This item is automatically calculated.** This is the sum of Items 6a, 6b, and 6c. [Cells 37-40]
  - a. ABAWD in qualifying component placements (WIOA and Veterans programs): Enter the number of new ABAWDs in a qualifying supervised job search component. A program, supervised or otherwise, when operated under Title 1 of the Workforce Investment Opportunity Act (WIOA) under section 236 of the Trade Act, or a program of the employment and training for veterans operated by the Department of Labor or the Department of Veterans Affairs, is considered a qualifying activity relating to the participation requirement necessary to maintain CalFresh eligibility for ABAWDs. **The quarter total is automatically calculated.** [Cells 41-44]

- b. Non-ABAWD placements: Enter the number of new non-ABAWDs in supervised job search component. **The quarter total is automatically calculated.** [Cells 45-48]
  - c. ABAWD in non-qualifying component placements: Enter the number of new ABAWDs in a non-qualifying supervised job search component. A supervised job search component that does not meet the requirements necessary to maintain CalFresh eligibility for ABAWDs. **The quarter total is automatically calculated.** [Cells 49-52]
7. New workfare (W) participants in the quarter: **This item is automatically calculated.** This is the sum of Items 7a and 7b. [Cells 53-56]
- a. ABAWD placements: Enter the number of new ABAWDs in workfare. **The quarter total is automatically calculated.** [Cells 57-60]
  - b. Non-ABAWD placements: Enter the number of new non-ABAWDs in workfare. **The quarter total is automatically calculated.** [Cells 61-64]
8. New self-employment training (SET) participants in the quarter: **This item is automatically calculated.** This is the sum of Items 8a and 8b. [Cells 65-68]
- a. ABAWD placements: Enter the number of new ABAWDs in self-employment training. **The quarter total is automatically calculated.** [Cells 69-72]
  - b. Non-ABAWD placements: Enter the number of new non-ABAWDs in self-employment training. **The quarter total is automatically calculated.** [Cells 73-76]
9. New job retention (JR) participants in the quarter: **This item is automatically calculated.** This is the sum of Items 9a and 9b. [Cells 77-80]
- a. ABAWD placements: Enter the number of new ABAWDs in job retention. **The quarter total is automatically calculated.** [Cells 81-84]
  - b. Non-ABAWD placements: Enter the number of new non-ABAWDs in job retention. **The quarter total is automatically calculated.** [Cells 85-88]
10. New education program basic (EPB) participants in the quarter (includes Adult Basic Education (ABE), High School Diploma (HSD) and General Education Diploma (GED): **This item is automatically calculated.** This is the sum of Items 10a and 10b. [Cells 89-92]
- a. ABAWD placements: Enter the number of new ABAWDs in education program basic. **The quarter total is automatically calculated.** [Cells 93-96]

- b. Non-ABAWD placements: Enter the number of new non-ABAWDs in education program basic. **The quarter total is automatically calculated.** [Cells 97-100]
- 11. New education program career (EPC) participants in the quarter (includes Career and Technical Education (CTE) and Vocational Training (VT): **This item is automatically calculated.** This is the sum of Items 11a and 11b. [Cells 101-104]
  - a. ABAWD placements: Enter the number of new ABAWDs in education program career. **The quarter total is automatically calculated.** [Cells 105-108]
  - b. Non-ABAWD placements: Enter the number of new non-ABAWDs in education program career. **The quarter total is automatically calculated.** [Cells 109-112]
- 12. New education program English language (EPEL) participants in the quarter (includes English as a Second Language (ESL) and English Language Learners (ELL): **This item is automatically calculated.** This is the sum of Items 12a and 12b. [Cells 113-116]
  - a. ABAWD placements: Enter the number of new ABAWDs in education program English language. **The quarter total is automatically calculated.** [Cells 117-120]
  - b. Non-ABAWD placements: Enter the number of new non-ABAWDs in education program English language. **The quarter total is automatically calculated.** [Cells 121-124]
- 13. New education program integrated (EPI) participants in the quarter (includes Bridge Programs): **This item is automatically calculated.** This is the sum of Items 13a and 13b. [Cells 125-128]

Part D gathers ongoing monthly CalFresh E&T participant counts. Individuals are counted every month they participate in any CalFresh E&T component.

For example, a participant who participates in supervised job search every month during the quarter would receive three counts in Item 27. If that same participant simultaneously participated in workfare throughout the quarter, the participant would also be counted three times in Item 28.
